While most of the features are functionally similar, the design and style of the pages will be significantly updated.

After logging on the user will be directed to a "Project Selection" page. All current projects that are accessible by the user will be displayed as links.

Once you select the appropriate project the new tabbed Implementer's menu will be displayed, as follows.

#### Planning Tools and Quarterly Reporting

- links to initial RMP and Workplan set up and review (Prior to MEPI approval).
- PDF generation of RMP and Workplan links to initial RMP and Workplan
- Quarterly Reporting schedule and due dates, submission and approval status.
- Link to creating and editing current Quarterly Report
- QR submission button

- includes all relevant documents for project implementation including past Quarterly Reports, Statement of Work, and QR appendices files added by the Implementer.

#### Public Events

- Specified Work plan activities can be identified as "Public Events". These events will be tracked by MEPI's PR and outreach team to promote the work of the program.
