DESCRIPTION OF RESPONDENTS: *This research will be conducted with a broad cross-section of potential savers to evaluate savings product ideas that are being developed based on internal guidelines, review of external product ideas and assessment of the savings needs study that precedes this work. Respondents at various life stages will be included as well as various levels of familiarity with banking products ranging from un/underbanked to fully banked and ranging from low to moderate income to higher levels of income.*
