Guidelines for Reviewers

Some questions also contain placeholders for text that varies depending on existing information (e.g., the start and end dates of a grant period) or a respondent's answer to an earlier item. The online survey will automatically incorporate skip patterns and present the appropriate text for placeholders and question wording to the respondent. Also note that **boldface type** is used for emphasis, while an asterisk (*) indicates that a roll-over definition is available to online respondents (see Glossary, below). Surveys will employ a variety of response structures and will be programmed to use radio buttons, checkboxes, text boxes, and drop down boxes. Examples of each are shown below.
