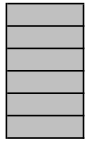

**PAPERWORK REDUCTION ACT, PRIVACY ACT, AND PUBLIC BURDEN**

It does this by providing grant monies to promote a strong educational base, responsive research, and training. The information will be used to determine the cost of each project and whether proposed matching costs are allowable. The information is also used in negotiating costs and in the administrative control of expenditures.
