Background:

NIST announced the formation of the Organization of Scientific Area Committees (OSAC) in February 2014. The OSAC components – the Forensic Science Standards Board, resource committees, scientific area committees subcommittees – are made up of members of the forensic science community, including those in government, academia and industry. Members are being selected from a pool of applications received in May 2014. New applications are being accepted for the Digital Evidence Subcommittee and to fill vacancies that may arise.

The OSAC infrastructure will strengthen the nation's use of forensic science by supporting the development and promulgation of forensic science consensus documentary standards and guidelines, determining each forensic discipline's research and measurement standards needs and ensuring that a sufficient scientific basis exists for each discipline.
