#### **PURPOSE:**

The NICHD is leading the development of PregSource<sup>™</sup>, an online resource for collecting data about pregnancy from pregnant women. The final website/application will offer pregnant women, who volunteer, a series of questionnaires related to their health during pregnancy. As we move through production and programming to launch, we want to test the website and application to ensure proper functionality, flow, and understandability. Respondents are women who have volunteered their time and effort for this purpose. Some of these organizations include the American College of Obstetricians and Gynecologists, the American College of Nurse Midwives, and the Association of Women's Health, Obstetric, and Neonatal Nurses. The respondents then contacted NICHD to volunteer for the beta testing. They include pregnant women, women who were recently pregnant, and women who may become pregnant in the near future, and women who have not ever been pregnant.
