# **Screening Criteria**

- · Gender: Aim for a mix in each market
- Language Recruiting: 2 Spanish speaking/reading and 4 English speaking/reading in each market (account for necessary over-recruits)
- Age: Good mix between 12-17
- All must be "never" smokers or are "susceptible-to-smoking" based on questions 13, 14, 15, 16 & 17.
- All must <u>not</u> have participated in a focus group discussion or an individual interview on a health-related topic in the past 6 months
- All need to have consent to participate by their parent(s) and their assent
- Thank and Terminate any respondent if they, or any member of their household, have worked in the past five years for a tobacco or cigarette company, public health or community organization involved in communicating the dangers of smoking, a marketing, advertising or public relations agency or department, the FDA, NIH, CDC, SAMHSA, CMS, ATF or TTB
- Thank and Terminate any respondent if they, or any member of their household, have ever lobbied on behalf of tobacco OR personally represented or worked on behalf of a tobacco company in connection with a tobacco lawsuit
