The purpose of this intercept survey is to capture and measure the Net Promoter Score of a segment of visitors to peacecorps.gov and their willingness to recommend Peace Corps volunteer opportunities or apply to a program. NPS is a customer loyalty metric, and a key measure of customer satisfaction. The data collected will be used in future campaign messaging and will fuel how campaign landing pages are designed in the future. A random sample of visitors will be invited to take the survey when they first visit a campaign landing page on peacecorps.gov. This survey will be conducted before and during the brand campaign scheduled to launch on June 1, 2016.

We do not have a customer list but we know that peacecorps.gov receives roughly 350,000 to 425,000 unique visitors to the website monthly. These visitors represent our “customers” to the website so we will survey this group. To achieve the maximum, our invitation rate to complete the survey given a hypothetical population of 400,000 would be approximately 38%. The tool is connected to peacecorps.gov on the backend and will randomly sample the visitors who come to the website.
