*If interviewing an EHR vendor:*

- Tell me about your EHR product(s).
  - o How long has it been on the market?
  - o How many implementations or users do you have?
  - o Is there a specific audience you're targeting?

*If interviewing a health care organization:*

- What EHR system(s) are you currently using to provide access to MedlinePlus?
  - o How long have you been using it?

*If interviewing a technical personnel:*

- Do you know if you are you using the Web Application or the Web Service of MedlinePlus Connect?
- What was your experience implementing MedlinePlus Connect into your EHR system?
  - o How much time did it take?
  - o Was it an easy or difficult task?
  - o What issues did you encounter with implementation?
- Have there been any issues or technical problems since implementation?
  - o [Get specifics of issues. Is it with the API or the medlineplus.gov site?]
- How do you prefer to be informed about updates to MedlinePlus Connect?
  - o Are you on the email list?
    - If no, would you like to be on the list?
  - o How much lead time do you need to accommodate changes?
  - o What kinds of changes are more problematic?

For all interviewees:

- Can you tell me what you do or your job title?
  - How many employees are in your company or organization?
- How did you find out about MedlinePlus Connect?
- What made you decide to implement MedlinePlus Connect?
  - Is it to meet Meaningful Use requirement?
- Tell me how you are using MedlinePlus Connect. *(User may also want to demonstrate)*
  - As patient education behind an Infobutton?
    - For discharge instruction or summary of care?
    - Are you using any other patient education resources/software, or just those from MedlinePlus Connect?
    - How familiar are you with the MedlinePlus site?
    - What do you think of the patient materials found via MedlinePlus Connect?
    - Who actually clicks on the link and obtains the information for the patient? Patients themselves? Nurses? Other health care providers?
  - If you are not using MedlinePlus Connect in an Infobutton implementation, what are you using it for?
    - Do you have a PHR system?
- What do you like about MedlinePlus Connect?
  - What don't you like?
- How can MedlinePlus Connect improve to meet your needs?
