TITLE OF INFORMATION COLLECTION: NCBI 2017 Sequence Database User Survey

PURPOSE:

The goal of this National Library of Medicine (NLM) survey is to collect qualitative customer service delivery feedback from users of the National Center for Biotechnology Information (NCBI) search services for sequence and related databases (Gene, Nucleotide, Protein, Assembly, Genome). The survey consists of a short list of questions regarding whether or not users were able to find what they were looking for, how easy or difficult it was to find desired results and so on, along with general questions about each user (occupation, etc.) and a free text box for any general comments about how to improve the service. The information from this survey will be used to improve the design and operation of the publically accessed website.

Respondents will be individual users of the NCBI website who voluntarily click on a popup invitation to take a survey that will appear on search results pages for sequence and related databases (Gene, Nucleotide, Protein, Assembly, Genome).
