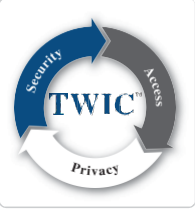

1. Once payment has been submitted as part of your TSA Pre/® enrollment, NO REFUNDS will be provided, regardless of the eligibility assessment outcome.
2. You may not need to apply for the TSA Pre/® application program if you:
 - Currently have a Known Traveler Number (KTN)
 - Are a member of a DHS Trusted Traveler Program such as CBP Global Entry, NEXUS, or SENTRI
 - Are a member of the U.S. military
 - Are a civilian employee of the Department of Defense or U.S. Coast Guard
