You don't have to talk to me today if you don't want to. If we start and then you decide you want to stop, that's okay too. Just tell me if you want to stop.

If it's okay, I would also like to record what we talk about today on this device [SHOW HAND HELD AUDIO RECORDER]. This helps me pay attention to what you say while we talk rather than write notes. Then I can still listen to the recording later to remember exactly what you said. We will not keep this recording for very long. After we have talked to all the kids in this study, I will delete this recording.

Are there any questions you would like to ask me right now?

You can still ask me questions at any time, okay?
