In order to reduce the cost of reporting the survey to the Census Bureau, we are asking all companies currently faxing data by way of the 800 number to transition to the new and improved internet data collection instrument. Internet reporting is fast, easy, and a convenient way to report your data. The M3 survey is authorized by law (Title 13, United States Code, Sections 131, 182, and 193). By Section 9 of the same law, your report to the Census Bureau is confidential. It may be seen only by persons sworn to uphold the confidentiality of Census Bureau information and may be used only for statistical purposes. The law also provides that copies retained in your files are immune from legal process. Public reporting burden for this collection of voluntary information is estimated to average 20 minutes per response.

The "M3 Instruction Manual" has the most recent information to assist you with reporting. From this web address, you also will be able to access the published M3 data.
