Grants Process

Pre-release

- Can you walk me through the process for developing a grant program? I'd like you to start at the very beginning. Please tell me very briefly what the various steps are and who the decision-makers are up to the point where the FOA is released.

 - 0 Probe for: Who decides/how is it decided to create a grant program? Who decides what mechanism to use? How do people hear about it? How does this compare or contrast with grants to CONUS recipients?

 - *o* What has been done to minimize those challenges?

Application

Let's talk about the application process itself next. I'd like you to think about your responses to my questions in terms of the ______ grant, but I would also like to know if, from your experience, what you are telling me about ______ is fairly typical of this type of grant and grantee. We certainly want to know things that are specific to this particular grant to inform our visit with them, but in the end we'll be writing recommendations that will apply to the grants program overall.

 - *O Probe:* What are some reasons those approaches did not work? What changes could be made that could help that approach or approaches be more successful?
- How would you say the challenges we just discussed are the same or different from those faced by other Insular Area grantees?
- What challenges do you or others here at HHS face in monitoring the program management of Insular Area grantees?
 - *o Probe for*: within their agency and with the islands

- What types of technical support to you provide for the Insular Areas personnel managing this project?
- What types of technical support or training do you think this grantee could benefit from but is not currently receiving?

Financial Management

Let's move on to Financial Management.

- From your experience, what would you recommend as best practices for minimizing these challenges or the effects of these challenges?
- What are some things you have seen or tried that do NOT work for addressing these challenges?
 - *o Probe:* What are some reasons those approaches did not work? What changes could be made that could help that approach or approaches be more successful?
- How would you say the challenges we just discussed are the same or different from those faced by other Insular Area grantees?
- What challenges do you or others here at HHS face in monitoring the financial management of Insular Area grantees?

<u>Reporting</u>

<u>Closeout</u>

- From your experience, what have you seen that works best at minimizing these challenges?
 - 0 Probe: What recommendations do you have, if any, for addressing these challenges?
- What intervention or interventions have been tried that DID NOT work in addressing these challenges?
 - 0 Probe: What are some reasons those approaches did not work? What changes could be made that could help that approach or approaches be more successful?

Insular Area Grants—Big Picture and Positives

Let's not talk a little bit about the way this grant is performing.

- How well are the outcome targets for this grant being met?
 - 0 How are those outcomes measured?
 - 0 Other than what we have already discussed, what are some reasons this grant is not meeting its outcome targets?
- We've talked about a lot of different challenges. If you had to pick one thing that is the absolute biggest challenge, what would it be?
 - 0 What are some of the reasons you selected that as the biggest challenge?
- Let's switch gears a bit and talk about positives. In your experience, which parts of the grants to the Insular areas are working best? I'm looking for successes or best practices in any of the phases we have discussed. *Probe for geographic area and time (a decade ago v. present)*
- What are some of the factors that made ______ a success?
- How transferrable are the factors you just described?
 - What are some reasons those factors are or are not transferrable?
- If you had to choose one "biggest bang for the buck" intervention or approach to these grants, what would that be?

Changes to Grants Management

Other than what we have already discussed, what changes to the Federal grants management process itself would be helpful in making these grants either more successful or easier for the recipients to comply with the requirements of the grants?
