**FEDERAL COST:** The estimated annual cost to the Federal government is \$7,763.

We reached this estimate by calculating at a GS-14/1, using the 2015 General Schedule (Base) at \$41.40 per hour. The hourly salary is multiplied by 1.5 to cover benefits, which totals to \$62.10 per hour. The benefits multiplier is inferred from the Bureau of Labor Statistics, Employer Costs for Employee Compensation – March 2015, US-15-1332.

We estimate the response rate to be high initially, as BIA continues to make datasets available to the public.
