1. All U.S. Principal Parties in Interest (USPPIs), forwarding agents, carriers or consolidators, etc. using aesdirect.census.gov to report electronic export information in accordance with 15CFR parts 30.1 through 30.99 must properly register with this site.
2. By submitting a registration to aesdirect.census.gov, you are and will continue to be in compliance with all applicable laws and regulations. This includes complying with the following security requirements:
 - a. Usernames and Passwords are to be kept secure and never be disclosed to any unauthorized user or any persons outside of the registered company.
 - b. Registered companies are to take responsibility for those persons having access to a Username, and Password. If a User forgets their Username or Password, they will need to contact their Account Administrator and/or User Managers to ask them to reset their password for them in Account Maintenance. If Users do not know who their Account Administrator or User Managers are they will need to contact Customer Support at 877-715-4433. If an employee with a username and password leaves the company or otherwise is no longer an authorized user, the Account Administrator must immediately disable their account in order to ensure the integrity and confidentiality of Title 13 data. Any violation of these security regulations will result in immediate loss of privilege to use AESDirect for a period of up to one (1) year.
