The information you provide will be reviewed promptly by IPR Center staff and disseminated for appropriate investigative response and tactical use to IPR Center partners.

Completion of this referral form is voluntary. The IPR Center accepts online complaints from actual victims as well as from third parties to the victims. While providing your contact information is voluntary, the IPR Center can best process a complaint if it receives accurate information in the form and has the ability to contact the complainant to clarify information that was provided, when necessary. 
