**PART I.—GENERAL INFORMATION**

**Background.** This proceeding was instituted in response to a petition filed March 9, 2016, by Metallurgical Products Company, West Chester, PA. Antidumping duties may be assessed on the subject imports as a result of this proceeding if the Commission makes an affirmative determination of injury, threat, or material retardation, and if the U.S. Department of Commerce makes an affirmative determination of dumping. **Phosphor copper** covered by this investigation is master alloys<sup>1</sup> of copper containing five percent or more of phosphorus by weight, regardless of form (including but not limited to shot, pellet, waffle, ingot, or nugget), and regardless of size or weight. Phosphor copper consists predominantly of copper, and may contain other elements, including but not limited to iron (Fe), lead (Pb), or tin (Sn), in small amounts (up to one percent by weight).

This merchandise is currently classified in the Harmonized Tariff Schedule of the United States ("HTSUS") under subheading 7405.00.10. This HTSUS subheading is provided for convenience and customs purposes.
