PART I.—GENERAL INFORMATION

Background. These proceedings were instituted in response to a petition filed on May 25, 2016 by Pasadena Commodities International, Nitrogen LLC (Pasadena, Texas). Countervailing and/or antidumping duties may be assessed on the subject imports as a result of these proceedings if the Commission makes affirmative determinations of injury, threat, or material retardation, and if the U.S. Department of Commerce makes affirmative determinations of subsidization and dumping. Questionnaires and other information pertinent to these proceedings are available at https://www.usitc.gov/investigations/701731/2016/ammonium_sulfate_china/preliminary.htm.

Ammonium sulfate covered by this petition is ammonium sulfate in all physical forms, with or without additives such as anti-caking agents. Ammonium sulfate, which may also be spelled as ammonium sulphate, has the chemical formula $(\text{NH}_4)_2\text{SO}_4$.

The scope includes ammonium sulfate that is combined with other products, including by, for example, blending (e.g., mixing granules of ammonium sulfate with granules of one or more other products), compounding (e.g., when ammonium sulfate is compacted with one or more other products under high pressure), or granulating (e.g., incorporating multiple products into granules through a slurry process). For such combined products, only the ammonium sulfate component is covered by the scope of these investigations.

Ammonium sulfate that has been combined with other products is included within the scope, regardless of whether the combining occurs in third countries.

Ammonium sulfate that is otherwise subject to these investigations is not excluded when commingled with ammonium sulfate from sources not subject to these investigations. Only the subject component of such commingled products is covered by the scope of these investigations.

The Chemical Abstracts Service ("CAS") registry number for ammonium sulfate is 7783-20-2.

The merchandise covered by these investigations is currently classifiable under Harmonized Tariff Schedule of the United States (HTSUS) subheading 3102.21.00. Although this HTSUS subheading and CAS registry number are provided for convenience and customs purposes, the written description of the scope of the investigations is dispositive.

Importer.--Any person or firm engaged, either directly or through a parent company or subsidiary, in importing ammonium sulfate (as defined above) into the United States from a foreign manufacturer or through its selling agent.
