## SPECIFIC PTA QUESTIONS

### 1. Reason for submitting the PTA: Renewal PTA

The Federal Emergency Management Agency (FEMA), U.S. Fire Administration (USFA) uses FEMA Form 516-0-1, *Federal Hotel and Motel Fire Safety Declaration Form*. The Federal Hotel and Motel Fire Safety Declaration Form collects basic information on life-safety systems related directly to fire-safety in hotels, motels, and similar places of accommodation applying for inclusion on the National Master List (NML). The Hotel and Motel Fire Safety Act of 1990, Public Law 101-391, requires FEMA to establish and maintain a list of hotels, motels, and similar places of public accommodation meeting minimum requirements for protection of life from fire; the list is known as the National Master List (NML). The referenced law resulted from a series of deadly fires in hotels and motels, occurring in the 1970's and 1980's, with high loss of life. The information is collected and distributed through an on-line electronic database accessed through the USFA website. Information submitted voluntarily by lodging establishments is reviewed and if the criteria meet the Hotel and Motel Fire Safety Act requirements, they are given a FEMA ID number and listed in the NML database. Federal travelers and the public seeking public accommodation with provisions for life-safety from fire access the NML through the on-line database and identify lodging establishments in the area to which they are traveling.

Property owners, lodging general managers, or their designee/delegate ("applicants") complete the form by providing basic information including identification of the owner(s) of the property, the business's Employer Identification Number (EIN), and provisions for life-safety from fire. The form requests specific responses from applicants as to the installation of smoke detectors in all guestrooms of properties submitted for listing on the NML. In addition, applicants must indicate if the lodging establishment has an automatic fire sprinkler system where the building is four stories or higher. For statutory reference see Title U.S.C. § 2224-26. This collection of information and form are part of Office of Management and Budget (OMB) Information Collection Resource (ICR) No. 1660-0068.

Records are retrieved by an organization's name and not by any PII.

This is a renewal—no changes to the information collection have been made since the last version.

<p>The FF 516-0-1 Federal Hotel and Motel Fire Safety Declaration Form is a Privacy Sensitive System that collects business related PII of Hotel and Motel owners. FEMA collects the PII to facilitate communication between FEMA an organization/property owner. Previously this collection of information was covered by the DHS Contact List PIA, however, the general purpose of the collect exceeds the scope of the DHS Contacts List PIA. A new PIA needs to be completed for this collection.</p> <p>Additionally, the FF 516-0-1 is retrieved by an organization/business name and not by the Point of Contact's PII. No SORN is required for this collection.</p>
