2. **AVERAGE PRICE PAID ON A PAY-WEIGHT BASIS:** Report average prices paid to growers for the quantities reported in 1.
3. **POINT AT WHICH PRICE IS TO BE REPORTED:** Report price given on the island of production at the processing plant door or first delivery point. Include in the prices, the delivery cost to the processing plant if fruit is not delivered by grower. Include payment to hired truckers or the cost of company trucks when used. Exclude freight cost from the reported price.
