	Interconception/ Postpartum visits	Percent of women enrolled in home visiting at the time of birth who receive a timely postpartum visit (within two months following birth).
	Breastfeeding	Percent of mothers enrolled in home visiting during pregnancy who initiate breastfeeding for their infants.
	Parental use tobacco	Percent of women participating in home visiting for at least six months who are currently smoking or using tobacco.
	Well-child visits	Percent of children who participated in home visiting that received last recommended well child visit based on AAP schedule.
	Maternal depression and stress	Percent of women participating in home visiting who receive maternal depression screening with validated tool.

<b>Communication Power</b>	<b>Proxy Power</b>	<b>Data Power</b>
<p>Can be understood and is meaningful to experts, policy makers, and the general public.</p> <ul style="list-style-type: none"><li>• Has policy value/salience.</li><li>• Represents consensus among diverse stakeholders.</li></ul>	<p>Represents a relevant topic.</p> <ul style="list-style-type: none"><li>• Is proximal to work; based on evidence that home visiting can have impact.</li><li>• Says something important about the desired outcome.</li><li>• Reflects a set of related issues.</li></ul>	<p>Is measurable now with reliable and readily available data.</p> <ul style="list-style-type: none"><li>• Maximizes administrative data.</li><li>• Maximizes data collected by models/ programs.</li></ul>
