- **Instructions to Respondents** adjustments to the wording of instructions to eliminate confusion and focus responses on areas of interest.
- **Response Options** adjustments to the list of possible responses for multiple-choice items.
- **Item Change** adjustments to the phrasing and content of an item prompt or stem.

The testing period confirmed the estimated burden of 15 minutes per respondent, which is reflected in this submission for generic clearance.

The survey will be administered electronically. Feedback will retained in accordance with NASA Records Retention Schedule 1392, 68D.
