1 Introduction

This document presents the user guide for the Office of Pollution Prevention and Toxics (OPPT) Section 5 Notices and Supports forms application submission process. This document is the user guide for the Secondary Authorized Official (AO) user of the Section 5 Notices and Supports application.

The Section 5 Notices and Supports application is the electronic, web-based tool provided by the Environmental Protection Agency (EPA) for the submission of Section 5 Notices and Supports data. As a Secondary AO, you can create or modify a Joint Submission/Letter of Support for a Section 5 Notices and Supports form as well as submit it to the Central Data Exchange (CDX). You can also delete Section 5 Notices and Supports forms, submit amendments to Joint forms, and download the Copy of Record (CoR).

For questions concerning the Toxic Substances Control Act (TSCA) Section 5 Notices and Supports software requirements, please contact the CDX Help Desk at help-desk@epacdx.net or call 1-888-890-1995 between the hours of 8 am – 6 pm Eastern Standard Time (EST). 2 System Requirements

To use the Section 5 Notices and Supports application to submit a Section 5 Notices and Supports form the following are required:

- An e-mail account
- JavaScript enabled web browser
- Internet access
- Adobe Acrobat Reader 5.0 or higher
- CDX username and password

3 Secondary Authorized Official Functions

This section describes how to:

- Access the application
- Navigate the Section 5 Notices and Supports 'Home' screen
- Assign Supports to complete a Letter of Support or Joint Submission
- Start, complete, and submit the Section 5 Notices and Supports Letters of Supports and Joint Submissions for a Premanufacture Notice (PMN), Biotechnology, or Letter of Support for a Bona Fide
- Upload an Extensible Markup Language (XML) file
- Download a Copy of Record
- Create an amendment for Joint Submissions and/or Letter of Supports

The Secondary AO has the ability to submit Joint Submissions and/or Letters of Support, and is legally responsible for the information submitted to EPA. The Secondary AO is typically a senior official with management responsibility for the person(s) completing the form. The Secondary AO can create, delete, and unlock submitted Joint Submissions and or/Letters of Support for creating amendments. The Secondary AO is responsible for restricting the Secondary Support's (and other authorized individuals) access to select forms by using the user management functionality within the system. The system uses Cross-Media Electronic Reporting Regulation (CROMERR) encryption security during the submission signing process.

The Secondary AO creates a new Joint Submission or Letter of Support and delegates to the Secondary Support to fill out required sections of the form.

The Secondary AO is responsible for receiving the unique identification number that will be sent after an original PMN, Biotechnology, or Bona Fide form is submitted and designated by the Primary Submitter as a Joint Form and/or Letter of Support form. The Joint Submission or Letter of Support will not be created until the Secondary AO creates a passphrase for a form. To link the Joint Form to the primary form, a user will enter the unique identification number.

You can save the form at any point during the data entry process. The save functionality will allow you to return to a form at any point in the future. You can print the form at any point; however, the 'Not For Submission' watermark will be placed on the form anytime the form is printed prior to actual submission.

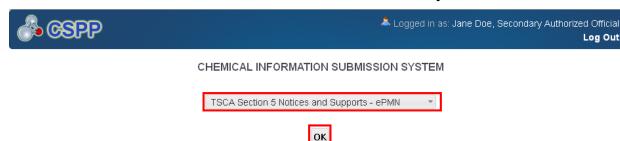
3.1 Log into Section 5 Notices and Supports Application

After you create an account in CDX, click the 'Secondary Authorized Official' link for the Chemical Safety and Pesticide Programs (CSPP) data flow to navigate to the 'Chemical Information Submission System' screen.



Exhibit 3-2 shows a screen capture of the 'Chemical Information Submission System' screen:

Section 5 of TSCA, EPA's New Chemicals Program, helps manage the potential risk to human health and the environment from chemicals prior to entry to the marketplace. Anyone who plans to manufacture or import a new chemical substance (i.e. one not listed on the TSCA inventory) for a non-exempt commercial purpose is required by Section 5 of TSCA to provide EPA with notice before initiating the activity. A Premanufacture Notice, or PMN, must be submitted at least 90 days prior to the manufacture or import of the chemical. Additional notice types which use the PMN form are listed to reflect different circumstances under which a chemical may be manufactured or imported such as Significant New Use Notices (SNUN), Low Volume Exemptions (LVE), Test Market Exemption Applications (TMEA), and Low Volume and Low Release Exemptions (LOREX). Biotechnology notice forms will be used to submit Microbial Commercial Activity Notices (MCAN), TSCA Experimental Release Applications (TERA), Tier 1 Exemptions, Tier 2 Exemptions, and Biotechnology Test Market Exemption Applications (Biotechnology TMEA). For a PMN or MCAN, the manufacturing or importing company must also notify EPA via a Notice of Commencement within 30 days after the start of the first manufacture or import of the chemical for non-exempt commercial purposes.

Please note: The public reporting and recordkeeping burden for this collection of information is estimated to average 93 hours per response for PMN, SNUN, LVE, and LOREX applications (TMEA is estimated to average 88 hours per response), including time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. The public reporting and recordkeeping burden for this collection of information is estimated to average 290 hours per response for MCAN applications and the NOC is estimated to average 0.8 hours per response. Send comments on the Agency's need for this information, the accuracy of the provided burden estimates, and any suggested methods for minimizing respondent burden, including through the use of automated collection techniques to the Director, Collection Strategies Division, U.S. Environmental Protection Agency (2822T), 1200 Pennsylvania Ave., NW, Washington, D.C. 20460. Include the OMB control number in any correspondence. Do not send the completed EPA Form 7710-25 (PMN) or Form 6300-14 (Biotechnology) or Form 7710-56 (NOC) to this address.

The software includes submission forms, embedded help files and a downloadable user manual to guide you through the Section 5 Notices and Supports submission process. Click OK to complete a Section 5 Notices and Supports reporting form, using the Section 5 Notices and Supports software. If you are not reporting on Section 5 Notices and Supports, please select a different application in the drop-down menu.

Navigation: To access the Section 5 Notices and Supports 'Home' screen, select 'TSCA Section 5 Notices and Supports – ePMN' from the submission type drop-down menu and click the 'OK' button.

3.2 Home Screen Navigation

You can access the Section 5 Notices and Supports 'Home' screen by selecting 'TSCA Section 5 Notices and Supports – ePMN' from the submission type drop-down menu on the 'Chemical Information Submission System' screen and clicking the 'OK' button.



The Section 5 Notices and Supports 'Home' screen is the first screen within the Section 5 Notices and Supports application. It provides you with links and tabs to access the 'Section 5 Notices and Supports Forms,' 'User Management,' and 'Resources' screens. To navigate to any of these screens, click the corresponding screen link (highlighted in blue text), or click the screen tab (located within the application header). The links and tabs provide the same functionality.

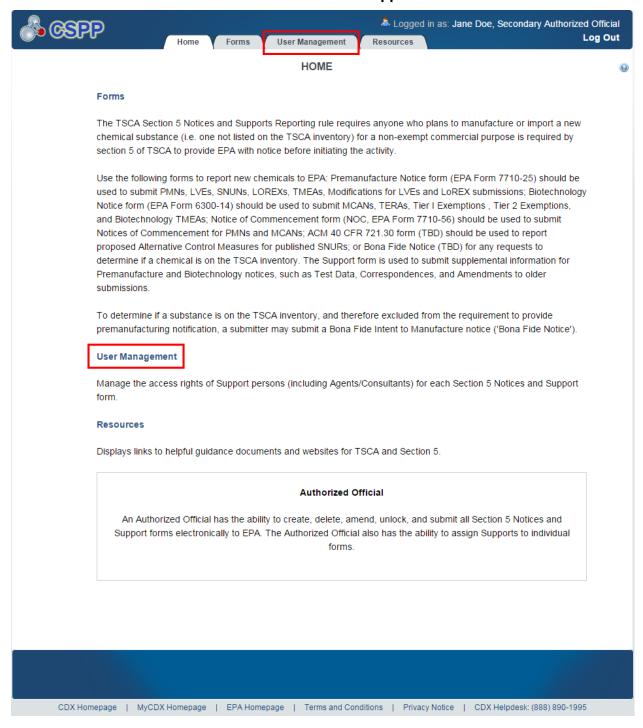
There is a ten (10) minute logout timer for this application; the application will automatically log you out after ten minutes of inactivity and navigate you back to the CDX login screen.

- Forms: Click the 'Forms' tab or link to navigate to the 'Section 5 Notices and Supports Forms' screen. You can create, modify, or delete a Section 5 Notices and Supports form using the 'Section 5 Notices and Supports Forms' screen. For additional details about the 'Section 5 Notices and Supports Forms' screen, please refer to Section Error! Reference source not found..
- User Management: Click the 'User Management' link or tab to navigate to the 'User Management' screen. You can manage the access rights of Supports per form alias using the 'User Management' screen. For additional details about the 'User Management' screen, please refer to **Section** Error! Reference source not found..
- **Resources:** Click the 'Resources' link or tab to navigate to the 'Resources' screen. You can find the Section 5 Notices and Supports user guide, as well as useful links for guidance documents on the 'Resources' screen. Navigation: Click the 'User Management' link or tab to access the 'User Management' screen and assign Supports.



3.3 User Management

You can access the 'User Management' screen by clicking the 'User Management' link on the Section 5 Notices and Supports 'Home' screen or by clicking the 'User Management' tab from the application header.

On the 'User Management' screen, you have the ability to assign one or more Supports to have access to modify any of the Section 5 Notices and Support forms you have created. You can also assign different Supports to fill out the Section 5 Notices and Supports submission for each form alias.

Form Alias: A form alias will not be available in this menu until it has been created. Select a form alias from the drop-down menu to begin assigning Supports. Once a form alias has been selected, the 'Assign Users' group box will update to display only the Supports who have identified you as their AO during CDX registration.

Form Information: This box shows information pertaining to the form you selected from the 'Form Alias' drop-down menu.

- Form Alias: Displays the form alias that a form is given.
- **TS Number:** Displays the toxic substances (TS) number that is entered for that specific form.
- Form Type: Displays the type of form, which may include 'Primary PMN,' 'Biotechnology,' or 'Bona Fide.'
- Form Subtype: This value will be blank for Secondary AOs since this value is disjointed from the form information displayed.
- Last Modified: Displays the date the form was last modified.

Assign Users: This box shows all the Supports you can assign to complete a Section 5 Notices and Supports form for the form alias selected. To move Supports from the 'Unassigned' group box to the 'Assigned' group box, highlight the individual or multiple Support(s) and click the 'add >>' button.

- Unassigned: This box/field contains the registered Supports associated with the AO who could potentially be assigned to access and edit the selected form. To move Supports from the 'Unassigned' group box to the 'Assigned' group box, highlight an individual or multiple Support(s) and click the 'add >>' button. To highlight multiple Supports hold down the <Ctrl> key on your keyboard while clicking each Support. To highlight multiple consecutive Supports, hold down the <Shift> key on your keyboard while clicking the first and last Supports in the list.
- Assigned: This box/field contains the registered Supports given permission, by the AO, to access and edit the selected form. This group box shows all the Supports that are assigned to complete the Section 5 Notices and Supports form for a single form alias. To move Supports from the 'Assigned' group box to the 'Unassigned' group box highlight individual or multiple Supports and click the '<< remove' button. To highlight multiple Supports hold down the <Ctrl> key on your keyboard and click each Support. To highlight multiple consecutive Supports hold down the <Shift> key on your keyboard and click the first and last Supports in the list.



- **Add** >>: Click the button to move Supports from the 'Unassigned' box to the 'Assigned' box.
- << **Remove:** Click the button to move Supports from the 'Assigned' box to the 'Unassigned' box.

When you have finished assigning the Supports, click the 'Save' button that displays after selecting a form to save the selection.

The Authorized Official is responsible for restricting a Support's access to select forms by assigning or un-assigning them to each form alias. The Support can access and edit only those forms for which the Authorized Official has granted access. Select the form to manage from the drop-down menu and assign a Support to the form by highlighting the individual and clicking the add link. To un-assign a Support, highlight the individual and click the remove link. To highlight and assign or un-assign multiple Supports, hold down the Ctrl or Shift keys on the keyboard and click each Support before clicking the 'add >>' or '<< remove' link. You must click

the 'Save' button after each change in user assignment.

You can access the 'Section 5 Notices and Supports Forms' screen by clicking the 'Forms' link from the Section 5 Notices and Supports 'Home' screen, or by clicking the 'Forms' tab located within the application header.



Only one Section 5 Notices and Supports form is created per form alias. Each column within the table of the 'Section 5 Notices and Supports Forms' screen can be sorted by clicking the individual column headers.

Start New Form: To create a new Section 5 Notices and Supports Joint Submission/Letter of Support, click the 'Start New Form' button. You will be required to enter the unique identification number supplied by the Primary AO or Primary Agent/Consultant and create a passphrase that will be associated with your particular form. Make sure to create a passphrase that you will remember, as it cannot be retrieved or reset. Refer to **Section 3.5** for further instructions on creating a new passphrase.

Edit an 'In Progress' Form: To modify an existing Section 5 Notices and Supports form, click the 'Alias' link that has a status of 'In Progress.' You will be required to enter the passphrase associated with that particular form to access and edit the form. Refer to **Section 0** for further instructions on viewing and modifying a form that is 'In Progress.'

Amend a submitted form: To edit an already submitted Section 5 Notices and Supports form (i.e., to create an amendment), you must first unlock the particular form by clicking the 'Lock' icon () under the 'Action' column. You are required to enter the passphrase associated with that particular submission to gain access and amend the submission. All changes that are made will be submitted as an amendment. Refer to **Section 0** for further instructions on creating an amendment.

The 'Section 5 Notices and Supports Forms' screen displays the following columns of information:

- Alias: Displays the form alias provided on the 'General Form Information,' 'General Document Information,' or 'Contact Information' screen. The 'Alias' column will display a default alias comprised of a form type, date stamp, and time stamp in the following format: <Form Type-YYYYMMDD-HH:MM:SS Time Zone> if you accept the system-generated 'Form Alias' on the first screen in a Section 5 Notices and Supports form. A form alias is helpful when a user or company has multiple forms and/or when you must differentiate between forms. Click the form alias link to navigate to the 'Enter Passphrase' screen to access a form.
- **Type:** Displays the form type pertaining to the reported chemical substance or mixture. This column can contain the following values: 'Joint PMN,' 'Joint Biotechnology,' or 'Joint Bona Fide.'
- **Subtype:** This column will not populate for a Secondary Authorized Official.
- Case Number: Displays the form case number pertaining to the reported chemical substance or mixture after EPA receives the submission. A consolidated submission will generate sequential case numbers for each chemical identified within the form. Case numbers will not be sequential for joint consolidated submissions. If the form has not been submitted and received, the field remains blank.
- **Status:** Displays the status of the Section 5 Notices and Supports form. The values will display as either 'In Progress' or 'Submitted.'
- Modify Date: Displays the date the form was last modified.

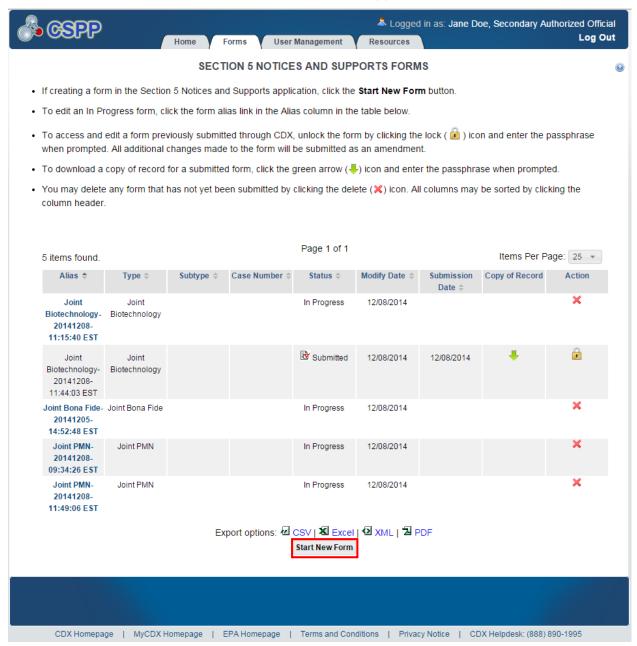


- **Submission Date:** Displays the date the form was submitted to EPA via CDX. This date populates only after the form has been submitted.
- Copy of Record: Click the 'Copy of Record' icon (♣) to navigate to the 'Enter Passphrase' screen, then the 'Cross-Media Electronic Reporting Regulation (CROMERR) Login' screen to continue to the 'Copy of Record' screen. The 'Copy of Record' icon (♣) displays only after the form has been completed. Refer to Section 10 for further instructions on downloading the Copy of Record. If you have just submitted via CDX, the 'Copy of Record' icon (♣) may take 15-20 minutes to display. In addition, you must refresh the 'Section 5 Notices and Supports Forms' screen for the 'Copy of Record' icon (♣) to display.
- Action: Displays a 'Delete' icon (\times) for all forms with a status of 'In Progress.' Click the 'Delete' icon to delete a form. This column displays a 'Lock' icon (\bullet) for all forms that have been submitted. Only an AO can unlock a form by clicking the 'Lock' icon (\bullet) and unlocking the form. The form will remain unlocked and display the 'Unlocked' icon (\bullet) until the form is resubmitted by a Secondary AO.
- Export Options: Displays 'CSV,' 'Excel,' 'XML,' and 'PDF' links for you to export the 'Section 5 Notices and Supports Forms' screen in one of the specified formats as an Excel spreadsheet, Comma-Separated Values (CSV), XML, or Portable Document Format (PDF). The export options section will not display until a form is created.
- **Start New Form:** Click this button to start a new form and navigate to the 'Create Passphrase' screen. This button is only available to Authorized Officials and Agents/Consultants.

Navigation: Click the 'Start New Form' button to navigate to the 'Create Passphrase' screen.

3.5 Create Passphrase

To start a new Section 5 Notices and Supports Joint/Letter of Support PMN, Biotechnology, or Bona Fide form, click the 'Start New Form' button. The 'Create Passphrase' screen provides a text field for you to enter in the unique identifier supplied by the Primary AO and create a passphrase to associate that passphrase with the form.



The application uses the passphrase as an encryption key to protect the contents of the form. You are responsible for remembering the passphrase and distributing it to the appropriate individuals.

If you forget the passphrase, you will not have access to the form and will not be able to view, print, submit, or make changes. If you lose or forget the passphrase, you must create a new form and passphrase. For security reasons, the system administrator does not have access to the passphrase and will not be able to retrieve it or reset it to a new one.

Unique Identifier: Enter the unique identifier that was provided by the Primary AO or Primary Agent/Consultant.

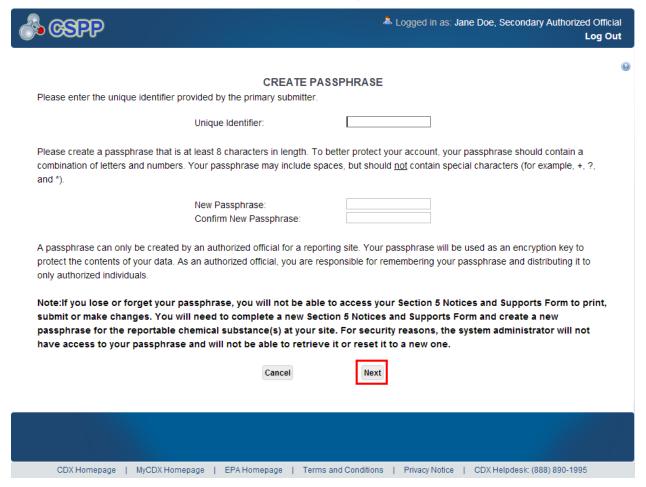
New Passphrase: To associate a passphrase with a form, enter a passphrase that is at least 8 characters in length. To protect your account, your passphrase should contain a combination of letters and numbers. The passphrase you create may include spaces, but should <u>not</u> contain special characters (for example, +,?, and *). You can associate the same passphrase with multiple forms.

You will be responsible for remembering the passphrase and distributing it to only authorized Supports for an individual form. If you forget the passphrase, you will not be able to access the Section 5 Notices and Supports form to print, submit, or make changes.

Navigation: Enter a 'Unique Identifier,' create a passphrase, and click the 'Next' button to navigate to the 'General Form Information' screen in a PMN or Biotechnology form. Click the 'Next' button to navigate to the 'General Document Information' screen in a Bona Fide form.

3.6 Enter Passphrase

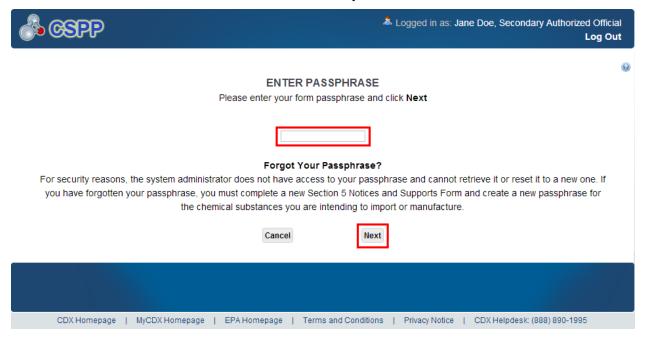
To edit a form click the 'Alias' link for a Section 5 Notices and Supports form with a status of 'In Progress' on the 'Section 5 Notices and Supports Forms' screen. The 'Enter Passphrase' screen requires you to enter the passphrase that is associated with the form.

Enter Passphrase: Enter the passphrase that you originally created and associated with the form.

Navigation: Enter the passphrase that you originally created and associated with the form and click the 'Next' button to navigate to the 'General Form Information' screen in a PMN or Biotechnology form.

3.7 Navigation Tree

The navigation tree is located on each screen on the left hand side. It allows you to navigate between the various screens within the application and the different sections of the form. You can perform the following functions using the navigation tree:

- Open and close the navigation tree: A navigation arrow that opens and closes the navigation tree is located to the right of the navigation tree to provide more visual form space. Click the arrow (◀) on the open navigation tree to close the navigation tree and increase the space of the form content. Likewise, click the arrow (▶) on the closed navigation tree to open the navigation tree.
- Collapse and Expand folders: Each section of the form falls under a collapsible folder within the navigation tree, which allows you to save space or easily view items in the navigation tree. When a folder is expanded, you can click the minus sign (-), the 'Folder' icon (a), or the folder title link to collapse that section of the navigation tree. When a folder is collapsed, you can click the plus sign (+), the 'Folder' icon (a), or the folder title link to expand that section of the navigation tree. When you place your cursor over a folder title link, it will highlight in red.
- Navigate between screens: You can use the navigation tree to navigate between the various screens within the application and the different sections of the form. A 'Form' icon (a) denotes each section of a form. Click a 'Form' icon (a) or a section title link to navigate between screens. You are required to save all information entered on a particular screen



before navigating to the next screen or all entered information will be lost. A prompt will appear after you click a link in the navigation tree indicating, 'Are you sure you want to leave the current page? Any unsaved changes will be lost.' Click the 'OK' button to navigate to the requested screen without saving any of the data in the previous screen. Click the 'Cancel' button to close the prompt and remain on the current screen.

- Delete chemical folders: To delete specific chemical folders, a 'Delete' icon (X) displays at the bottom of each chemical folder within the navigation tree of a PMN form. When a chemical folder is deleted, all information entered within the deleted chemical folder is lost and cannot be retrieved. You can add a new chemical folder by clicking the 'Add Consolidated Chemical' link, and filling in all corresponding data. This delete functionality is not applicable to the Biotechnology or Bona Fide form.
- Copy chemical folders: To copy a specific chemical folder, click the 'Copy' icon () that displays at the bottom of each chemical folder within the navigation tree of a PMN form. When a chemical folder is copied, the chemical name, Chemical Abstracts Service Registry Number (CASRN), and attached documents are removed from the copied chemical. This copy functionality is not applicable to the Biotechnology or Bona Fide module.
- Delete 'Submitted Controlled Operations' or 'Operations Controlled By Others': Click the 'Delete' icon (X) that displays at the bottom of each 'Submitter Controlled Operations' or 'Operations Controlled by Others' folder within the navigation tree to delete a specific operations folder. When a 'Submitter Controlled Operations' or 'Operations Controlled by Others' folder is deleted, all information entered within the deleted operation is lost and cannot be retrieved. Click the 'Add Operation' link under the appropriate operations folder and fill in all corresponding data to add a new 'Submitter Controlled Operations' or 'Operation Controlled by Others' folder. The delete functionality is not applicable while a user is navigating on a screen within the 'Operations Controlled by Others' folder. This delete functionality is not applicable to the Biotechnology or Bona Fide module within the Section 5 Notices and Supports application.
- Upload XML: The system displays an 'Upload XML' button in the navigation tree to allow a user to upload an XML file into a PMN form or joint PMN form, or to export an existing PMN form into an XML file format. A user may also upload eTSCA thick client files into a PMN form. If an XML file is uploaded into an existing form, the contents of that XML file overwrites the contents within the PMN form. For more information about the upload XML functionality, refer to Section 4.1.27.



Please note that in IE 7, the scroll bar within the navigation tree may freeze or portions of the scroll bar may be missing which can prevent you from using the navigation tree. If the scroll bar freezes, click the 'Previous' and 'Next' buttons on a page to navigate, or click other links within the navigation tree to continue within the form.

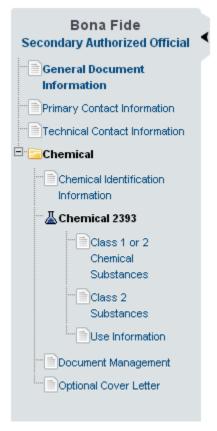

3.8 Action Bar

The action bar is located at the bottom of the form section on each screen. You can perform the following functions using the action bar:

• Validate: Click the 'Validate' icon (✓) at any stage of completing a Section 5 Notices and Supports form. A 'Section 5 Notices and Supports Validation' pop-up window generates when you click the 'Validate' icon (✓) if you disable the pop-up blocker within your internet browser. The 'Section 5 Notices and Supports Validation' pop-up window displays a report of all warning messages and validation errors. On screens that display an expandable/collapsible field set, you must click the 'Save' button displayed within the expandable/collapsible field set to save the information entered within the field set before the 'Validate' functionality initiates. Refer to Section 8 for more information on validating a form.

Exhibit 3-15: Action Bar - Validate





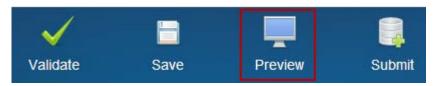
• Save: Click the 'Save' icon () at any stage of completing a Section 5 Notices and Supports form to save the form. To generate and access links to other pages of the form within the navigation tree, you must click the 'Save' icon () within the action bar. After you click the 'Save' icon (), you will receive a prompt indicating that all data entered in the form has been saved successfully. The save function does not validate any entered data. On screens that display an expandable/collapsible field set, you must click the 'Save' button displayed within the expandable/collapsible field set to save the information entered before being able to click the 'Save' icon () located within the action bar or use the 'Previous' and 'Next' buttons to navigate to another page. Click the 'Previous' and 'Next' buttons on a form to save the data entered within a form. Click the 'X' button in the upper right-hand corner of the form in your browser to close the form without saving.

• **Preview:** Click the 'Preview' icon () at any stage of completing a Section 5 Notices and Supports form to preview the form. After you click the 'Preview' icon (), you will be given the option to view a regular version of the PDF (the confidential business information (CBI) version of the form or the non-CBI version if the form contains no CBI) or a sanitized version of the PDF. Choosing either option will generate and display a watermarked PDF of the form in a separate tab of your internet browser. Please note that attachment header sheets no longer generate within the PDF.

• Submit: As a Secondary AO you have the ability to click the 'Submit' icon () to submit Letters of Support, Joint Forms, and/or amendments to Joint Forms or after you or the Support have completed all sections of the Section 5 Notices and Supports submission process. After you click the 'Submit' icon () a pop-up message displays to confirm the submission process. The form validates during the submission process and displays any applicable warning or error messages. Refer to Section Error! Reference source not found. for further instructions on validation errors. You can continue the submission process only after clearing all validation errors. Validation warnings will not prevent you from submitting a form. Upon successful submission of a form, the application generates and sends an email indicating the successful submission of the form to the submitter's email address. Refer to Section Error! Reference source not found. for more information on submitting a Section 5 Notices and Supports form.

 - If you click the 'MyCDX Homepage' link, the application takes you to the CDX Login screen.
 - If you click the 'EPA Homepage' link, the application takes you to the EPA Homepage.

3.9 Attach Documents

The 'Attach Document' button displays on various screens within a Section 5 Notices and Supports form, and provides functionality for you to attach supporting documents where needed. Click the 'Attach Document' button displayed on a screen to access the 'Attach Documents' pop-up window. You can attach a file and enter a description, number of pages, and indicate CBI status. There is no limit on the size of the file that can be attached; however, the application prevents a user from uploading an empty document.

The system allows you to claim an uploaded document as CBI. If you claim a document as CBI, the system requires you to upload a sanitized version of the attached document. If you wish to change a CBI attachment to be non-CBI by un-checking the 'CBI' checkbox, a warning appears to notify you that un-checking the 'CBI' checkbox will delete the sanitized file. If you neglect to populate a required field and click the 'OK' button, an error message will display to indicate the missing field and the application will delete the previously attached file.

After you upload a document to be attached, the 'Attach Documents' pop-up window will close and the document's information will display in a table format on the screen. Depending on the screen, the attachment table may display the section of the page the file is associated with, the



file name and file extension of the document, a description of the document, the number of pages in the document, and if the document was claimed CBI. The system allows you to delete unwanted documents by clicking the 'Delete' icon (×) located under the 'Actions' column. To view, open, or edit previously attached documents, click the appropriate file name of the document within the 'File Name' column of the document table to view previously entered document information.

Please note that in IE 7, the 'Cancel' button within the 'Attach Documents' pop-up window disappears and reappears when checking the 'CBI' checkbox.

- Type: Select the document type of the document that you upload. This drop-down menu contains the following values: 'Aquatic Ecotoxicity,' 'Chemical Structure Diagram,' 'Fate,' 'gel-permeation chromatography (GPC),' 'Genetic Toxicity,' 'Health Toxicity,' 'IES Report,' 'Safety Datasheet,' and 'Terrestrial Ecotoxicity' for PMN and Biotechnology forms. This drop-down menu contains 'Spectrum of Substance,' 'Statement of Commercialization,' 'Statement of Research and Development,' and 'Other' for Bona Fide forms. This is a required field.
- Subtype: Select the document type of the document that you upload. This drop-down menu contains the following values, which are grouped under specific document types:
 'Partitioning (e.g., Koc, Kd, Kow, Koa, Henry's law constant),' 'Hydrolysis,' 'Fugacity,'
 'Photolysis,' 'Monitoring data (e.g. air, water, soil, biota, human),' 'Biodegradation,'
 'Bioconcentration Factors/Bioaccumulation Factors (BCF/BAF),' 'Material Safety Data
 Sheet/Safety Data Sheet (MSDS/SDS),' 'Technical Datasheet,' 'Eye Irritation,' 'Combined
 Repeated-Dose/Developmental/Reproductive Toxicity,' 'Sensitization,' 'Carcinogenicity,'
 'Repeated-Dose Toxicity,' 'Neurotoxicity,' 'Acute Toxicity,' 'Developmental Toxicity,'
 'Pharmacokinetics/Metabolism,' 'Dermal Irritation,' 'Reproductive Toxicity,' 'Fish Chronic
 Toxicity,' 'Invertebrate Acute Toxicity,' 'Invertebrate Chronic Toxicity,' 'Algae Toxicity,'
 'Fish Acute Toxicity,' 'Chromosomal Aberrations Assay,' 'Unscheduled DNA Synthesis,'
 'Genetic Mutation Assay,' 'Plant Toxicity,' 'Invertebrate Toxicity,' 'Avian Toxicity,' and
 'Other.' Document subtypes are not applicable to a Bona Fide form. This is a required field
 when displayed.
- Attachment: Click the 'Browse' button to generate the 'File Upload' window to search for a document on your hard drive. The application prevents the upload of empty documents. The attached file can be one of the following file types: .pdf, .mol, .ppt, .pptx, .xls, .xlsx, .doc, .docx, .rtf, .txt, .gif, .jpg, .png, .bpm, .fas, .gbk, or .embl.
- **Description:** Enter a description associated with the attached document. Submitters should not include any CBI information in the document description. This is a required field.
- **Number of Pages:** Enter the number of pages in a document. This is a required field in a PMN or Biotechnology form. This field is not applicable to a Bona Fide form.
- Check to claim the attachment as CBI: Check the 'CBI' checkbox to claim the attached document as confidential. Un-checking the 'CBI' checkbox for a CBI document generates a warning notifying you that un-checking the CBI claim will delete the sanitized file. This checkbox is not applicable to a Bona Fide form.
- Sanitized Attachment: Click the 'Browse' button to generate the 'File Upload' window to search for a particular file on your hard drive. The attached file can be one of the following



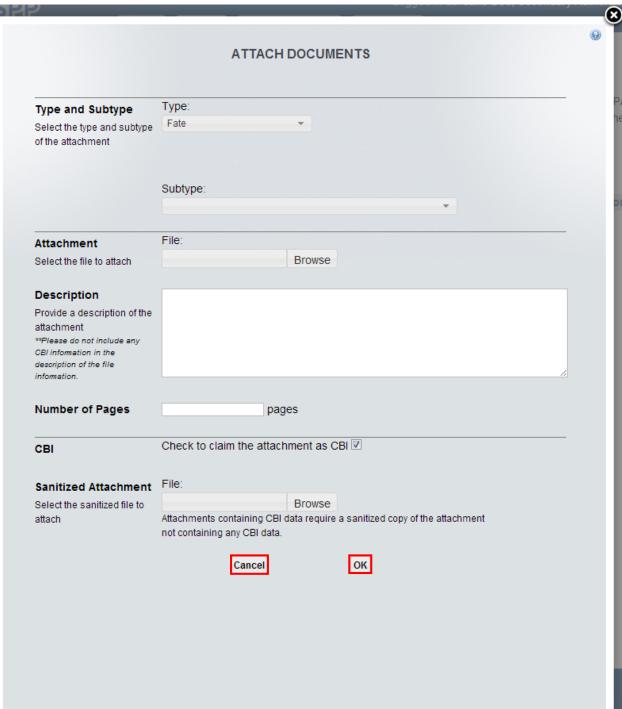
file types: .pdf, .ppt, .pptx, .xls, .xlsx, .doc, .docx, .rtf, .txt, .gif, .jpg, .png, .bpm, .fas, .gbk, or .embl. For any attached document claimed as CBI, you will be required to attach a sanitized version of the document. This field is not applicable to a Bona Fide form.

- Cancel: Click the 'Cancel' button to cancel the attach document process.
- **OK:** Click the 'OK' button to attach and link the document uploaded on the 'Attach Documents' window to the form. If a field is missing, a warning message will display notifying you that all attachments must be re-attached and the missing field must be populated.

Navigation: Click the 'Cancel' button or 'X' icon in the upper right-hand corner to cancel the document attachment process. Click the 'OK' button to attach the document to the form and navigate back to the original screen from which the document attachment process was initiated.



3.10 Search Substance Registry Services

The 'Search SRS' button displays on various screens within a Section 5 Notices and Supports form to identify chemicals that may be stored in SRS.

Search SRS: Click the 'Search SRS' button to generate the 'Search Substance Registry Services' pop-up window. You can search for the reported chemical(s) by either the 'Chemical Abstracts Service Registry Number (CASRN)' or 'CA Index Name or Other Synonym.' The application also offers the option of entering user-specified chemical information by clicking the 'Create New Chemical' button. Click the 'Create New Chemical' button to generate the 'Chemical Not Found In Substance Registry Services' pop-up window and enter chemical information by filling in the 'Chemical Name' and 'CASRN' (if desired) field under the manual entry field set.

The system allows you to enter each chemical by clicking the 'OK' button located at the bottom of the 'Search SRS' window. Once you enter all known chemical information and click the 'OK' button, the chemical information saves and populates into the chemical description table. The 'Actions' column of the chemical table allows you to delete chemicals that have been added.

The Section 5 Notices and Supports application contains functionality to prevent a user from adding duplicate chemicals within a multi-component submission. The application checks chemicals in the following order:

- If both chemicals have CASRNs, they will be compared.
- If only one chemical has a CASRN, they will not be compared and are considered different.
- If neither chemicals have CASRNs, their chemical names will be compared.

An error message generates within the expandable/collapsible field set if a user attempts to add a duplicate chemical within a multi-component submission.

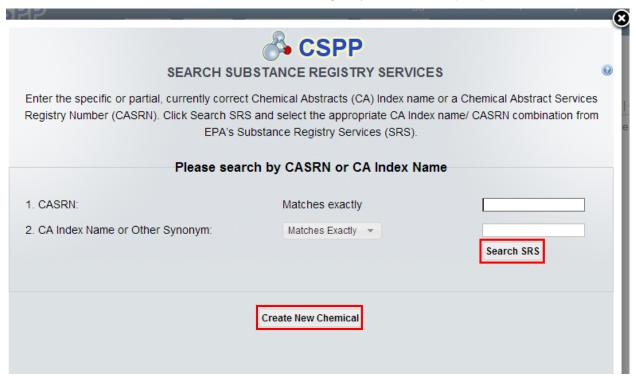
Please note in IE 7, the CSPP logo might be misaligned in the 'Search Substance Registry Services' window.

- **CASRN:** Enter the chemical abstracts service registry number of the chemical; this field accommodates dashes. Either the 'CASRN' or 'CA Index Name or Other Synonym' field is required when searching SRS.
- CA Index Name or Other Synonym: Enter the chemical abstract '(CA) Index Name or Other Synonym' of the chemical. This field displays the following options: 'Matches Exactly,' 'Contains,' and 'Begins With.' Either the 'CASRN' or 'CA Index Name or Other Synonym' field is required when searching SRS.
- **Search SRS:** Click the 'Search SRS' button to initiate the database search for the 'CASRN' or 'CA Index Name or Other Synonym' for the desired chemical.
- Create New Chemical: Click the 'Create New Chemical' button to generate the 'Chemical Not Found In Substance Registry Services' pop-up window.

Navigation: Click the 'Search SRS' button on the 'Search Substance Registry Services' window to initiate the database search for the 'CASRN' or 'CA Index Name or Other Synonym.' After SRS returns results, select the radio button associated to a chemical, click the 'OK' button on the 'Search SRS' window, close the 'Search Substance Registry Services' window, and navigate back to the screen from which the SRS search was initiated where the chemical information will be populated.

If the chemical is not found in the 'Search Substance Registry Services' window, click the 'Create New Chemical' button to generate the 'Chemical Not Found In Substance Registry Services' pop-up window.

- CBI: Check the 'CBI' checkbox to claim the entered chemical as confidential.
- Chemical Name: Enter the chemical name. This is a required field.
- **CASRN:** Enter the CASRN, if available.
- **Maximum Percent:** Enter the maximum percentage for the impurity. This field displays only in the 'Chemical Not Found In Substance Registry Services' window on the 'Additional Chemical Information' screen.
- Cancel: Click the 'Cancel' button to navigate back to the 'Search Substance Registry Services' pop-up window.
- **OK:** Click the 'OK' button to enter the manually entered chemical information into the fields on the screen from which the SRS search was initiated.

Navigation: Click the 'OK' button to save the specified chemical information and navigate back to the screen from which the SRS search was initiated where the chemical information will be populated. Click the 'Cancel' button to navigate back to the 'Search SRS' pop-up window. Click the 'X' located in the upper right corner to close the pop-up window and navigate back to the screen from which the SRS search was initiated.

3.11 Add Facility

The 'Add Facility' button displays on the 'Submitter Operation Information' screen and the 'Industrial Sites Controlled By Others' screen within a Joint PMN form. This button also displays on the 'Submitter Site Identification' screen within a Bona Fide form. The 'Add Facility' button is used to generate the 'Add Facility' pop-up window and select the applicable sites for which you will be reporting. The 'Add Facility' drop-down menu contains the sites that all AO users within the same organization are registered for within CDX registration; additional facilities can be added within CDX to further populate this drop-down menu.



If you are not registered to any facilities within CDX registration, or you have finished identifying all possible sites, a message displays within a pop-up window notifying you to add additional sites within your CDX registration profile to add additional sites to a form.

Click the 'Add Facility' button to generate the 'Add Facility' pop-up window which displays the following fields: 'Select a site from the drop-down menu below,' 'CBI,' 'Alias,' 'EPA Registry ID,' 'Facility Name,' 'Facility Address,' 'City,' 'State,' and 'Postal Code.' Each individual site may be claimed as CBI.

- Select a site from the drop-down menu below: Select a site that you will be reporting on from the drop-down menu.
- **CBI:** Check the 'CBI' checkbox to claim the facility information as confidential.
- Alias: Enter the site alias. This is a required field if a Joint Submission or Letter of Support is pending for the form.
- **EPA Registry ID:** Displays the EPA registry ID of the site selected from the drop-down menu.
- Facility Name: Displays the name of the site selected from the drop-down menu.
- Facility Address: Displays the address of the site selected from the drop-down menu.
- City: Displays the city of the site selected from the drop-down menu.
- **State:** Displays the state of the site selected from the drop-down menu.
- **Postal Code:** Displays the postal code of the site selected from the drop-down menu.
- **Add Facility:** Click the button to add the selected site to the main page from which you are initiating the search.
- Cancel: Click the button to cancel the process of adding a site.

Navigation: Click the 'Add Facility' button to add the selected site to the screen from which you initiated the site identification process.



4 PMN Secondary User

Anyone who plans to manufacture or import a new chemical substance for a non-exempt commercial purpose is required by Section 5 of TSCA to provide EPA with notice before initiating the activity, known as a PMN submission. A PMN must be submitted at least ninety (90) days prior to the manufacture or import of the chemical.

The PMN joint process is a multi-step process with coordination needed on the parts of Primary and Secondary users (including AOs and Agents/Consultants). The Primary user will first identify that a Joint Submission and/or Letter of Support(s) will supplement a form. Based on the selection, the 'Joint Submission' folder and/or 'Letter of Support' folder will generate in the navigation tree. Each folder will contain a section for the Primary user to enter contact information and instruction information with the Joint and/or Letter of Support unique identification number (ID).

When the Primary user enters the relevant 'Joint' or 'Letter of Support' folder, the user will enter the Secondary AO or Secondary Agent/Consultant's contact information on the first screen. The Primary user will use the email address entered on this screen to send the Secondary user the unique identification number. The next screen in the 'Joint' or 'Letter of Support' folder will display the unique identification number that will be sent to the Secondary AO or Secondary Agent/Consultant, and a text box for the Primary user to provide instructions or information to the Secondary user about what is to be filed.

The Secondary user will register in CDX as a Secondary AO and access the Section 5 Notices and Supports application. Once you arrive at the 'Section 5 Notices and Supports Forms' screen, click the 'Start New Form' button and navigate to the 'Create Passphrase' screen. For 'Joint PMN' and 'Letter of Support' forms, the process will work the same; other than being able to enter a foreign address for 'Letter of Support.' Once the Secondary AO has created a new form and assigned a passphrase, the Secondary AO may enter the required information on the form. On the 'Create Passphrase' screen, the Secondary AO will enter the unique identification number sent via email from the Primary AO's form. Once the Secondary AO has entered the unique identification number, the form will display.

4.1 Create Joint Submission

As a Secondary AO, you can start a new Letter of Support or Joint Submission and assign your Supports to complete the form.

4.1.1 General Form Information (Joint PMN)

You can navigate to the 'General Form Information' screen by entering the unique identification number provided by the AO and creating a passphrase on the 'Create Passphrase' screen. The 'General Form Information' screen allows you to identify information that is specific to the form type selected from the 'Section 5 Notices and Supports Forms' screen.

The 'General Form Information' screen provides fields to input identifying information for a specific form. You will have the option to assign a 'Form Alias' to identify the form. A unique form alias is helpful when a user or company has multiple forms and/or when you must differentiate between forms to the help desk. Upon navigating to the 'General Form Information' screen, the system auto-generates a default alias comprised of a form type, date stamp, and time stamp in the following format: <Form Type-YYYYMMDD-HH:MM:SS Time Zone>.



The 'PMN Identification' section provides fields for you to enter information regarding other communications with EPA by entering a 'TS Number' and 'Payment ID.' The TS number is determined by a company and is used to identify the form for both payment and to connect related submissions when additional communications (Letters of Support, Joint Submissions, and corrections) are sent before a PMN/LVE case number has been assigned. The TS number can be any six (6) character alphanumeric combination. The TS number should include two (2), three (3), or four (4) letters. Company names, recognizable words, and numeric series are not recommended. A unique identification number for the form will generate later if a Letter of Support or Joint Submission is being filed.

The 'Test Data' section allows you to identify data that is included in the notice the Primary AO or Primary Agent/Consultant selected from the 'Type of Notice' drop-down menu. The following values will display as checkboxes: 'Environmental fate data,' 'Health effects data,' 'Environmental effects data,' 'Physical/Chemical properties,' 'Risk assessments,' 'Structure/Activity relationships,' 'Test data not in the possession or control of the submitter,' and 'Other data.' If you check 'Other Data,' the system will not to allow you to enter in the specific other information. More often than not, the remaining options under 'Test Data' provide sufficient information for information included in the PMN form.

You are required to submit all test data in your possession or control and to provide a description of all other data known to or reasonably ascertainable to you, if these data are related to the health and environmental effects on the manufacture, processing, distribution in commerce, use, or disposal of the new chemical substance. Standard literature citations may be submitted for data in the open scientific literature. Complete test data (written in English), not summaries of data, must be submitted if they do not appear in the open literature. You should clearly identify whether test data is on the substance or on an analog. In addition, the chemical composition of the tested material should be characterized. Data should be submitted according to the requirements of §720.50 of the Premanufacture Notification Rule (40 Code of Federal Regulations (CFR) Part 720).

- **Form Alias:** Enter the form alias. Upon navigating to the screen, the screen will autogenerate an editable form alias in the following format: <Form Type-YYYYMMDD-HH:MM:SS Time Zone>. This is a required field.
- TS Number: Enter the TS number related to the PMN form; this field accepts any six (6) character alphanumeric combination. It is used by the financial institution that receives payment for EPA when it notifies the Agency that the fee has been received. The TS number should include two (2), three (3), or four (4) letters. Company names, recognizable words, and numeric series are not recommended. TS numbers should be unique to the submission and should not be reused in subsequent submissions.
- Environmental fate data: Check the 'Environmental fate data' checkbox to indicate that the form contains environmental fate data.
- **Health effects data:** Check the 'Health effects data' checkbox to indicate that the form contains health effects data.
- Environmental effects data: Check the 'Environmental effects data' checkbox to indicate that the form contains environmental effects data.

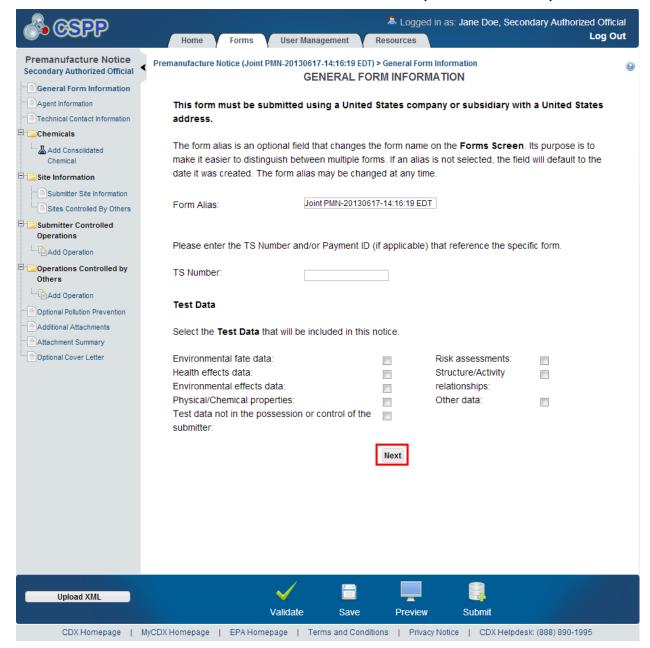


- **Physical/Chemical properties:** Check the 'Physical/Chemical properties' checkbox to indicate that the form contains physical/chemical properties data.
- Test data not in the possession or control of the submitter: Check the 'Test data not in the possession or control of the submitter' checkbox to indicate that the form contains test data not in the possession or control of the submitter.
- **Risk assessments:** Check the 'Risk assessments' checkbox to indicate that the form contains risk assessments data.
- **Structure/Activity relationships:** Check the 'Structure/Activity relationships' checkbox to indicate that the form contains structure-activity relationships (SAR) data.
- Other data: Check the 'Other data' checkbox to indicate that the form contains other types of data.

Navigation: Click the 'Next' button to navigate to the 'Agent Information' screen. You can also access this screen by clicking the 'Agent Information' link within the navigation tree.

4.1.2 Agent Information

You can access the 'Agent Information' screen by clicking the 'Next' button from the 'General Form Information' screen. You can also navigate to this screen by clicking the 'Agent Information' link within the navigation tree.



The 'Agent Information' screen provides fields for you to enter information regarding all parties involved in representing the PMN form. The agent should be a person who can answer questions about the form. The 'Agent Information' screen displays an 'Add Agent' button that generates the 'Add Agent' pop-up window for you to input the contact information on behalf of whom the submission is being made. You will be able to enter multiple agents; if the agent is the same individual who is filling out the form, click the 'Copy CDX Registration' button to retrieve user information entered during CDX registration. The system provides a checkbox for you to claim entered contact information as confidential by checking the 'Check here to claim this information as CBI' checkbox. Each agent will have an individual CBI claim. You will be able to enter contact information for each agent, and click the 'OK' button, which will populate the agent table located on the 'Agent Information' screen. Click the 'Delete' icon (X) located under the 'Actions' column to delete agents. To edit agent information, click the agent name link within the 'Last Name' column, which will generate the 'Add Agent' pop-up window with the previously entered agent information.

- Add Agent: Click the 'Add Agent' button to generate the 'Add Agent' pop-up window to enter information for multiple agents.
- Last Name: Displays the last name of the reported agent. Click the 'Last Name' link to generate the 'Add Agent' pop-up window and edit the agent information.
- First Name: Displays the first name of the reported agent.
- Address: Displays the mailing address of the reported agent.
- CBI: Indicates the CBI status of the agent information by displaying either a 'Y' or an 'N.'
- Actions: Click the 'Delete' icon (×) to delete specific agents; a warning message displays to confirm deletion of the agent information.

4.1.2.1 Add Agent

Click the 'Add Agent' button to generate the 'Add Agent' pop-up window. Enter agent information into the fields displayed on the 'Add Agent' pop-up window. Click the 'Cancel' button to stop populating agent information. Click the 'OK' button after entering agent information to populate the information on the main 'Agent Information' screen.

The identification of an agent is optional.

- Copy CDX Registration: Click the 'Copy CDX Registration' button to display a prompt confirming the import of CDX registration information and allow the system to populate the agent information fields with your contact information provided during CDX registration.
- Check here to claim this information as CBI: Check the 'Check here to claim this information as CBI' checkbox to claim agent information as confidential. If the 'CBI' checkbox is checked before clicking the 'Copy CDX Registration' button, the 'CBI' checkbox will become unchecked upon navigating back to the pop-up window after copying



- CDX registration information. Check the 'CBI' checkbox after importing CDX registration information to claim agent information as confidential.
- **First Name:** Enter the agent's first name. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form.
- Last Name: Enter the agent's last name. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form.
- **Position:** Enter the agent's job title.
- **Company Name:** Enter the agent's company name. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form.
- **Phone Number:** Enter the agent's daytime phone number: U.S. or international. This field does not allow dashes. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form.
- **Phone Extension:** Enter the agent's daytime phone number extension. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information.
- Email Address: Enter the agent's email address. The email address must follow the standard email address format: John.Doe@abc.com. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information.
- Mailing Address 1: Enter the first line of the agent's mailing address. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form.
- Mailing Address 2: Enter the second line of the agent's mailing address. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information.
- City: Enter the city of the agent's mailing address. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form.
- State: Select the state of the agent's mailing address from the drop-down menu. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form and if the 'Country' field is set to 'United States.' This field is disabled if a non-US country is selected from the 'Country' drop-down menu.
- **Postal Code:** Enter the postal code of the agent's mailing address. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This is a required field only if agent information will be added to the form and if the 'Country' field is set to 'United States.'

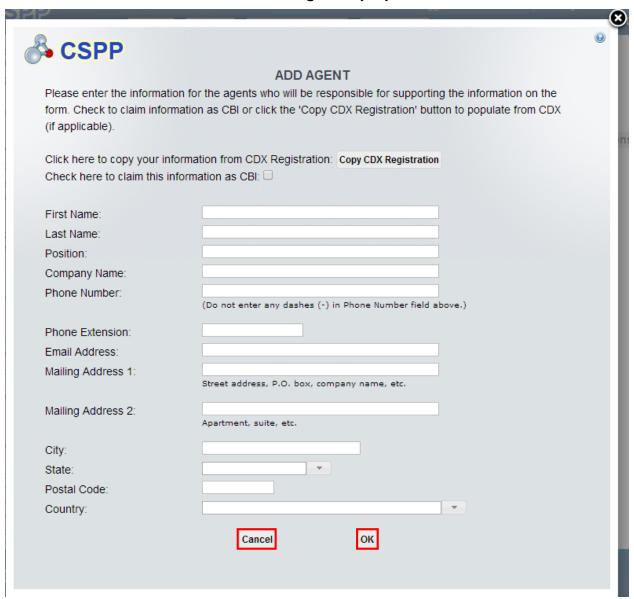
Country: Select the country of the agent's mailing address from the drop-down menu. Click the 'Copy CDX Registration' button to populate the fields with CDX registration information. This field is automatically set to 'United States' if a value is selected from the



'State' drop-down menu. This is a required field only if agent information will be added to the form.

4.1.3 Technical Contact Information

You can access the 'Technical Contact Information' screen by clicking the 'Next' button from the 'Agent Information' screen. You can also access this screen by clicking the 'Technical Contact Information' link within the navigation tree.

The technical contact should be able to answer, or obtain answers to, questions related to the chemical submitted to EPA within the joint PMN form or Letter of Support. The technical contact does not have to physically work at the site reported on the form, but must be readily available by phone or email. It is required to identify at least one technical contact.

The system provides functionality to enter multiple technical contacts. If the contact is the same person who is filling out the form, the system presents a 'Copy CDX Registration' button for you to retrieve your user information from CDX. You will enter the contact information for each technical contact within the 'Add Technical Contact' window and click the 'OK' button at the bottom of the window, which will populate the technical contacts table located on the 'Technical Contact Information' screen. Click the 'Delete' icon (X) located under the 'Actions' column to delete a technical contact. Click the technical contact name within the 'Last Name' column to edit technical contact information.

- Add Technical Contact: Click the 'Add Technical Contact' button to generate the 'Add Technical Contact' pop-up window, which provides fields for you to enter technical contact information.
- Last Name: Displays the last name of the reported technical contact. Click the 'Last Name' link to generate the 'Add Technical Contact' pop-up window that contains previously identified technical contact information to edit the technical contact information.
- First Name: Displays the first name of the reported technical contact.
- Address: Displays the address of the reported technical contact.
- **CBI:** Indicates the CBI status of the technical contact information by displaying either a 'Y' or an 'N.'
- Actions: Click the 'Delete' icon (×) to delete specific technical contacts. A pop-up generates to confirm the deletion of the technical contact information.

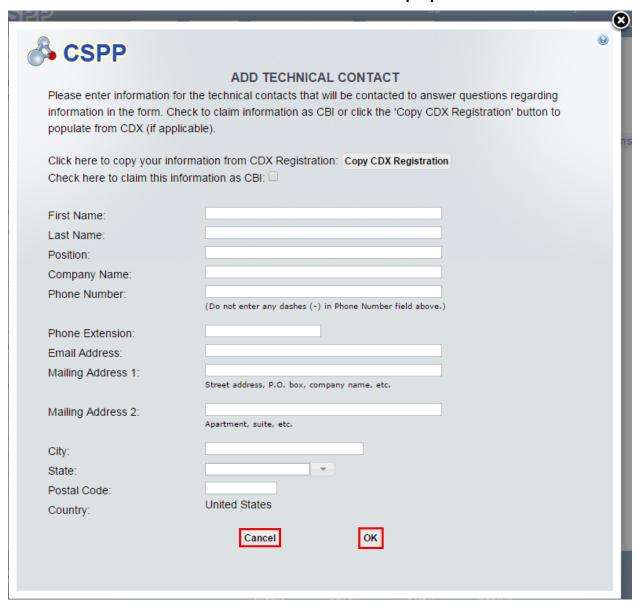

4.1.4 Chemical Identification

You can access the 'Chemical Identification' screen by clicking the 'Next' button from the 'Technical Contact Information' screen. You may also click the 'Add Consolidated Chemical' or 'Chemical Identification' links within the navigation tree access the 'Chemical Identification' screen.



The 'Chemical Identification' screen identifies the type of chemical the submitter will be entering into the application. You will be able to file a Joint PMN form for a class 1 or 2 chemical substance or a polymer. Based on your selection, the appropriate screens for the respective chemical will appear. If you select the 'Class 1 or 2 Chemical Substance' radio button, click the 'Save' icon () within the bottom action bar, or click the 'Next' button to generate the 'Class 1 or 2 Chemical Substances' screen within the navigation tree. If you identify the chemical as a polymer by selecting the 'Polymer' radio button, click the 'Save' icon () within the bottom action bar, or click the 'Next' button to generate the 'Polymer Identification Information' screen and the 'Monomers and Other Reactants' screen within the navigation tree.

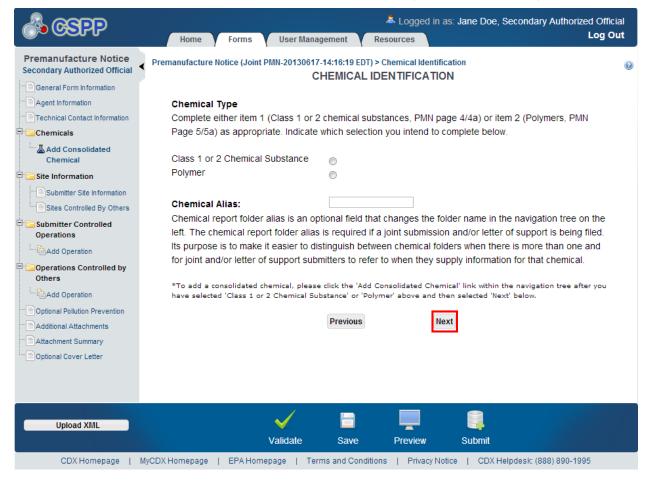
This screen provides a field to identify an alias for the chemical substance, and allows you to identify chemicals in a consolidated chemical submission. The chemical alias is required if a Joint Submission or Letter of Support is being filed and renames the chemical folder within the navigation tree.

- Class 1 or 2 Chemical Substance: Select the 'Class 1 or 2 Chemical Substance' radio button to indicate that the chemical is a class 1 or 2 substance. If you select the 'Polymer' radio button after initially selecting the 'Class 1 or 2 Chemical Substance' radio button, the application generates a confirmation message warning you that you will lose all data for this chemical if the chemical type changes. Selecting either the 'Class 1 or 2 Chemical Substance' or 'Polymer' radio button is required.
- **Polymer:** Select the 'Polymer' radio button to indicate that the chemical is a polymer. If you select the 'Class 1 or 2 Chemical Substance' radio button after initially selecting the 'Polymer' radio button, the application generates a confirmation message warning you that you will lose all data for this chemical if the chemical type changes. Selecting either the 'Class 1 or 2 Chemical Substance' or 'Polymer' radio button is required.
- Chemical Alias: Enter the chemical alias to associate with a chemical. This field will autogenerate a chemical alias in the navigation tree upon leaving the screen if this field is left blank. This field is required.

Navigation: If you selected the 'Class 1 or 2 Chemical Substance' radio button, click the 'Next' button to navigate to the 'Class 1 or 2 Chemical Substances' screen. You can also access this screen by clicking the 'Class 1 or 2 Chemical Substances' link within the navigation tree.

If you selected the 'Polymer' radio button, click the 'Next' button to navigate to the 'Polymer Identification Information' screen. You can also navigate to this screen by clicking the 'Polymer Identification Information' link within the navigation tree.

4.1.5 Class 1 or 2 Chemical Substances

You can access the 'Class 1 or 2 Chemical Substances' screen if you selected the 'Class 1 or 2 Chemical Substance' radio button on the 'Chemical Identification' screen and clicked the 'Next' button. You can also access this screen by clicking the 'Class 1 or 2 Chemical Substances' link within the navigation tree.

The 'Class 1 or 2 Chemical Substances' screen provides fields for you to enter information describing the chemical for which the PMN is to be filed. This screen will outline the unique chemical properties that show the name, composition, and structure of the chemical. The system provides fields for you to identify several key aspects concerning a chemical's identity.



For a single component submission, create the field set by clicking the 'Add New Chemical' button. Upon clicking the 'Add New Chemical' button, the application generates an expandable/collapsible field set containing numerous fields for you to enter information pertaining to that particular chemical.

For a multi-component submission, create another field set by clicking the 'Add New Chemical' button. Multi-component chemical submissions occur when two or more chemicals are always generated together in a single pot and are never isolated. Upon clicking the 'Add New Chemical' button, the application generates a field set containing numerous fields for you to enter information pertaining to that particular chemical. Enter additional chemical components, each with unique identifying information, by clicking the 'Add New Chemical' button for each additional chemical that is part of the multi-component mixture. All multi-component chemicals will reside in one chemical folder in the navigation tree. Duplicate chemicals are not allowed within a multi-component submission.

For a consolidated submission, create and identify chemicals in separate chemical folders by clicking the 'Add Consolidated Chemical' link within the navigation tree.

If you select the 'Class 1' radio button on the 'Class 1 or 2 Chemical Substances' screen, click the 'Next' button to navigate to the 'Additional Chemical Information' screen. If you select the 'Class 2' radio button on the 'Class 1 or 2 Chemical Substances' screen, click the 'Next' button to navigate to the 'Class 2 Substances' screen.

For a class 1 substance chemical structure diagram, provide a complete and correct chemical structure diagram. A class 1 structural diagram should clearly and completely indicate the identity of the atoms and the nature and location of the bonds joining the atoms. Provide ionic charges and known stereo chemical details. Carbon atoms in ring systems do not need to be explicitly shown.

For a class 2 substance chemical structure diagram:

- 1) List the immediate precursor substances with their respective CASRN.
- 2) Describe the nature of the reaction or process.
- 3) Indicate the range of composition and the typical composition (where appropriate).
- 4) Provide a correct representative or partial chemical structure diagram, as complete as can be known, if one can be reasonably ascertained.

Provide partial, complete, or representative structural diagrams to the extent possible. The diagram should indicate the characteristic or variable compositional structural components of the substance. If you are unsure of the exact structure, provide the best information you have and indicate that it is your best estimate of the chemical structure.

- Add New Chemical: Click the button to generate the class 1 or 2 chemical substances expandable/collapsible field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.



- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.
- **Expand All:** Click the 'Expand All' link located at the upper-right of the expandable/collapsible field sets to expand a series of field sets.
- Collapse All: Click the 'Collapse All' link located at the upper-right of the expandable/collapsible field sets to collapse a series of field sets.
- **B.1.a.** Class of Substance: In section B.1.a., select the 'Class 1' or 'Class 2' radio button to identify whether a 'Class 1' or 'Class 2' chemical substance is being reported. Selecting the 'Class 2' chemical substance radio button indicates that some portions of the structure may not be known and a 'Class 2 Substances' screen will appear within the navigation tree after clicking the 'Next' button for you to enter information concerning how the chemical was created. If multiple 'Class 2' chemical components are added, only one 'Class 2 Substances' screen will generate that applies to all the components. Check the 'CBI' checkbox to claim the chemical substance class as confidential. Either the 'Class 1' or 'Class 2' radio button must be selected.
- Class 1: Select the 'Class 1' radio button to identify the chemical as a 'Class 1' substance. A 'Class 1' substance is a single molecular entity that can be represented by a single, definite structural diagram. Either the 'Class 1' or the 'Class 2' radio button in the 'B.1.a. Class of Substance' section is required.
- Class 2: Select the 'Class 2' radio button to identify the chemical as a 'Class 2' substance. A 'Class 2' substance is a substance whose composition cannot be represented by a single, definite chemical structural diagram. Class 2 substances include substances of unknown, variable, or uncertain composition, complex mixtures or reaction products, or well-defined substances without specific structures. Either the 'Class 1' or the 'Class 2' radio button in the 'B.1.a. Class of Substance' section is required.
- CBI: Check the 'CBI' checkbox to claim the 'Class of Substance' as confidential.
- **Search SRS:** Click the 'Search SRS' button to generate the 'Search Substance Registry Services' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the search SRS functionality.
- **CASRN:** Displays the CASRN of the chemical identified on the 'Search Substance Registry Services' pop-up window, if applicable.
- Chemical Name: Displays the chemical name of the chemical identified on the 'Search Substance Registry Services' pop-up window. For class 1 substances, a 'Chemical Abstracts (CA) Index Name' must be provided. For class 2 substances either a 'CA Index Name' or 'CA Preferred Name' must be provided, whichever is appropriate based on current CA nomenclature rules and conventions. This is a required field.



- **CBI:** Check the 'CBI' checkbox to claim the 'Chemical Name' field as confidential and generate the 'Generic Chemical Name' text field.
- **B.6. Generic Chemical Name:** Enter the generic name to associate with a chemical. This field only displays when 'CASRN' and 'Chemical Name' are marked as 'CBI.' This is a required field if there is no pending Letter of Support or Joint Submission for the form.
- Method 1 (CAS Inventory Expert Service): Select the 'Method 1 (CAS Inventory Expert Service)' radio button to identify the ID method as the CAS Inventory Expert Service (IES) method and generate the 'IES Order #' field. A copy of the identification report obtained from the CAS Inventory Expert Services must be submitted as an attachment to this notice; an IES report is required. For a consolidated submission, each chemical must be 'Method 1' except when the submission is pending a Letter of Support for that chemical. In the case of an LVE/LOREX modification form type, this 'Method 1' requirement is not applicable. A single response option in the 'B.1.c. ID Method' section is required if there is no pending Letter of Support or Joint Submission for the form.
- Method 2 (Other Method): Select the 'Method 2 (Other Method)' radio button to identify the ID method as 'Other Method.' An alternative method of providing a name, such as a Scientific and Technical Information Network (STN) database report or a CAS Client Services report, qualifies as 'Method 2.' The chemical can be 'Method 2' if the consolidated submission is pending a Letter of Support. A single response option in the 'B.1.c. ID Method' section is required if there is no pending Letter of Support or Joint Submission for the form.
- **IES Order** #: Enter the IES order number of the report. This field only displays when the 'Method 1 (CAS Inventory Expert Service)' radio button is selected.
- **B.1.d. Molecular Formula:** Enter the molecular formula associated with a chemical. The molecular formula must give the correct identity and number of atoms of each element contained in the PMN molecule or a description if the substance is a class 2 material. The system will not allow subscripts and superscripts to be used.
- CBI: Check the 'CBI' checkbox to claim the 'Molecular Formula' data as confidential.
- Attachments: Select the section of the page the file is associated with that you intend to attach from the drop-down menu. This drop-down menu contains the following values: 'Chemical Structure Diagram' and 'ID Method.' This is a required field to upload an attachment.
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section** Error! Reference source not found. for further details regarding the attach document functionality.
- **Section:** Displays the section associated with a document.
- **File Name:** Displays the file name and file extension of the file that is uploaded on the 'Attach Documents' pop-up window.
- **Description:** Displays the description associated with a document.
- Pages: Displays the number of pages a document contains.
- **CBI:** Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'



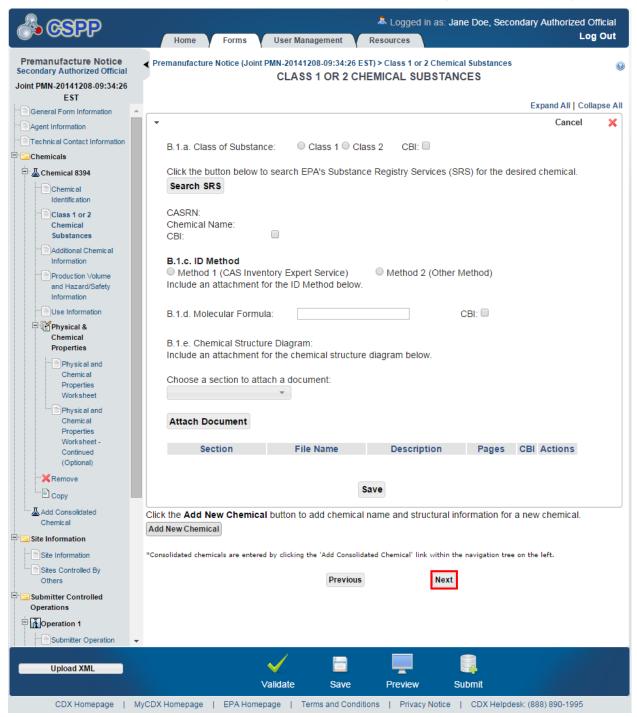
- Actions: Click the 'Delete' icon (×) to delete the entire document row permanently from the system; a warning message displays to confirm the deletion of the document.
- Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able to navigate away from the screen using the 'Previous' and 'Next' buttons. Refer to Section 3.8 for more information regarding the save functionality in an expandable/collapsible field set.

4.1.6 Class 2 Substances

You can access the 'Class 2 Substances' screen by clicking the 'Next' button from the 'Class 1 or 2 Chemical Substances' screen when you select the 'Class 2' radio button for the 'Class of Substance' field. You can also access this screen by clicking the 'Class 2 Substances' link within the navigation tree.

The 'Class 2 Substances' screen captures information regarding a class 2 chemical substance. A class 2 chemical substance is a substance that may not have a defined chemical structure that has been identified. This screen provides fields to identify specific elements in the creation of the chemical using the following fields: 'Precursor Substances,' 'Nature of Reaction,' and 'Range of Composition.'

Enter precursor substances by searching SRS or using manual entry when the substance is not in SRS. The selected substances will display in a table listing the 'Chemical Name' and 'CASRN.'

The system provides fields to capture 'Nature of Reaction' and 'Range of Composition' in text boxes. The 'Nature of Reaction' and 'Range of Composition' text boxes can be claimed as CBI.

- **B.1.e.1. Precursor Substances:** This table captures the chemicals identified as immediate precursor substances, along with the respective CASRNs, if applicable.
- **CBI:** Check the 'CBI' checkbox to claim the precursor substances information as confidential.
- **Search SRS:** Click the 'Search SRS' button to generate the 'Search Substance Registry Services' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the search SRS functionality.
- Chemical Name: Displays the chemical name associated with a precursor substance. Click the chemical name link to generate the 'Search SRS' pop-up window to make edits.
- CASRN: Displays the CASRN, if applicable, associated with a precursor substance.
- Actions: Click the 'Delete' icon (×) to delete the entire chemical row permanently from the system; a warning message displays to confirm the deletion of the chemical.
- **B.1.e.2. Nature of Reaction:** Enter the nature of the reaction or process description.
- CBI: Check the 'CBI' checkbox to claim the nature of reaction information as confidential.
- **B.1.e.3. Range of Composition:** Enter the range of composition and the typical composition description. Provide the range of composition in weight percent for each specific component or class of components that you intend to manufacture for commercial purposes.
- **CBI:** Check the 'CBI' checkbox to claim the range of composition information as confidential.
- Attachments: Select the section of the page the document you intend to attach is associated with from the drop-down menu. This drop-down menu contains the following values: 'B.1.e.1. Precursor Substances,' 'B.1.e.2. Nature of Reaction,' and 'B.1.e.3. Range of Composition.' This is a required field.



- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window and initiate the document upload process. Refer to **Section** Error! Reference source not found. for further details regarding the attach document functionality.
- Section: Displays the section associated with a document.
- **File Name:** Displays the file name and file extension of a file that is uploaded on the 'Attach Documents' window.
- **Description:** Displays the description associated with a document.
- **Pages:** Displays the number of pages a document contains.
- **CBI:** Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'
- Actions: Click the 'Delete' icon (×) to delete the entire document row permanently from the system; a warning message displays to confirm the deletion.

Exhibit 4-8: Class 2 Substances Screen (Joint Submission) (Scroll 1)

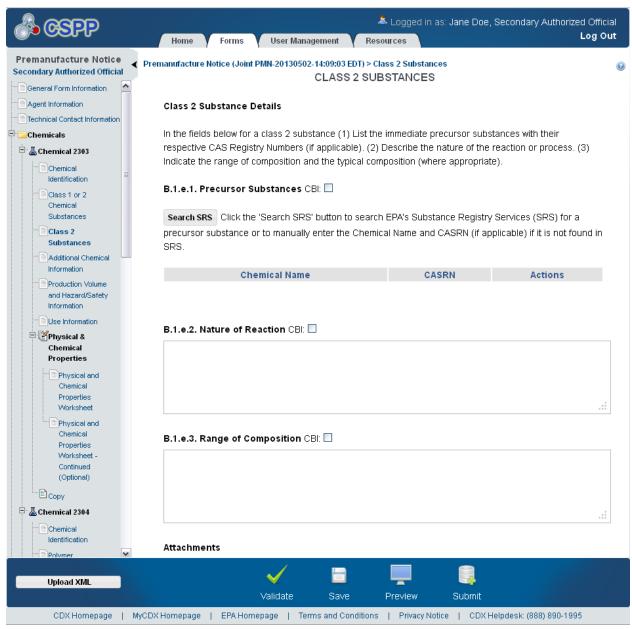

4.1.7 Additional Chemical Information

You can navigate to the 'Additional Chemical Information' screen by selecting the 'Class 1' radio button on the 'Class 1 or 2 Chemical Substances' screen and clicking the 'Next' button, by clicking the 'Next' button on the 'Class 2 Substances' screen, or clicking the 'Next' button from



the 'Monomers and Other Reactants' screen. You can also access this screen by clicking the 'Additional Chemical Information' link within the navigation tree.

The 'Additional Chemical Information' screen captures information regarding the chemicals produced as byproducts and impurities when a chemical is manufactured. This screen also captures other names for the chemical at hand in the 'Synonyms' and 'Trade Identification' tables.

An 'Impurities' table displays information regarding the impurities that may be reasonably anticipated to be in the respective chemical or polymer as manufactured for commercial purpose. Click the 'Search SRS' button to access the 'Search SRS' pop-up window and populate the 'Impurities' table. You will also be able to enter a chemical using the 'Chemical Name' and 'CASRN' field (if applicable) on the 'Chemical Not Found In Substance Registry Services' pop-up window. If there are unidentified impurities, enter "unidentified." You also have the option of claiming the chemical as confidential by checking the 'CBI' checkbox. A 'Maximum %' field is also displayed which captures the maximum percentage for the impurity. Documents may be attached for the 'Impurities' section if necessary.

A 'Byproducts' table provides fields to capture information regarding the byproducts that may be produced from the manufacture of the respective chemical or polymer. Click the 'Search SRS' button to access the 'Search SRS' pop-up window and populate the 'Byproducts' table. You may associate a CASRN with a byproduct (if applicable) and check the 'CBI' checkbox to claim a byproduct as confidential. Documents may be attached for the 'Byproducts' section if necessary.

A 'Synonyms' table provides fields to capture the synonyms that the respective chemical or polymer may be referred to in the documentation. A maximum of five synonyms can be entered in the table. The search SRS functionality cannot be used to populate the 'Synonyms' table. You may attach documents associated with the 'Synonyms' section to provide additional synonyms if necessary.

A 'Trade Identification' table provides fields to capture information about the trade names by which the respective chemical or polymer may be referred in documentation. There is no limit to the number of trade names that may be added. You may attach documents associated with the 'Trade Identification' section to provide additional information if necessary.

The 'Attach Documents' pop-up window provides fields to upload documents related to the 'Impurities,' 'Byproducts,' 'Synonyms,' and/or 'Trade Identification' section(s). Select the section of the page the document is associated with from the 'Section' drop-down menu, and click the 'Attach Document' button to generate the 'Attach Documents' pop-up window and attach a document. The system provides a 'CBI' checkbox to claim the uploaded document as confidential. If you claim a document as CBI, the system requires you to upload the sanitized version of the attached document.

If the sanitized version of the document is not provided, the Section 5 Notices and Supports form will fail validation upon navigating away from the 'Attach Documents' window. To view or edit previously attached documents, click the appropriate file name of the document within the 'File Name' column of the attachments table.

The attachments table displays the section of the page the document is associated with, the file name and file extension of the document, the document description, the number of pages in the document, and if the document was claimed CBI. Click the 'Delete' icon (×) located under the 'Actions' column to delete unwanted documents. Click a file name link in the 'File Name'



column to generate the 'Attach Documents' pop-up window to view and/or edit an attached document.

- **B.3. Impurities Search SRS:** Click the 'Search SRS' button to display the 'Search Substance Registry Services' pop-up window. Refer to **Section** Error! Reference source not found. for further details regarding the search SRS functionality.
- Impurity: Displays the name of the impurity. An impurity is a chemical substance that you did not intend to be present with your PMN substance. List all known impurities that are present, regardless of their weight percent. List the expected maximum percentage of each impurity and indicate its confidentiality status. An impurity may be suggestive of chemical precursors or chemical processes. Click the 'Impurity' link to navigate to the 'Search Substance Registry Services' pop-up window to edit chemical information for an impurity.
- CASRN: Displays the Chemical Abstracts Service Registry Number for the impurity (if applicable).
- **Maximum %:** Displays the maximum percentage for the impurity; decimal values are accepted.
- **CBI:** Indicates the CBI status of the impurity by displaying either a 'Y' or an 'N.'
- Action: Click the 'Delete' icon (×) to delete the entire impurity entry permanently from the system; a warning message displays to confirm the deletion.
- **B.7. Byproducts Search SRS:** Click the 'Search SRS' button to generate the 'Search Substance Registry Services' pop-up window. Refer to **Section** Error! Reference source not found. for further details regarding the search SRS functionality.
- **Byproduct Name:** Displays the name of the byproduct. Describe any byproducts resulting from the manufacture, processing, use, or disposal of the new chemical substance. List any byproducts that you reasonably anticipate will result from the manufacture, processing, use and disposal of the new chemical substance at sites under your control. Click the 'Byproduct Name' link to generate the 'Search Substance Registry Services' pop-up window to view and/or edit byproduct information. Provide the specific chemical name, CAS numbers if they can be determined, and the confidential status of the byproducts formed. If no byproducts are formed, enter "None" or leave the section blank.
- **CASRN:** Displays the CASRN for the byproduct (if applicable).
- CBI: Indicates the CBI status of the byproduct by displaying either a 'Y' or an 'N.'
- Action: Click the 'Delete' icon (×) to delete the entire byproduct entry permanently from the system; a warning message displays to confirm the deletion.
- **B.4. Synonyms CBI:** Check the 'CBI' checkbox to claim the 'Synonym' field set as confidential.
- Synonym: Enter the synonym of the chemical; there is a maximum of five chemical synonyms that can be added in the 'Synonyms' table. Additional synonyms can be provided in an attachment. Synonyms include common chemical names used in scientific or technical literature, and code numbers or code names referenced in the PMN and its attachments. Indicate which synonyms may be proprietary and require CBI protection. Chemical name synonyms must be consistent with the chemical structure and thus not misleading. If you add a blank, editable line in this table and click the 'Next' button, no error will display indicating



that the blank line should be saved or deleted. If text is entered in a blank field and you click the 'Next' button, the application will save the entered value. If you click the 'Form' icon (), edit the entered values and click the 'Next' button without saving the changed value, an error will generate.

- Actions: Click the 'Add' icon () to add a new text field to enter additional synonyms. Click the 'Save' icon () to save a chemical synonym. Click the 'Form' icon () that appears after saving to edit a chemical synonym. Click the 'Delete' icon () to delete a previously added chemical synonym. To cancel changes to a field, simply clear the data entered in the field.
- **B.5. Trade Identification CBI:** Check the 'CBI' checkbox to claim the trade identification section as confidential.
- **Trade Name:** Enter the trade identification name. List any trade name that is used or will be used for the neat chemical substance, whether or not they are registered brands/trademarks. There is no limit to the number of trade names that can be added. Check the 'CBI' checkbox to indicate the CBI status of trade names. If you add a blank, editable line in this table and click the 'Next' button, no error will display indicating that the blank line should be saved or deleted. If text is entered in a blank field and you click the 'Next' button, the application will save the entered value. If you click the 'Form' icon (), change the entered value(s) and click the 'Next' button without saving the changed value(s), an error message will generate.
- Actions: Click the 'Add' icon (♣) to add a new text field to enter additional trade identification names. Click the 'Save' icon (♣) to save a trade identification name. Click the 'Form' icon (♠) to edit a trade identification name. Click the 'Delete' icon (★) to delete a previously added trade identification name.
- Attachments: Select the section of the page with which the document is associated from the drop-down menu. This drop-down menu contains the following values: 'Byproducts Section,' 'Impurities Section,' 'Synonyms Section,' and 'Trade Identification Section.'
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section** Error! Reference source not found. for further details regarding the attach document functionality.
- **Section:** Displays the section of the page with which the document is associated.
- **File Name:** Displays the file name and file extension of the file that is uploaded on the 'Attach Documents' pop-up window.

Exhibit 4-10: Additional Chemical Information Screen (Joint Submission) (Scroll 1)

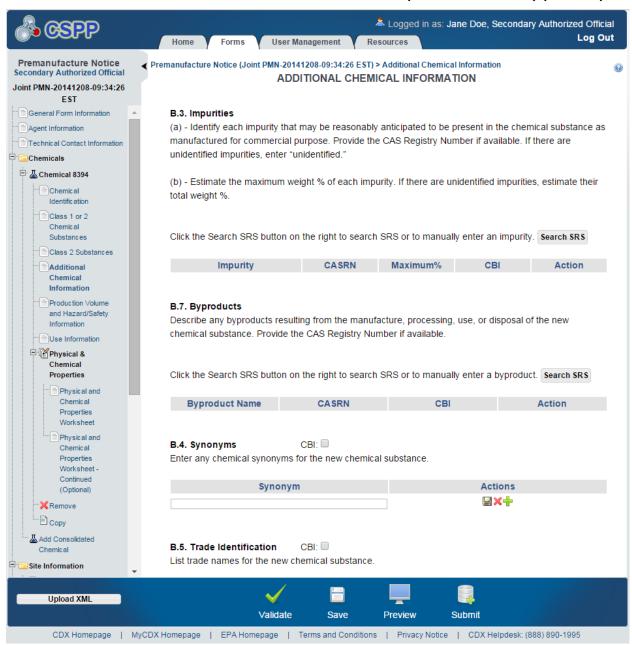
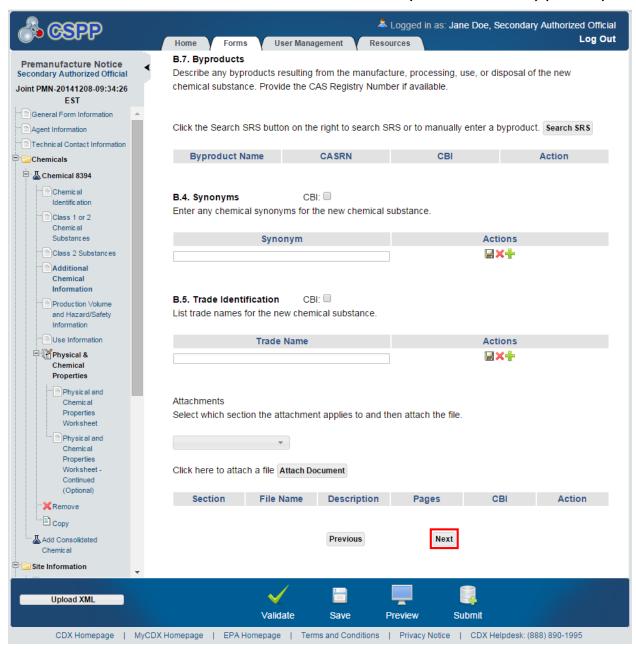

4.1.8 Polymer Identification Information

You can access the 'Polymer Identification Information' screen by clicking the 'Next' button from the 'Chemical Identification' screen if you select the 'Polymer' radio button. You can also



access this screen by clicking the 'Polymer Identification Information' link within the navigation tree after selecting the 'Polymer' radio button on the 'Chemical Identification' screen.

The 'Polymer Identification Information' screen captures information describing the polymer(s) for which the PMN will be filed. This screen outlines the unique chemical properties that show the name, composition, and structure of the polymer. The system will provide fields for you to identify several key aspects concerning a polymer's identity.

Click the 'Add New Chemical' button to create a chemical field set. Upon clicking the 'Add New Chemical' button, an expandable/collapsible field set generates that contains numerous fields that pertain to the particular polymer. You are able to enter multiple chemical substances, each with unique information, by clicking the 'Add New Chemical' button for each chemical you wish to identify.

For a single component submission, create the field set by clicking the 'Add New Chemical' button. Upon clicking the 'Add New Chemical' button, the application generates a field set containing numerous fields that captures information pertaining to that particular chemical.

For a multi-component submission, click the 'Add New Chemical' button to create a field set. Multi-component chemical submissions occur when two or more chemicals always generate together in a single pot and are never isolated. Upon clicking the 'Add New Chemical' button, the application generates a field set that provides numerous fields to enter information pertaining to that particular chemical. Enter additional chemical substances, each with unique identifying information, by clicking the 'Add New Chemical' button for each additional chemical that is part of the multi-component mixture. All multi-component chemicals will reside in one chemical folder in the navigation tree.

For a consolidated submission, create separate chemical folders by clicking the 'Add Consolidated Chemical' link within the navigation tree. A form may contain a maximum of six (6) separate chemical folders.

- Add New Chemical: Click the 'Add New Chemical' button to generate a polymer identification information expandable/collapsible field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set; a confirmation message displays to confirm the deletion.
- Expand All: Click the link located at the upper-right of the expandable/collapsible field sets to expand a series of field sets.
- **Collapse All:** Click the link located at the upper-right of the expandable/collapsible field sets to collapse a series of field sets.



- **Search SRS:** Click the button to generate the 'Search SRS' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the search SRS functionality.
- **CASRN:** Displays the CASRN of the chemical identified on the 'Search SRS' pop-up window, if applicable.
- **Chemical Name:** Displays the name of the chemical that has been identified on the 'Search SRS' pop-up window.
- **CBI:** Check the 'CBI' checkbox to identify the chemical as confidential.
- **B.6 Generic chemical name:** Enter the generic name to associate with a chemical. This field displays when 'Chemical Name' and 'CASRN' are CBI. This is a required field.
- Method 1 (CAS Inventory Expert Service): Select the 'Method 1 (CAS Inventory Expert Service)' radio button to identify the ID method as the 'CAS Inventory Expert Service' method. Submit a copy of the identification report obtained from the CAS Inventory Expert Services as an attachment to this notice. For a consolidated submission, each chemical must be 'Method 1' except when the submission is pending a Letter of Support for that chemical. Select the 'Method 1 (CAS Inventory Expert Service)' radio button to generate the 'IES Order #' field. A single response option in the 'ID Method' section is required if there is no pending Letter of Support or Joint Submission for the form.
- **IES Order** #: Select the 'Method 1 (CAS Inventory Expert Service)' radio button to generate this field. Enter the IES order number. This is a required field if there is no pending Letter of Support or Joint Submission for the form.
- Method 2 (Other Method): Select the 'Method 2 (Other Method)' radio button to identify the ID method as 'Other Method.' An alternative method of providing a name, such as a STN database report or a CAS Client Services report, qualifies as 'Method 2.' If the chemical is pending a Letter of Support, the method can only be 'Method 2.' A single response option in the 'ID Method' section is required if there is no pending Letter of Support or Joint Submission for the form.
- Attachments: Select the section of the page with which the document is associated from the drop-down menu. This drop-down menu contains the following values: 'Chemical Structure Diagram' and 'ID Method.' It is required that a document be attached for the ID Method if there is no pending Letter of Support or Joint Submission for the form.
- Attach Document: Click the button to generate the 'Attach Documents' pop-up window. Refer to Section Error! Reference source not found. for additional details regarding the attach document functionality.
- **Section:** Displays the section of the page with which the file is associated.
- **File Name:** Displays the file name and file extension of a document that is uploaded on the 'Attach Documents' window.
- **Description:** Displays the description of a document.
- Pages: Displays the number of pages in a document.
- CBI: Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'

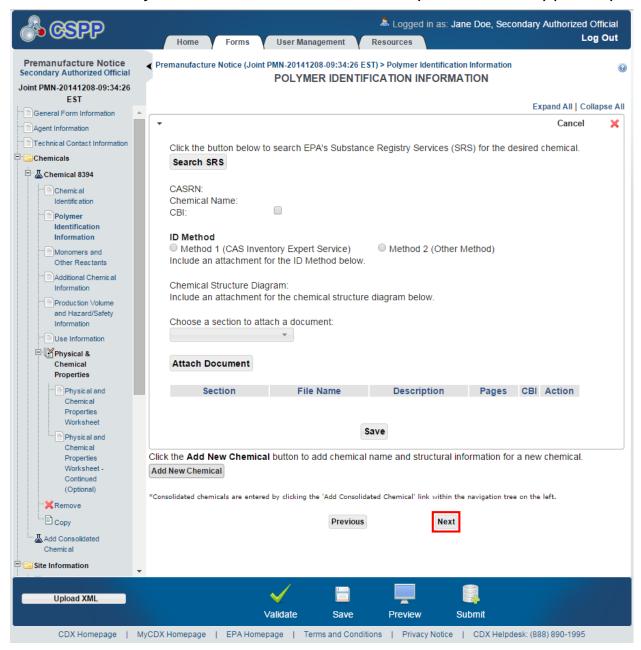

4.1.9 Monomers and Other Reactants

You can navigate to the 'Monomers and Other Reactants' screen by clicking the 'Next' button from the 'Polymer Identification Information' screen. You can also access this screen by clicking the 'Monomers and Other Reactants' link within the navigation tree.

The 'Monomers and Other Reactants' screen is used to identify the chemical measurements and monomers that make up a polymer. The screen is divided into two sections to identify different elements describing a polymer: 'Polymer Weight Information' and 'Monomers and Other Reactants.'

In the 'Monomers and Other Reactants' section, enter the typical weight percent of each monomer or other reactant in the polymer. Enter the maximum weight percent of each monomer or other reactant that may be present as a residual in the polymer as manufactured for commercial purposes. The maximum residual should be less than the typical composition. Do not use parts per million (ppm) units (1 ppm = 0.0001 wt%).

To reference a monomer cleared with an LVE, include an attachment detailing any specifics.

Please note that in IE 7, the % symbols that display to the right of the 'max. weight % below 500 molecular weight' and 'max weight % below 1000 molecular weight' fields might be slightly misaligned.

- **CBI:** Check the 'CBI' checkbox to claim the 'Polymer Weight Information' section as confidential.
- Method of Measurement: Only a single response option can be selected for 'Method of Measurement;' valid values include 'GPC' and 'Other (Specify).' Gel-permeation chromatography (GPC) is a well-established method for establishing the number average molecular weight (M_n) and weight fractions below 500 and 1,000 Daltons. It may not be useful for all polymer evaluations; however, solubility problems and misleading calibration standards can lead to questionable GPC data. Correction estimates can be documented and presented in cases where only a soluble fraction of the polymer can be analyzed. This is a required field if there is no pending Letter of Support or Joint Submission for the form.
- **Specify other method of measurement:** Enter the method of measurement when you select the 'Other (Specify)' radio button as the method of measurement. This is a required field when the 'Other (Specify)' radio button is selected.
- (i) lowest number avg. molecular weight: Enter the lowest number average molecular weight; the entered value must be a positive numerical value and can contain decimal values. This is a required field if there is no pending Letter of Support or Joint Submission.
- (ii) max. weight % below 500 molecular weight: Enter the maximum weight percentage below 500 molecular weight; the value entered must be a positive numerical value greater than or equal to zero (0), but less than or equal to one hundred (100) and can contain decimal values. This value must be less than or equal to the value specified in the '(iii) max. weight % below 1000 molecular weight' field. This is a required field if there are no pending Joint Submissions or Letters of Support.
- (iii) max. weight % below 1000 molecular weight: Enter the maximum weight percentage below 1,000 molecular weight; the value entered must be a positive numerical value greater than or equal to zero (0) but less than or equal to one hundred (100) and can contain decimal



values. This value must be greater than or equal to the value specified in the '(ii) max. weight % below 500 molecular weight' field. This is a required field if there are no pending Joint Submissions or Letters of Support.

- **Add Monomer:** Click the 'Add Monomer' button to generate the monomer expandable/collapsible field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.
- **Expand All:** Click the 'Expand All' link located at the upper-right of the expandable/collapsible field sets to expand a series of field sets.
- Collapse All: Click the 'Collapse All' link located at the upper-right of the expandable/collapsible field sets to collapse a series of field sets.
- **Search SRS:** Click the 'Search SRS' button to generate the 'Search Substance Registry Services' pop-up window. Refer to **Section** Error! Reference source not found. for additional details regarding the search SRS functionality.
- Monomer or Other Reactant: Displays the monomer or other reactant name; this field populates based on information entered on the 'Search SRS' pop-up window. This is a required field.
- **Include in Identity:** Check the 'Include in Identity' checkbox to claim the value for 'Monomer or Other Reactant' as part of the monomer identification. This checkbox is most applicable for monomers that are less than or equal to 2% since the monomer is not considered to be included in the identity unless this checkbox is checked. This checkbox appears when a value of '2' or less is entered into the 'Typical Composition' text field.
- **CBI:** Check the 'CBI' checkbox to claim the monomer or other reactant name and CASRN as confidential.
- CAS Registry Number: Displays the CASRN for the specified monomer; this field populates based on information entered on the 'Search SRS' pop-up window.
- Chemical Name: Displays the name of the chemical identified on the 'Search SRS' pop-up window.
- **Typical Composition:** Enter the typical composition value that a monomer contributes to a polymer; the value entered must be a positive numerical value greater than zero (0) and less than or equal to one hundred (100) and can contain decimal values. If the value entered is less than or equal to '2' a warning will be displayed in the global 'Validate' function or during the submission process indicating that the typical composition is a value that is less



- than or equal to 2 percent and asking you whether it should be included in the chemical identity. This is a required field, and the value must be greater than zero (0).
- **CBI:** Check the 'CBI' checkbox to claim the 'Typical Composition' and 'Include In Identity' fields as confidential.
- Maximum Residual: Enter the maximum residual value. Indicate the maximum weight percent of each monomer or other reactant that may be present as a residual in the polymer as manufactured for commercial purposes. Enter a percent value less than or equal to the maximum weight; do not use ppm units (1 ppm = 0.0001 wt%). The value entered must be a positive numerical value that is less than or equal to the typical composition value. This is a required field.
- CBI: Check the 'CBI' checkbox to claim the 'Maximum Residual' field as confidential.
- Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able to navigate away from the screen using the 'Previous' and 'Next' buttons. Refer to Section 3.8 for more information regarding the save functionality in an expandable/collapsible field set.
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the attach document functionality.
- **File Name:** Displays the file name and file extension of the document that is uploaded on the 'Attach Documents' pop-up window. Click the file name link to navigate to the 'Attach Documents' pop-up window to make any edits.

Exhibit 4-12: Monomers and Other Reactants Screen (Joint Submission) (Scroll 1)

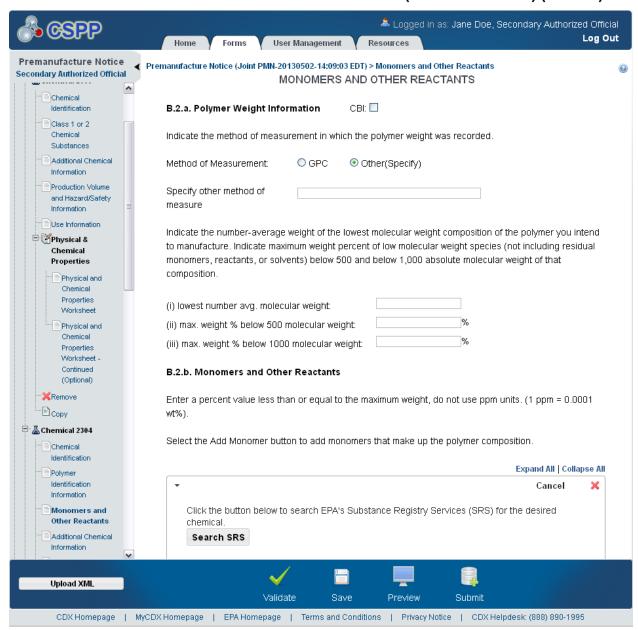
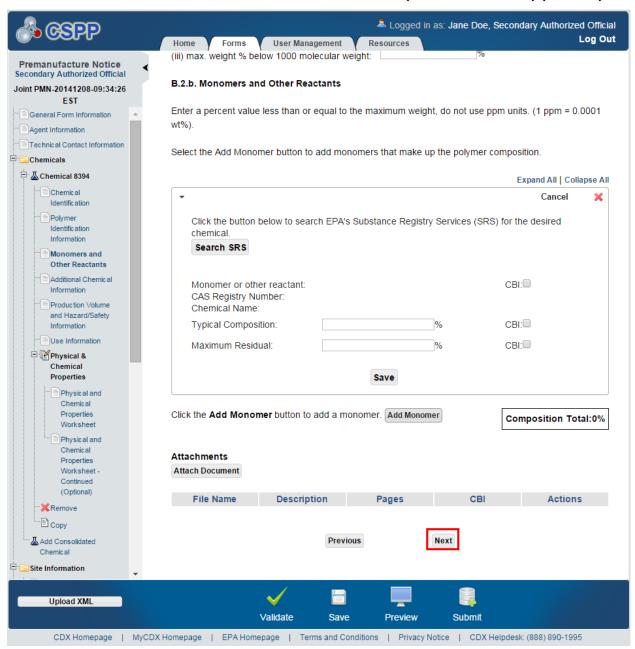

4.1.10 Production Volume and Hazard/Safety Information

You can navigate to the 'Production Volume and Hazard/Safety Information' screen by clicking the 'Next' button from the 'Additional Chemical Information' screen. You can also access this



screen by clicking the 'Production Volume and Hazard/Safety Information' link within the navigation tree.

The 'Production Volume and Hazard/Safety Information' screen collects different information regarding a chemical's production and hazard elements.

Production Volume: The 'Production Volume' section captures information about production for the respective chemical or polymer for the 'Maximum first 12-month production' and the 'Maximum 12-month production.' The 'Maximum first 12-month production' value should be less than or equal to the 'Maximum 12-month production' value. The maximum volume may not exceed 100,000,000,000,000 kg/year for either field. The entered values will automatically display decimal points upon navigating away from the page. Decimals are allowed up to the milligram (.000001). Estimates should be on a 100% new chemical substance basis. Your production volumes should be estimated as accurately as possible, but you are not bound to your estimates unless you check the 'Binding' checkbox. Include amounts you intend to produce for export. Provide an estimate of the first 12 months of production and the maximum production volume for any consecutive 12-month period during the first three (3) years of commercial manufacture. You may upload an attachment to enter additional production information.

Hazard Information: The 'Hazard Information' section captures information regarding hazards that the company chooses to disclose. For EPA to take respirator use into account when evaluating risks posed by a new chemical, the MSDS (material safety data sheet) for the substance must specify a respirator that is appropriate for the types of anticipated exposures. For the same reason, all respirators must be certified by the National Institute for Occupational Safety and Health (NIOSH), and be referenced in the MSDS as "NIOSH certified" respirators.

If any type of risk assessment is prescribed to determine personal protective equipment (PPE) requirements, such risk assessment must be performed by a qualified Industrial Hygienist (IH) or other authorized occupational safety and health specialist.

Engineering controls are the preferred methods for managing workplace exposures to hazards. If these controls are inadequate or lacking, personal protective equipment must be used.

For EPA to take glove use into account when evaluating risks posed by a new chemical, the MSDS for the substance must specify gloves that are impervious to the substances of concern, as well as suitable for the type of tasks.

Close-fitting goggles or a full-face piece facemask are preferred for vapor, mist, or fume exposures, or wherever workplace contaminants can readily bypass loose-fitting equipment.

The information is collected in a file attachment. The system will display instructional text for you to identify which forms should be uploaded.

Provide the MSDS for the PMN substance or intermediate or product mixture (that contains it) as an attachment to the PMN. Also, include hazard warning statements or labels, if relevant. The personal protection requirements of the MSDS become integral requirements of an LVE notice.

- **CBI:** Check the 'CBI' checkbox to claim the production volume information as confidential.
- **Binding:** Check the 'Binding' checkbox to claim the production volume information as binding. This checkbox is enabled for LVE or LVE modifications only.

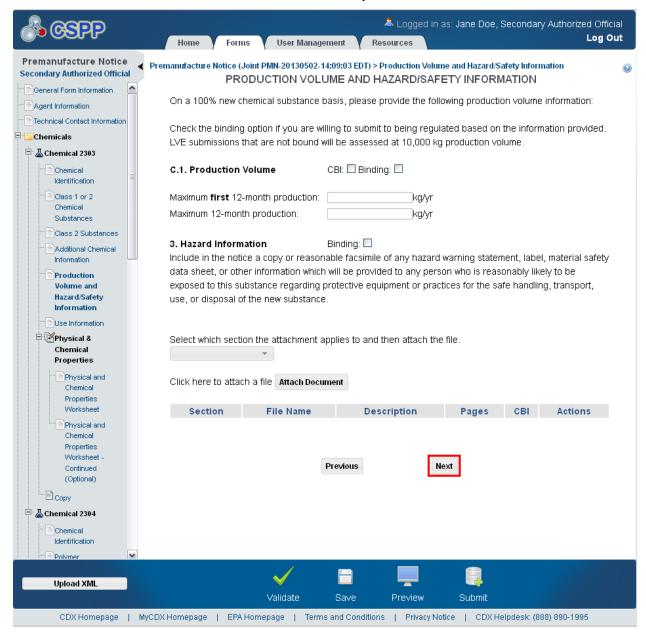


- **Maximum first 12-month production:** Provide an estimate of the first 12 months of production. The entered value must be a numerical value and must be greater than zero but less than 100,000,000,000,000 kg/year. This field accepts decimals to the milligram and is a required field if you do not have a pending Joint Submission and/or Letter of Support.
- Maximum 12-month production: Enter the data associated with the production volume. Provide an estimate of the maximum production volume for any consecutive 12-month period during the first three (3) years of commercial manufacture. The entered value must be a numerical value and must be greater than zero but less than 100,000,000,000,000,000 kg/year. This value must be greater than or equal to the 'Maximum first 12-month production' value. This field accepts decimals to the milligram and is a required field if you do not have a pending Joint Submission and/or Letter of Support.
- **Binding:** Check the 'Binding' checkbox to claim the hazard information as binding.
- Attachments: Select the section of the page with which the attached document is associated. This drop-down menu contains the following value: 'Production Information Section' and 'Hazard Information Section.'
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section** Error! Reference source not found. for additional details regarding the attach document functionality.
- **Section:** Displays the section with which the document is associated.
- **File Name:** Displays the file name and file extension of the file that is uploaded on the 'Attach Documents' pop-up window. Click the file name link to navigate to the 'Attach Documents' pop-up window to make any edits.
- **Description:** Displays the description associated with a document.
- Pages: Displays the number of pages a document contains.
- **CBI:** Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'

4.1.11 Use Information

You can navigate to the 'Use Information' screen by clicking the 'Next' button from the 'Production Volume and Hazard/Safety Information' screen. You can also access this screen by clicking the 'Use Information' link within the navigation tree.



The 'Use Information' screen captures data about how the new chemical substance is intended to be used by function and application. Function refers to the chemical purpose for which the substance is designed and is often based on the physical and chemical properties of the substance. Application refers to how the substance is used in particular processes or products. An example of a function and application would be as a dispersive dye for finishing polyester fibers. When you navigate to the screen, the screen contains instructional text and an 'Add Use' button. When you click the 'Add Use' button, an expandable/collapsible field set opens and displays the 'Use Information' fields. Upon saving the entry, the expandable/collapsible field set collapses and displays the 'Category of Use' and 'Production %' values.

You will first enter a description for the 'Category of Use' field. Each use will center on the 'Category of Use' and the different variables surrounding it. The category of use information should be specific enough to allow EPA reviewers to anticipate potential exposure patterns for the new substance (e.g. merely indicating "Dye" is not sufficient – is it photographic dye, a reactive dye for nylon fibers, or a dye to be incorporated in a polymer making film?). LVE notices limit you to your stated category of use(s), so make sure your description fully encompasses all intended uses for any LVE. When you claim the 'Category of Use' as CBI, you are required to enter a 'Generic Use Description.' The generic use description will be available publicly.

The table captures the different elements of use that the PMN form captures. The 'Production %' and '% in Formulation' values will be captured to indicate how the product will be used and at what percent in that use. Each use must capture the percent of the production and percent in formulation for each category of use. The 'Production %' must equal up to 100% for all uses if there is no pending Letter of Support or Joint Submission for the form, and the field can be declared CBI. The '% in Formulation' value can equal up to 100%, and the field can be declared CBI.

The '% of substance expected' per use is captured for the following categories: 'Site Limited,' 'Consumer,' 'Industrial,' and 'Commercial.' The '% of substance expected' value must total 100%. The '% of substance expected' values can be claimed as CBI or listed as binding. These use types are used to determine the risks that the chemical will place on society.

- **Add Use:** Click the 'Add Use' button to add a new use information expandable/collapsible field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.



- **Expand All:** Click the 'Expand All' link located at the upper-right of the expandable/collapsible field sets to expand a series of field sets.
- Collapse All: Click the 'Collapse All' link located at the upper-right of the expandable/collapsible field sets to collapse a series of field sets.
- Category of Use: Enter the category of use for the specific chemical substance by function and application. This is a required field.
- **CBI:** Check the 'CBI' checkbox to claim the category of use information as confidential and generate the 'Generic Use Description' field. Claiming the 'Category of Use' field as CBI and then un-checking the 'CBI' checkbox generates a confirmation message that all attached documents will be deleted.
- Binding: Check the 'Binding' checkbox to claim the category of use information as binding.
- **C.2.b. Generic Use Description:** Enter the generic use description of the chemical. This field displays when the 'Category of Use' field is claimed CBI. If you claim any category of use description as confidential, enter a generic description of that category. This field is required when the 'Category of Use' field is claimed CBI.
- Total Production for this Use %: Enter an estimate of the percent of total production for the first three years devoted to each category of use for the specific chemical. The entered value must be a value greater than zero (0) but less than or equal to one hundred (100). The 'Production %' must equal up to 100% for all uses if there is no pending Letter of Support or Joint Submission for the form. This field allows for decimal values. This is a required field.
- **CBI:** Check the 'CBI' checkbox to claim the 'Total Production for this Use' information as confidential.
- In Formulation %: Estimate the percent of the new substance as formulated in mixture, suspensions, emulsions, solutions, or gels as manufactured for commercial purposes at sites under your control associated with each category of use. The entered value must be a value greater than zero (0) but less than or equal to one hundred (100) and can include decimal values. This is a required field.
- **CBI:** Check the 'CBI' checkbox to claim the 'Percentage in Formulation' information as confidential.
- **CBI:** Check the 'CBI' checkbox to claim the percentage of substance expected per use information as confidential.
- **Binding:** Check the 'Binding' checkbox to claim the percentage of substance expected per use information as binding.
- Site Limited %: Enter the site limited percentage of substance expected per use for the submitted substance. Blank fields are recognized as zeroes. This field allows for decimal values. Break down the use(s) by percentage for the indicated end user categories. For example, site-limited means the substance will only be used on the adjacent property unit where manufactured and will not intentionally be removed from the site except for waste disposal.
- Consumer %: Enter the consumer percentage of substance expected per use for the submitted substance. Blank fields are recognized as zeroes. This field allows for decimal values. Break down the use(s) by percentage for the indicated end user categories. Consumer



use means that private individuals will use the chemical substance or products containing the substance for personal use or enjoyment.

- Industrial %: Enter the industrial percentage of substance expected per use for the submitted substance. Blank fields are recognized as zeroes. This field allows for decimal values. Break down the use(s) by percentage for the indicated end user categories. Industrial use means that the chemical substance or product containing the substance will be used at the locations of other manufacturers or processors.
- Commercial %: Enter the commercial percentage of substance expected per use for the submitted substance. Blank fields are recognized as zeroes. This field allows for decimal values. Break down the use(s) by percentage for the indicated end user categories. Indicate percentage of product volume expected for the listed "use" sectors. Commercial use refers to the chemical substance or product containing the chemical substance being used by a company to provide a consumer service.
- If you have provided a "consumer" use, provide details: Enter consumer use details. Provide a detailed description of the use(s) of this chemical substance in consumer products. In addition, include estimates of the concentration of the new chemical substance as expected in consumer products and describe the chemical reactions by which this substance loses its identity in the consumer product. This is a required field if the 'Consumer % of substance expected per use' field is populated and is a value greater than zero (0).
- **CBI:** Check the 'CBI' checkbox to claim the 'If you have provided a 'consumer' use, provide details' information as confidential.
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section** Error! Reference source not found. for additional details regarding the attach document functionality.
- **File Name:** Displays the file name and file extension of the file uploaded on the 'Attach Documents' pop-up window. Click the 'File Name' link to navigate to the 'Attach Documents' pop-up window to make any edits.
- **Description:** Displays the description associated with a document.
- **Pages:** Displays the number of pages a document contains.
- CBI: Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'
- Actions: Click the 'Delete' icon (×) to delete the entire attached document row permanently from the system. A warning message displays to confirm deletion of the document.
- Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able to navigate away from the screen using the 'Previous' and 'Next' buttons. Refer to Section 3.8 for more information regarding the save functionality in an expandable/collapsible field set.

Production Total: Displays the total production percentage for all uses. This value must be equal to 100, unless a Joint Submission or Letter of Support is pending, in which case the total value requirement is not immediately applicable.

Exhibit 4-15: Use Information Screen (Joint Submission) (Scroll 1)

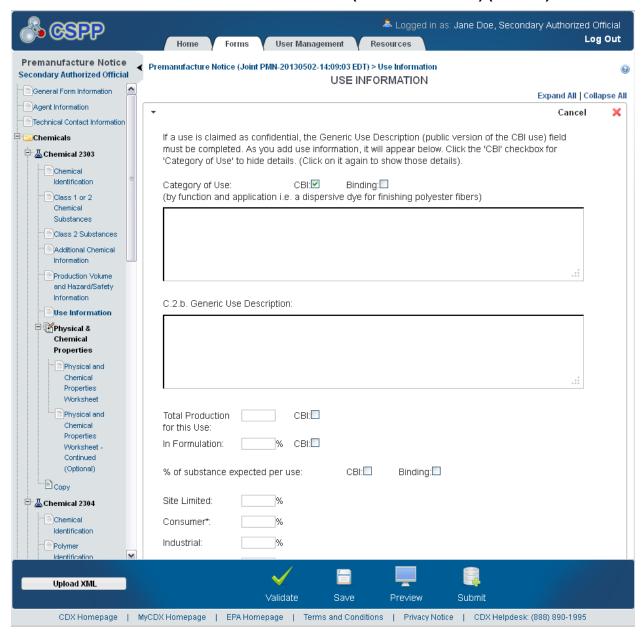

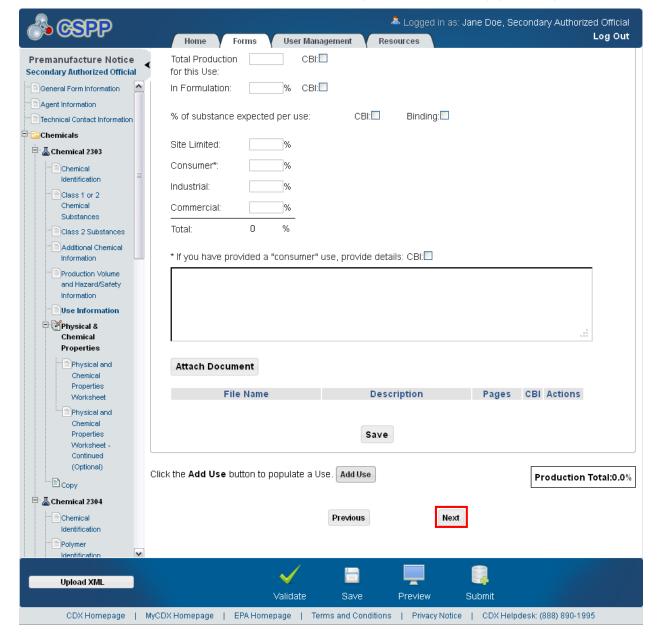


Exhibit 4-16: Use Information Screen (Joint Submission) (Scroll 2)

4.1.12 Physical and Chemical Properties Worksheet

You can navigate to the 'Physical and Chemical Properties Worksheet' screen by clicking the 'Next' button from the 'Use Information' screen. You can also access this screen by clicking the 'Physical and Chemical Properties Worksheet' link within the navigation tree.



The 'Physical and Chemical Properties Worksheet' screen is used to capture optional information about a chemical's properties. EPA uses the chemical properties to determine additional safety data about a chemical; the properties are used to determine potential risks and exposures of the chemicals.

The properties for a chemical are captured in an expandable/collapsible field set format. The following categories may apply to a chemical: 'Physical state of neat substance,' 'Vapor Pressure @ temperature,' 'Density/relative density,' 'Solubility @ temperature ____ solvent ____,' 'Solubility in water @ temperature ____,' 'Melting temperature,' 'Boiling/sublimation temperature @ _____,' 'Spectra,' 'Dissociation constant,' 'Particle size distribution,' 'Octanol/water partition coefficient,' 'Henry's Law constant,' 'Volatilization from water,' 'Volatilization from soil,' 'pH @ concentration [concentration],' 'Flammability,' 'Explodability,' and 'Adsorption/coefficient.' All of the properties will capture the relevant values for a chemical. Each property may be claimed individually as CBI.

To enter physical/chemical property information, select a physical/chemical property from the drop-down menu and click the 'Add Property' button. The expandable/collapsible field set expands and displays all fields that should be entered for that property. You are then able to enter all relevant information regarding that property. Value fields are able to accept '<' or '>' symbols. When all information is entered, click the 'Save' button. Each property may only be entered once per chemical.

You may also enter an option for 'Other.' The 'Other' option will allow you to enter a user-specified property and any relevant values. The property will capture the relevant values for the chemical and the property measurement can be identified as 'Measured' or 'Estimate.' The 'Other' option may be claimed individually as CBI. You may enter multiple properties as 'Other.'

You may upload attachments for the chemical properties on the 'Physical and Chemical Properties Worksheet – Continued (Optional)' screen.

EPA's risk assessment process does utilize physiochemical properties, as some of the attributes listed here can relate directly to chemical risks. Among the most useful parameters of a new substance to EPA are the boiling point, the melting point, vapor pressure, the octanol/water partition coefficient, water solubility, Henry's Law Constant, hydrolysis, spectral data, mass spectrometry (MS), proton and C13 Nuclear Magnetic Resonance (NMR), Infrared (IR), and Ultraviolet (UV) absorption, and the soil/sediment absorption coefficient. In the absence of this data, EPA will estimate to the extent possible physiochemical data to aid in their risk evaluations.

Indicate whether the value you provide is based on an actual test measurement ('Measured') or is based on an estimate ('Estimate'). Note that EPA staffers indicate that data qualifiers such as 'negligible' or 'soluble' are not useful descriptions.

You are not required to generate the listed test data if you do not have it.

Physical/chemical properties data may be so unique that they could in the future link the PMN substance to a commercial product or may tend to identify unique classes of chemical substance, and therefore some data elements may represent confidential business information. Review the CBI status of each entry carefully, and avoid making unsupportable claims.



Please note that in IE 7, all physical/chemical properties you wish to add must be identified before navigating away from this page; otherwise, the properties are removed from the 'Add Property' drop-down menu. In addition, you will be able to add the 'Henry's Law constant' property more than once, and the chemical property fields located within the expandable/collapsible fields sets on this page will be disorganized. After clicking the 'Next' button, you will navigate to the 'Physical and Chemical Properties Worksheet – Continued (Optional)' screen. After clicking the 'Previous' button, the physical/chemical properties have been removed from the 'Add Property' drop-down menu.

- Add Property: Click the 'Add Property' button to add and open a new 'Property' expandable/collapsible field set for a selected property.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of an expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when an expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of an expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of an expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.

- **Adsorption/Coefficient CBI:** Check the 'CBI' checkbox to claim the adsorption/coefficient property as confidential.
- **Boiling/sublimation temperature** @ **Value**: Enter the boiling/sublimation temperature in °C of the chemical substance. This is a required field if the 'Boiling/sublimation temperature @' property is selected.
- Boiling/sublimation temperature @ [pressure] torr: Enter the value of the pressure in torr for which the boiling/sublimation of the chemical substance was determined. Value fields are able to accept '<' or '>' symbols. This is a required field if the 'Boiling/sublimation temperature @' property is selected.
- Boiling/sublimation temperature @ Measured or Estimate: Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value



from the drop-down menu. This is a required field if the 'Boiling/sublimation temperature @' property is selected.

- **Boiling/sublimation temperature** @ **CBI:** Check the 'CBI' checkbox to claim the 'Boiling/sublimation temperature @' property as confidential.
- **Density/relative density Value:** Enter the density/relative density value of the chemical substance in g/cm3. Value fields are able to accept '<' or '>' symbols. This is a required field if the 'Density/relative density' property is selected.
- **Density/relative density Measured or Estimate:** Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Density/relative density' property is selected.
- **Density/relative density CBI:** Check the 'CBI' checkbox to claim the 'Density/relative density' property as confidential.
- **Dissociation constant Value:** Enter the dissociation constant value of the chemical substance. Value fields are able to accept '<' or '>' symbols. This is a required field if the 'Dissociation constant' property is selected.
- **Dissociation constant Measured or Estimate:** Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Dissociation constant' property is selected.
- **Dissociation constant CBI:** Check the 'CBI' checkbox to claim the 'Dissociation constant' property as confidential.
- Explodability Value: Enter the explodability value of the chemical substance. This field allows text or numbers to be entered and is also able to accept '<' or '>' symbols. This is a required field if the 'Explodability' property is selected.
- Explodability Measured or Estimate: Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Explodability' property is selected.
- Explodability CBI: Check the 'CBI' checkbox to claim the 'Explodability' property as confidential.
- **Flammability Value:** Enter the flammability value of the chemical substance. This field allows text and is also able to accept '<' or '>' symbols. This is a required field if the 'Flammability' property is selected.
- **Flammability Measured or Estimate:** Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Flammability' property is selected.

- Solubility @ temperature solvent Value: Enter the solubility of the chemical substance in g/L.
- Solubility @ temperature solvent Measured or Estimate: Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Solubility @ temperature solvent' property is selected.
- Solubility @ temperature solvent CBI: Check the 'CBI' checkbox to claim the 'Solubility @ temperature solvent' property as confidential.
- Solubility in Water @ temperature: Enter the temperature value in °C of the chemical for which the solubility in water was measured. This is a required field if the 'Solubility in Water @ temperature' property is selected.
- Solubility in Water @ temperature Value: Enter the solubility in water of the chemical substance in g/L. Value fields are able to accept '<' or '>' symbols. This is a required field if the 'Solubility in Water @ temperature' property is selected.
- Solubility in Water @ temperature Measured or Estimate: Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Solubility in Water @ temperature' property is selected.
- Solubility in Water @ temperature CBI: Check the 'CBI' checkbox to claim the 'Solubility in Water @ temperature' property as confidential.
- **Spectra Value:** Enter the spectra value of the chemical substance. Value fields are able to accept '<' or '>' symbols. This is a required field if the spectra property is selected.
- **Spectra Measured or Estimate:** Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Spectra' property is selected.

- Vapor Pressure @ temperature Measured or Estimate: Indicate whether the property value is 'Measured' or based on an 'Estimate' by selecting the appropriate value from the drop-down menu. This is a required field if the 'Vapor Pressure @ temperature' property is selected.

Exhibit 4-17: Physical and Chemical Properties Worksheet Screen (Joint Submission) (Scroll 1)

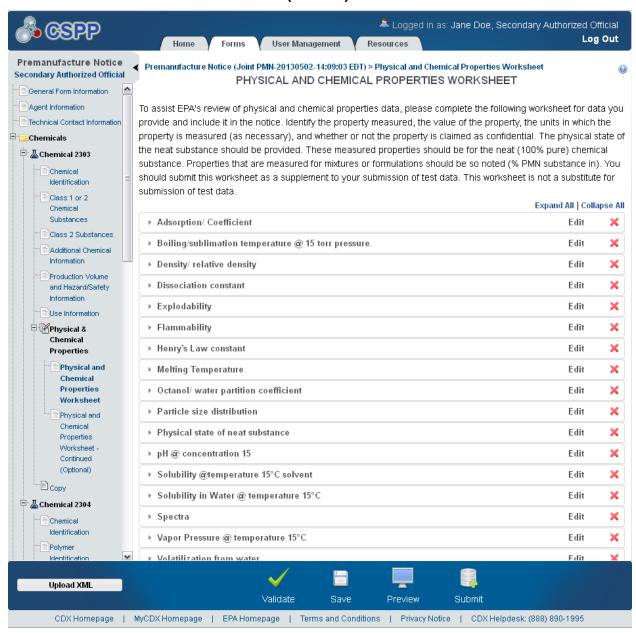
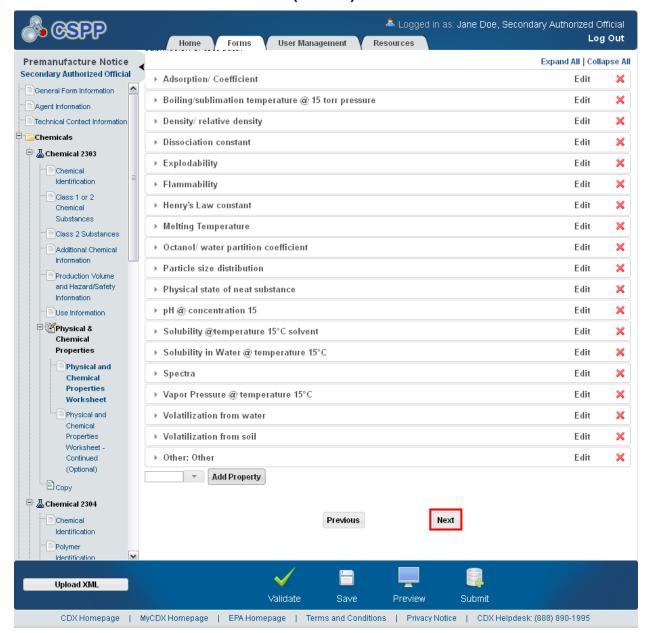

When you attach a document, the properties that were selected on the 'Physical and Chemical Properties Worksheet' screen will be listed with checkboxes in the 'Attach Documents' window for you to select with which properties an attachment is associated. Check the properties that are relevant to the document, and then select a type and subtype value for the document. You will be able to attach a document, enter a description of the document, and list the number of pages.

The system provides functionality to claim an uploaded document as CBI. If a document is claimed as CBI, the system requires you to upload the sanitized version of the attached document. 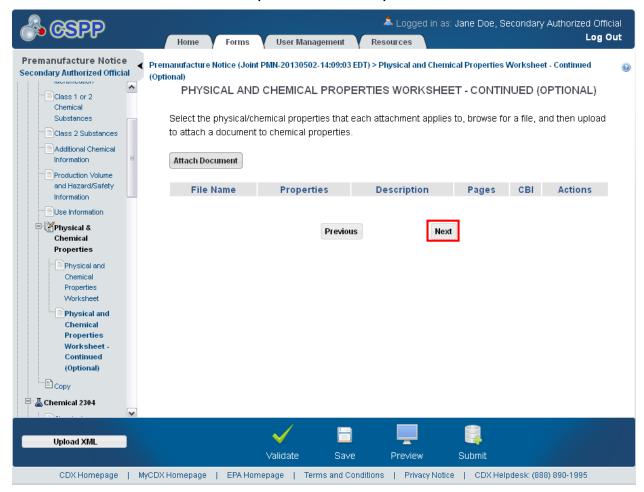

- **Type:** Select the document type from the drop-down menu.
- **Subtype:** Select the document subtype from the drop-down menu.
- Chemical Properties: Displays the physical and/or chemical properties identified on the 'Physical and Chemical Properties Worksheet' screen that can be potentially associated with a document. Check the appropriate chemical properties that are associated with a document that is being attached. These checkboxes are enabled only if 'Physical Chemical Property' is selected from the 'Type' drop-down menu.

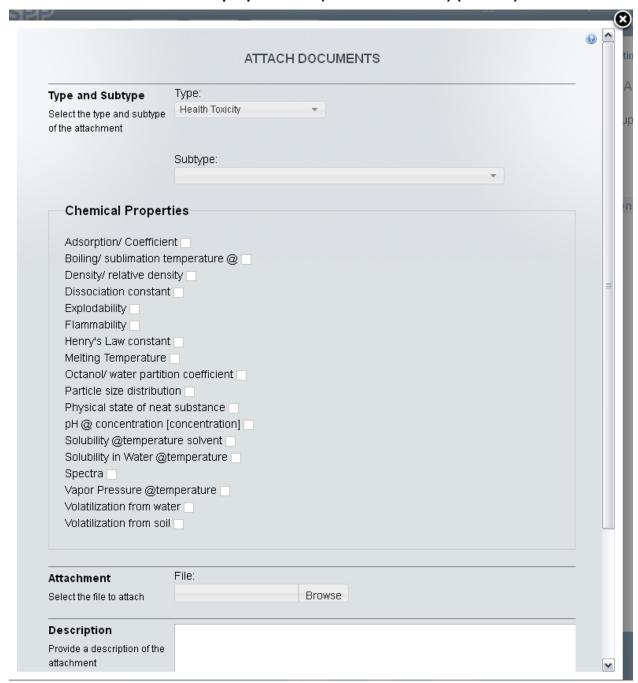

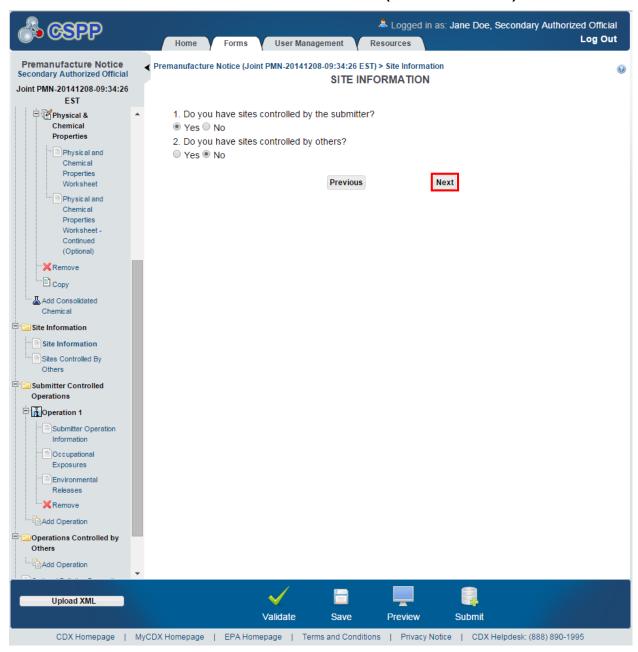

If a user indicates there are submitter-controlled sites, the 'Submitter Operation Information,' 'Occupational Exposures,' and 'Environmental Releases' screens are automatically generated within the 'Submitter Controlled Operations' folder within the navigation tree. If a user indicates there are sites controlled by others, the 'Industrial Sites Controlled By Others,' 'Exposures/Releases,' and 'Byproduct Information' screens automatically generate within the 'Operations Controlled By Others' folder within the navigation tree upon clicking the 'Next' button. Toll manufacturing sites are considered sites controlled by the submitter.

- Do you have sites controlled by the submitter?: Select the 'Yes' radio button to indicate that you have submitter controlled sites to identify; this response automatically generates the screens within the 'Submitter Controlled Operations' folder in the navigation tree upon clicking the 'Next' button. Select the 'No' radio button if you do not have any submitter-controlled sites to identify. An error message displays if a submitter-controlled site displays within the navigation tree and the 'No' radio button is selected.
- Do you have sites controlled by others?: Select the 'Yes' radio button to indicate that you have sites controlled by others to identify; this response automatically generates the screens within the 'Operations Controlled by Others' folder in the navigation tree upon clicking the 'Next' button. You can navigate to the 'Sites Controlled By Others' screen by clicking the 'Next' button from the 'Site Information' screen. You can also access this screen by clicking the 'Sites Controlled By Others' link within the navigation tree.

The 'Sites Controlled By Others' screen captures information about known and/or unknown sites not controlled by the submitter. Complete the 'Operations Controlled By Others' section within the navigation tree for typical processing or use operations involving the new chemical substance at sites not controlled by the submitter. Importers do not have to complete this section for operations outside the U.S.; however, you must report any processing or use activities after import. Complete a separate 'Operations Controlled By Others' section for each type of processing, or use operation involving the new chemical substance. If the same operation is performed at more than one site, describe the typical operation common to these sites. The screen first captures whether there is any data for other controlled sites. If there is no data for sites controlled by others, the screen will not update and the option of selecting the 'Next' button is available. If there is data for sites controlled by others, an additional question will appear. The screen then captures whether site-specific data for the chemical is known for 'Sites Controlled By Others.' If you indicate that there is site-specific data by selecting the 'Yes' radio button, the screen will generate a text field to enter the '# of unknown sites' and a 'CBI' checkbox to claim the number of unknown sites as confidential. If there is no site-specific data, the screen displays a text box to capture the number of unknown sites.

Please note that in IE 7, after adding a site, the '# of unknown sites' text box label disappears but the text field and 'CBI' checkbox are still displayed.

- Do you have any sites controlled by others for which you have information to report?: If you select 'Yes' the screen will display the question 'Do you have site-specific information?' If you select 'No' only the listed navigation options will display. If an operation controlled by others displays within the navigation tree, the 'Yes' radio button must be selected for this question.
- Do you have site-specific information?: If you select 'Yes' the screen generates fields to capture specific site information. If you select 'No,' an error message displays indicating that any other sites you have will be deleted.

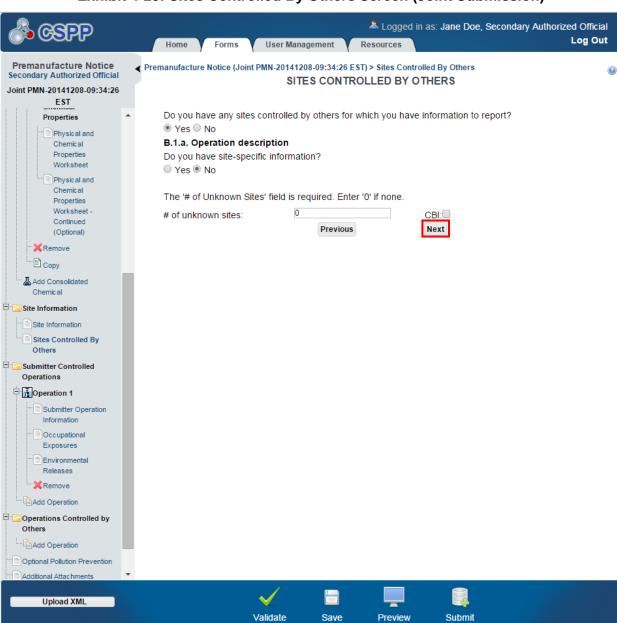


Exhibit 4-23: Sites Controlled By Others Screen (Joint Submission)

4.1.17 Submitter Operation Information

You can navigate to the 'Submitter Operation Information' screen by clicking the 'Next' button from the 'Sites Controlled By Others' screen. You can also access this screen by clicking the 'Submitter Operation Information' link under the 'Submitter Controlled Operations' folder within the navigation tree. You can add additional sites by clicking the 'Add Operation' link within the navigation tree under the 'Submitter Controlled Operations' folder.

The 'Submitter Operation Information' screen captures information about an operation that occurs at a particular site or group of sites. You are asked a series of questions and, based on the responses, a series of fields displays regarding a specific operation. The guided approach is designed to eliminate errors and ensure the completion of all relevant sections for a site. You will be able to enter an operation alias to identify the operation. Importers are not required to complete this section for operations outside the U.S.; however, any industrial processing or use operation that takes place after import must be described. It should be noted that Toll manufacturing sites are considered to be sites controlled by the submitter.

You will first be asked to select the site(s) and chemical(s) for the operation and will then select the applicable operation type checkboxes.

If you select an option other than 'Use' for the operation type, you will be asked whether the chemical is manufactured or processed as a 'batch' or 'continuous' process. Based on the property selected, fill in the relevant information. If you select the 'Use' operation type, then there will be no further options on this screen. The follow-up screens are used to capture specific information about the operation type process.

The system provides a text box for describing the process description. Additional process information may also be included in an attachment. In the process description, include the following information: (1) Diagram the major unit operation steps and chemical conversions. Include interim storage and specify transport containers (e.g., 5-gallon pails, 55-gallon drum, rail car, tank truck, etc.). (2) Provide the identity, approximate weight (by kilograms (kg) kg/day or kg/batch on a new chemical substance basis), and entry point of all starting materials, feedstocks (including reactants, solvents, catalysts, etc.), products, recycle streams, and wastes. Include cleaning chemicals (note frequency if not used daily or per batch). (3) Identify by number the points of release, including small or intermittent releases, to the environment of the new chemical substance. If releasing to two media at the same step, assign a second release number for the second medium.

You may claim the process description or attachment as CBI. If an attached document is claimed as CBI, the system requires a sanitized version of the attached document to be uploaded. To access or edit previously attached documents, click the file name of the document within the 'File Name' column of the document table.

The document table displays the file name and file extension of the document, the document description, the number of pages in the document, and whether a sanitized copy of the document was attached. Click the 'Delete' icon (×) under the 'Actions' column to delete unwanted documents.

• **Operation Alias:** Enter the operation alias. This field makes it easier to distinguish between operations in the navigation tree when there is more than one operation. This is a required field if the form is pending a Joint Submission or a Letter of Support.

- **Processing:** Check the 'Processing' checkbox to indicate that processing is taking place at the site. Checking the 'Processing' checkbox generates the 'Is it batch or continuous' radio buttons.
- Use: Check the 'Use' checkbox to indicate that chemical use is taking place at the site.
- **CBI:** Check the 'CBI' checkbox to claim the amount and duration information as confidential.
- Is it batch or continuous?: Select the 'Batch' radio button to indicate that the chemical is produced in a batch process. Select the 'Continuous' radio button to indicate that the chemical is produced on a continuous basis. Either the 'Batch' or 'Continuous' radio button is required to be selected.
- Max kg/batch: Enter the maximum number of kilograms produced per batch. This field only displays when you select the 'Batch' radio button and is a required field. This field accepts decimal values.
- Hours/batch: Enter the hours of manufacturing or processing time needed per batch. This field only displays when you select the 'Batch' radio button and is a required field. This field accepts decimal values.
- Batches/year: Enter the number of batches produced per year. This field only displays when you select the 'Batch' radio button and is a required field. This field accepts decimal values.
- Max kg/day: Enter the maximum number of kg of a chemical produced per day. This field only displays when you select the 'Continuous' radio button and is a required field. This field accepts decimal values.
- Hours/day: Enter the number of hours per day that the chemical is processed or manufactured; this value cannot exceed 24. This field only displays when you select the 'Continuous' radio button and is a required field. This field accepts decimal values.



- **Days/year:** Enter the number of days per year that the chemical is processed or manufactured; this value cannot exceed 365. This field only displays when you select the 'Continuous' radio button, and is a required field. This field accepts decimal values.
- CBI: Check the 'CBI' checkbox to claim the process description as confidential.
- **Process Description:** Enter the process description. In the 'Process Description' text box, or an attachment, address the following items: (1) Diagram the major unit operation steps and chemical conversions. Include interim storage and transport containers (specify e.g., 5-gallon pails, 55-gallon drum, rail car, tank truck, etc.). (2) Provide the identity, the approximate weight (by kg/day or kg/batch on a 100% new chemical substance basis), and entry point of all starting materials and feedstocks (including reactants, solvents, catalysts, etc.), and of all products, recycle streams, and wastes. Include cleaning chemicals (note frequency if not used daily or per batch). (3) Identify by number the points of release, including small or intermittent releases, to the environment of the new chemical substance. If releasing to two media at the same step, assign a second release number for the second medium. Either this field is required or a document must be attached.
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the attach document functionality.
- **File Name:** Displays the file name and file extension of the file that is uploaded on the 'Attach Documents' pop-up window.
- **Description:** Displays the description associated with a document.
- **Pages:** Displays the number of pages a document contains.
- **CBI:** Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'
- Actions: Click the 'Delete' icon (×) to delete the entire attached document row permanently from the system. A warning message displays to confirm the deletion.

Exhibit 4-24: Submitter Operation Information Screen (Joint Submission) (Scroll 1)

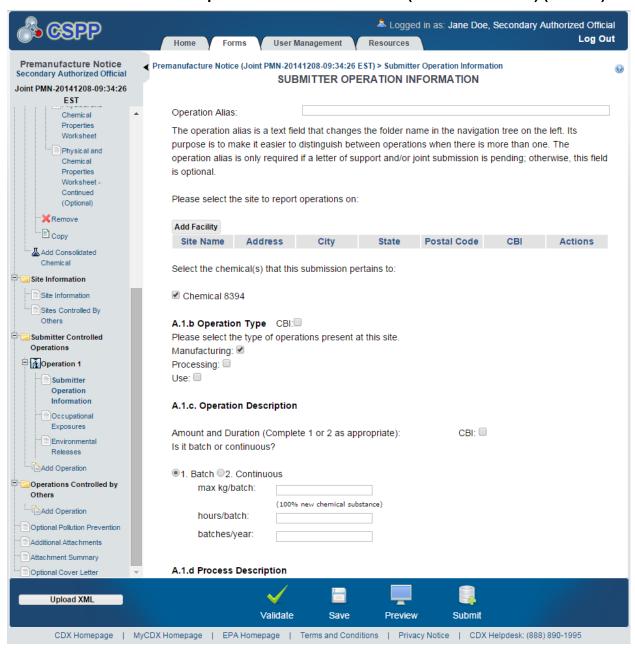
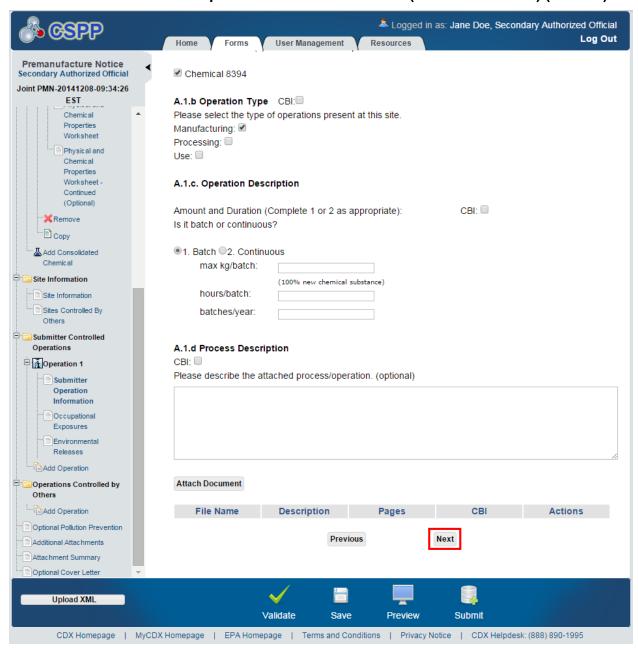

Click the 'Add' button to generate an expandable/collapsible field set to enter occupational exposure information. The application displays fields for you to enter information for 'Worker Category (1),' 'Worker Activity (1),' 'Protective Equipment/Engineering Controls (3),' 'Physical Form(s) (5),' '% New Substance (5),' '# Workers Exposed (8),' 'Maximum Duration Hours/Day (10),' and 'Maximum Duration Days/Year (11).' EPA is attempting to estimate exposure levels, the number of workers potentially exposed, and possible routes and duration of exposure to the PMN substance. Work with your plant engineers to develop accurate data; review the CBI status of data you provide.

Information entered into the 'Maximum Duration Hours/Day (10)' and 'Maximum Duration Days/Year (11)' fields must be a positive whole number or decimal. The system does not allow special characters to be saved in these fields. If further explanation is required regarding duration of exposure, please provide this in an attachment.

- **Add:** Click the 'Add' button to generate the 'Occupational Exposure Submitter Controlled Sites' expandable/collapsible field set.

The information contained within the 'Physical Forms and % New Substance' field in the thick client separates into two (2) separate fields, the 'Physical Form(s)' field and '% New Substance' field when these fields are populated via an XML file generated from the ePMN thick client. This is a required field.
- **Binding:** Check the 'Binding' checkbox to claim the physical form(s) information as binding.
- % New Substance (5): Enter the percentage of new chemical substance (if part of a mixture) at the time of exposure. A value of zero (0) entered in this field will display an error. Please pay particular attention to the information if this field is populated via XML file. The information contained within the 'Physical Forms and % New Substance' field in the thick client separates into two (2) separate fields, the 'Physical Form(s)' field and '% New Substance' field when these fields are populated via an XML file generated from the ePMN thick client. This is a required field that accepts decimal values.
- **Binding:** Check the 'Binding' checkbox to claim the percentage new substance information as binding.
- # Workers Exposed (8): Enter the number of workers exposed. Estimate the maximum number of all workers involved in each activity for all sites combined. This is a required field.
- **CBI:** Check the 'CBI' checkbox to claim the number of workers exposed as confidential.
- Hours/Day (10): Enter the maximum duration occupational exposure occurs for the activity for any worker in hours per day; this field allows decimal values. A value of zero (0) entered in this field will display an error. This is a required field.
- Days/Year (11): Enter the maximum duration occupational exposure occurs for the activity for any worker in days per year; this field allows decimal values. A value of zero (0) entered in this field will display an error. This is a required field.
- **CBI:** Check the 'CBI' checkbox to claim the maximum duration values as confidential.



• Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able to navigate away from the screen using the 'Previous' and 'Next' buttons. Refer to Section 3.8 for more information regarding the save functionality in an expandable/collapsible field set.

4.1.19 Environmental Releases

The 'Environmental Releases' screen captures information about the environmental release and disposal status of a particular site. The information on exposure and environmental release is related to the flow diagram/process description on the 'Submitter Operation Information' screen. This page is duplicated and populated for each flow diagram supplied in the PMN (manufacturing, each processing description, and any use diagrams). The information provided should focus on the PMN substance. EPA reviewers pay particular attention to human exposure and environmental release date under their TSCA mandate to protect against unreasonable risks from new chemical substances. In the absence of this information, EPA will make its own estimates of worker exposure and environmental release, which are usually conservative. You should present data that is accurate and as complete as possible.

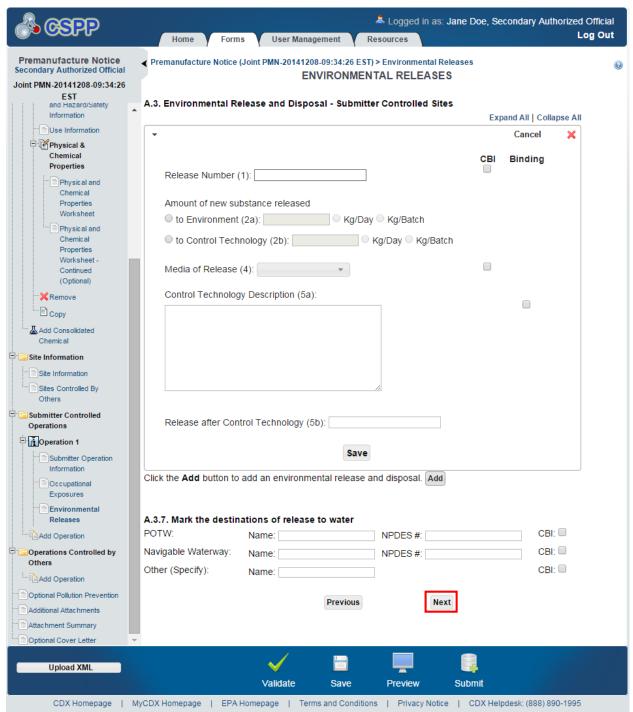

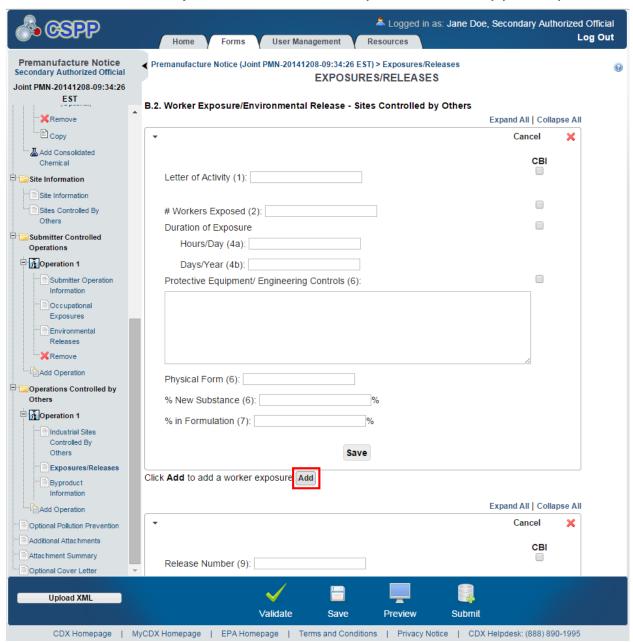

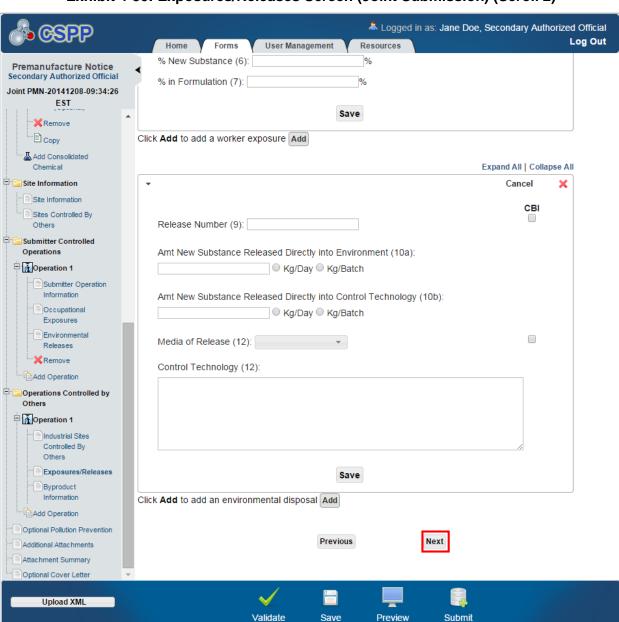


Exhibit 4-30: Exposures/Releases Screen (Joint Submission) (Scroll 2)

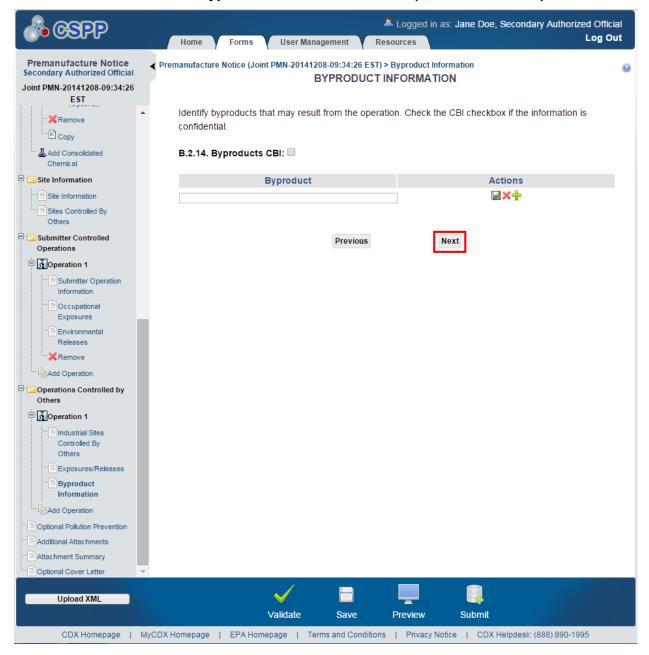

The 'Optional Pollution Prevention' screen provides fields for companies to enter data about their pollution prevention efforts. The company has the option of entering information as a free text field or as an attachment. The company can claim the information as confidential by checking the 'CBI' checkbox.

The system allows an uploaded document to be claimed as CBI. If a document is claimed as CBI, the system requires the sanitized version of the attached document to be uploaded. To access or edit previously attached documents, click the appropriate file name of the document within the 'File Name' column of the document table.

The attachment table displays the file name and file extension of the document, the document description, the number of pages the document contains, and the CBI status of the document. Click the 'Delete' icon (×) located within the 'Actions' column to delete unwanted documents.

You may provide information not reported elsewhere in this form regarding your efforts to reduce or minimize potential risks associated with activities surrounding manufacturing, processing, use, and disposal of the PMN substance on the 'Optional Pollution Prevention' screen. Include new information pertinent to pollution prevention, including source reduction, recycling activities and safer processes or products available due to the new chemical substance. Source reduction includes the reduction in the amount or toxicity of chemical wastes by technological modification, process and procedure modification, product reformulation, and/or raw materials substitution. Recycling refers to the reclamation of useful chemical components from wastes that would otherwise be treated or released as air emissions or water discharges, or land disposal. Quantitative or qualitative descriptions of pollution prevention, source reduction and recycling should emphasize potential risk reduction in addition to compliance with existing regulatory requirements. EPA is interested in the information to assess overall net reductions in toxicity or environmental releases and exposures, not the shifting of risks to other media (e.g., air to water) or non-environmental areas (e.g., occupational or consumer exposure). To the extent known, information about the technology being replaced will assist EPA in its relative risk determination. In addition, information on the relative cost or performance characteristics of the PMN substance to potential alternatives may be provided.

- (1) An overall reduction in risk to human health or the environment;
- (2) A reduction in the generation of waste materials through recycling, source reduction or other means;
- (3) A reduction in the use of hazardous starting materials, reagents, or feedstocks;

EPA strongly encourages submitters to provide pollution prevention data in their notices, as this information assists the Agency in balancing the benefits of a PMN substance against its unique risks.

While Agency staffers frequently receive information on the benefits of the PMN substance with respect to its use(s), data on pollution prevention effects are rarely included. This section should be utilized to indicate to EPA benefits in terms of the raw materials incorporated, the manufacturing process, emission reductions, less toxic waste byproducts, or lower risks upon end use and disposal. You should consider the entire life cycle of the PMN substance in your evaluation.

Also consider opportunities for product stewardship or other risk management controls that could significantly reduce risk characteristics of the new substance (e.g., disposal techniques that can be easily implemented and substantially reduce waste toxicity).

Initiatives in the New Chemicals Program such as Environmental Technology Initiative (ETI) for Chemicals, and the Pollution Prevention Recognition Project, are geared towards incorporating this type of information into the Agency's risk management decision making and recognizing innovative chemical design or technological innovation that shows potential for environmental and human health benefits.

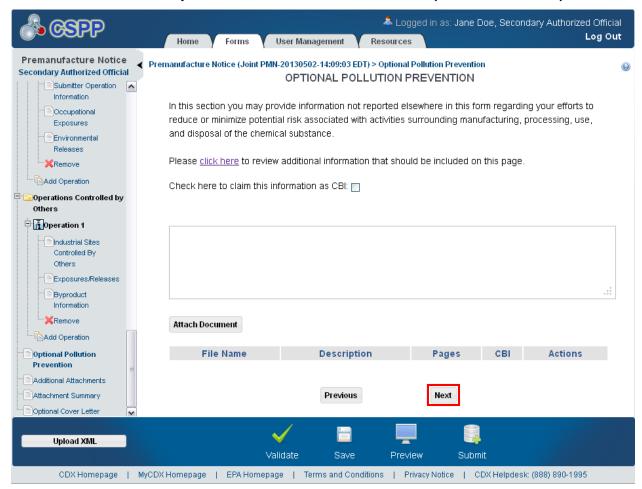

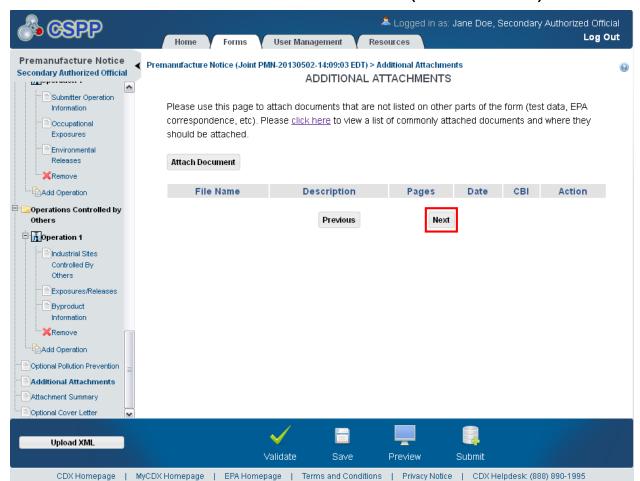


Exhibit 4-33: Additional Attachments Screen (Joint Submission)

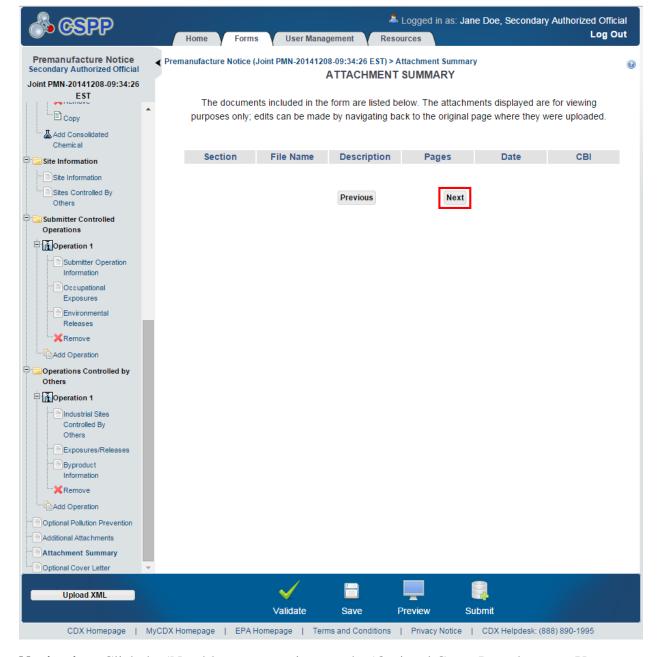


Exhibit 4-34: Attachment Summary Screen (Joint Submission)

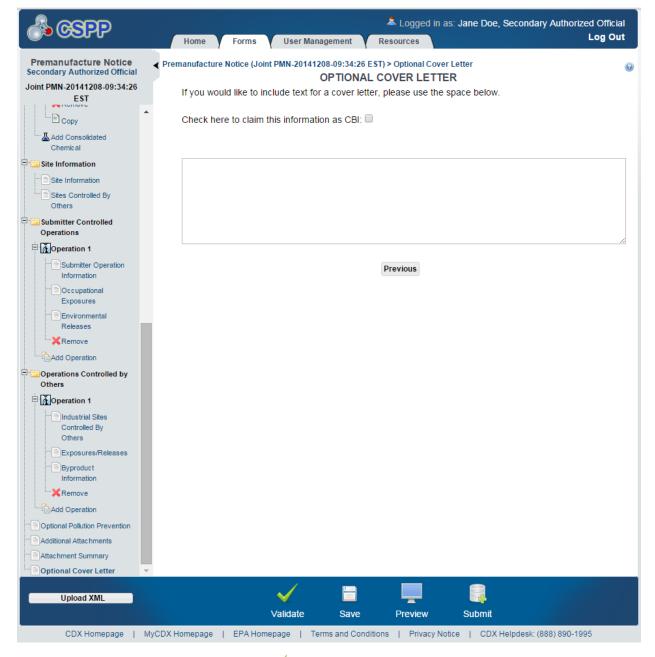


Exhibit 4-35: Optional Cover Letter Screen (Joint Submission)

The 'Upload XML' screen is used to upload a PMN XML file (created from the PMN thick client with a file type of .pmn_tsca or the ZIP file generated from a CoR) into a current joint PMN form for joint PMN forms with numerous chemicals. You also have the option to export a current joint PMN form into an XML file using the 'Export XML' link. The upload XML functionality is only available for a PMN form.

If you upload an XML file into a pre-populated form, the XML file overwrites the contents of the pre-populated form. In addition, uploading any file removes the attached documents within a form, which must be re-attached. You must also add any sites identified within the form to your CDX registration profile.

After uploading a file, click the 'Preview' icon () located in the bottom action bar to view a PDF preview of the form ensuring that all the data has populated correctly and any other information is displayed accurately. In particular, ensure that the 'Letter of Activity (1),' 'Protective Equipment/Engineering Controls,' 'Physical Form,' 'Media of Release,' 'Control Technology,' and '% New Substance' fields of entry have been populated correctly.

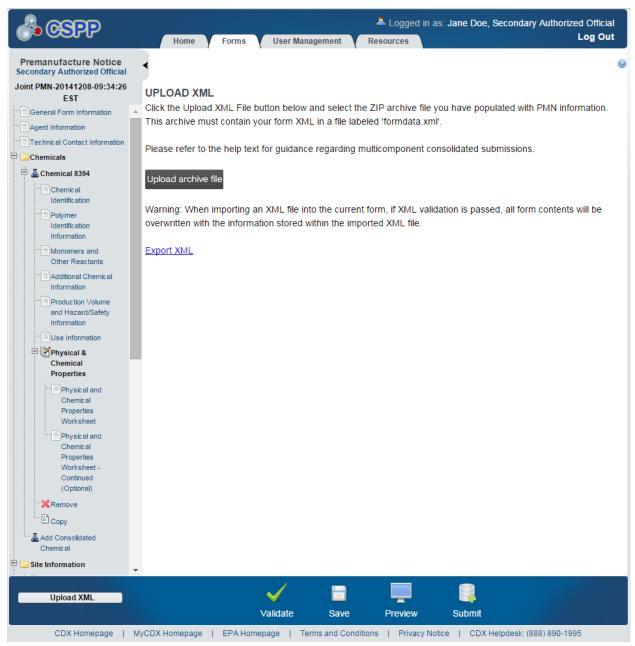

5 Biotechnology Secondary User

5.1 Joint and Letter of Support Process

The Biotechnology form is used to collect information about "intergeneric" microorganisms that will be manufactured or imported into the United States. EPA collects the information provided in a Biotechnology form through a free text box and attachments. The Biotechnology form does not have a structured data format, but there are several types of Biotechnology notices that can be filed. The different types are as follows: Microbial Commercial Activity Notice (MCAN), TSCA Experimental Release Application (TERA), Tier I Exemption, Tier II Exemption, and Biotechnology Test Market Exemption (TME) forms. All the forms have the same upload requirements and EPA will retain responsibility for verifying the correct information is received.

The Biotechnology Joint and/or Letter of Support process will be a multi-step process with coordination required between the Primary, Joint, and/or Letter of Support submitters. The Primary user would first state that a Joint Submission and/or Letter of Support would supplement the application on the 'General Form Information' screen. Based on the selection, the 'Joint Submission' and/or 'Letter of Support' folder will populate. Each folder will contain a section for you to enter contact information, field information, and instruction information with the secondary user's unique identification number. The Primary submitter may identify up to two Joint Submissions and an unlimited number of Letters of Support.

When the Primary user enters the relevant Joint Submission and/or Letter of Support folder, the Primary user will be asked to enter contact information for the Joint and/or Letter of Support submitter on the first screen. The Primary user will use the email address entered on this screen will be used to send the Joint and/or Letter of Support Submitter the unique identifier. The second screen in the Joint and/or Letter of Support folder will display the unique ID that will be sent to the Secondary use at and a text box for the Primary user to provide the Secondary user instructions or information about what is to be filed. The Secondary user will not be sent the information that the Primary user captured or be able to access the Joint and/or Letter of Support form until the Primary AO has submitted the original Biotechnology form.

The secondary submitter will register in CDX as a Secondary AO and access the Section 5 Notices and Supports application. Once you arrive at the 'Section 5 Notices and Supports Forms' screen, click the 'Start New Form' button and enter in the unique identifier on the 'Enter Passphrase' screen sent via email by the Primary user which will generate the appropriate form that the secondary submitter will be populating. The unique ID will link the primary and joint forms on the backend. The joint form will contain the same screens listed for the primary Biotechnology form, except the Joint submitter will not be supplied the 'Joint Folder.' All screens will be identical with regards to requirements and view with the exception of the 'Section 5 Notices and Supports Forms' screen and the 'General Form Information' screen, which are listed below. The secondary submission process will also be identical to the primary submission.

5.1.1 General Form Information

You can access the 'General Form Information' screen by creating a passphrase in the 'Create Passphrase' screen or by entering a passphrase in the 'Enter Passphrase' screen.

The 'General Form Information' screen presents a list of text fields and drop-down menus for you to input identifying information for the specific form. You will have the option to assign a



'Form Alias' to help you identify the form. A form alias is helpful when a user or company has multiple forms and/or when you must differentiate between forms to the help desk. Upon navigating to the 'General Form Information' screen, the system auto-generates a default alias in the following format: <Form Type-YYYYMMDD-HH:MM:SS Time Zone>.

The TS number must be a six (6) character alphanumeric combination and should include two (2), three (3), or four (4) letters. Company names, recognizable words, and numerical series are not recommended.

The 'Text/Comments' text box captures information regarding the submission/attachment. A 'CBI' checkbox displays above the 'Text/Comments' text box to claim the information as confidential.

The 'General Form Information' screen displays the option to attach a document by clicking the 'Attach Document' button. For more information regarding the attach document functionality, please refer to **Section** Error! Reference source not found..

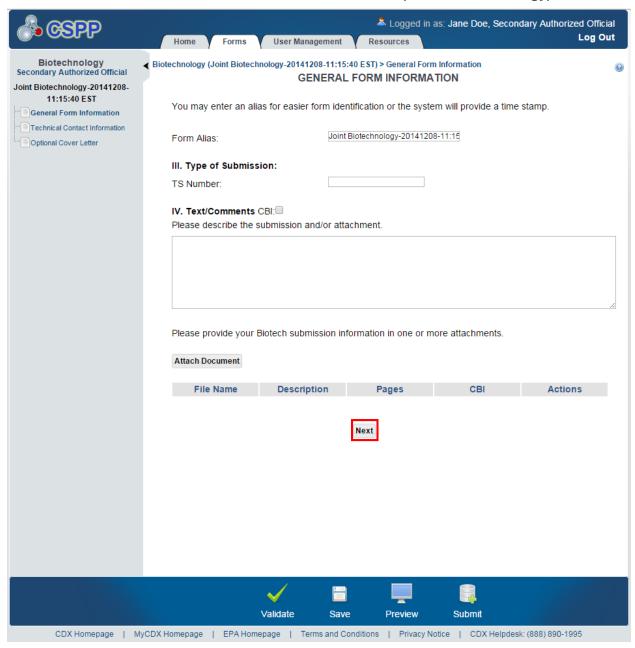
- **Form Alias:** Enter a custom form alias, if applicable. Upon navigating to the screen, the system auto-generates an editable alias comprised of <Form Type-YYYYMMDD-HH:MM:SS Time Zone>. This is a required field.
- **Type of Submission:** Select the submission type from the drop-down menu. This drop-down menu contains the following values: 'MCAN (Microbial Commercial Activity Notice),' 'TERA (TSCA Experimental Release Application),' 'Tier I Exemption,' 'Tier II Exemption,' and 'Biotechnology TME (Test Market Exemption).'
- **TS Number:** Enter the TS number. The TS number can be any six (6) character alphanumeric combination and should include two (2), three (3), or four (4) letters. Company names, recognizable words, and numeric series are not recommended. This field is required if 'MCAN' is selected from the 'Type of Submission' drop-down menu, but is also required regardless of the submission type if a Letter of Support is pending, and/or if a joint Biotechnology form is being filed.
- **Text/Comments:** Enter a description of the form and/or attachment.
- **CBI:** Check the 'CBI' checkbox to claim the 'Text/Comments' information as confidential.
- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Upload attachments including published literature, regulations and certifications, ID data, construct data, effects data, MSDS, manufacturing details, use details, inactivation data, and/or other types of documents. At least one document is required even if a Letter of Support or Joint Submission is claimed. Please refer to Section Error! Reference source not found. for additional details regarding the attach document process.
- **File Name:** Displays the file name and file extension of a document that is uploaded on the 'Attach Documents' pop-up window.
- **Description:** Displays the description of a document.
- Pages: Displays the number of pages a document contains.
- **CBI:** Indicates the CBI status of a document by displaying either a 'Y' or an 'N.'



• Actions: Click the 'Delete' icon (×) to delete the entire attached document row permanently from the system. A warning message displays to confirm the deletion.

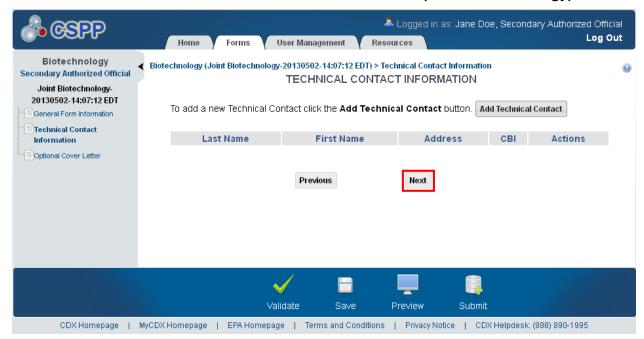

You can access the 'Add Technical Contact' pop-up window by clicking the 'Add Technical Contact' button on the 'Technical Contact Information' screen.

- Copy CDX Registration: Click the 'Copy CDX Registration' button to copy your information from CDX registration; a message displays confirming the import of CDX registration information.
- Check here to claim this information as CBI: Check the 'Check here to claim this information as CBI' checkbox to claim the technical contact information as confidential.
- **First Name:** Enter the technical contact's first name. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration. This is a required field.
- Last Name: Enter the technical contact's last name. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration. This is a required field.
- **Position:** Enter the technical contact's job title.
- **Company Name:** Enter the technical contact's company name. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration. This is a required field.

- Email Address: Enter the technical contact's email address. The email address must follow the standard email address format: John.Doe@domain. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration.
- Mailing Address 1: Enter the first line of the technical contact's mailing address. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration. This is a required field.
- Mailing Address 2: Enter the second line of the technical contact's mailing address. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration.
- **City:** Enter the city of the technical contact's mailing address. Click the 'Copy CDX Registration' button to populate the fields with information entered during CDX registration. This is a required field.

The 'Optional Cover Letter' screen is used to communicate information to EPA not collected elsewhere in the form. The cover letter is used to give OPPT resources and special instructions

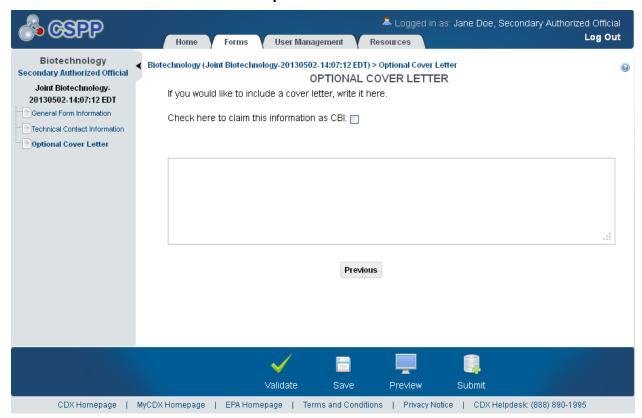


regarding the application. The cover letter should be either fully CBI or non-CBI to eliminate user error to promote transparency between the company and EPA.

- Check here to claim this information as CBI: Check the 'Check here to claim this information as CBI' checkbox to claim the cover letter information as confidential.
- **Optional Cover Letter:** Enter the description and any additional special instructions regarding the form.

6 Bona Fide Form Secondary User

The purpose of the Bona Fide module is to receive an official determination from EPA as to whether a substance is on the TSCA inventory. Submitters may attempt to avoid submitting a PMN by completing a Bona Fide form to establish that the chemical already exists on the inventory. The Bona Fide process is covered in a thirty (30) day period.

6.1 Edit Bona Fide Form

To edit a Joint Bona Fide form, navigate to the 'Section 5 Notices and Supports Forms' screen and select 'Bona Fide' from the 'Form Type' drop-down menu. Refer to **Section 3.4** for additional details regarding the 'Section 5 Notices and Supports Forms' screen.

Refer to **Section 3.5** for additional details regarding the create passphrase process.

6.1.1 General Document Information

You can access the 'General Document Information' screen by entering the unique identification number provided by the AO and creating a passphrase on the 'Create Passphrase' screen.

The 'General Document Information' screen presents text fields and checkboxes for you to input identifying information for the specific form. You will have the option to assign a 'Form Alias' by which the form can be identified. The form alias is helpful when you or the company has multiple forms and/or when a user must differentiate between forms to the help desk. If a form alias is not entered, the system will provide a default alias comprised of a form type and date and time stamp in the following format: <Form Type-YYYYMMDD-HH:MM:SS Time Zone>.

You can claim the entirety of the form as CBI. The entire form will be claimed as CBI if you check the 'I claim the entirety of the submission as CBI' checkbox. The entire form will be considered non-CBI if you leave the 'I claim the entirety of the submission as CBI' checkbox unchecked.

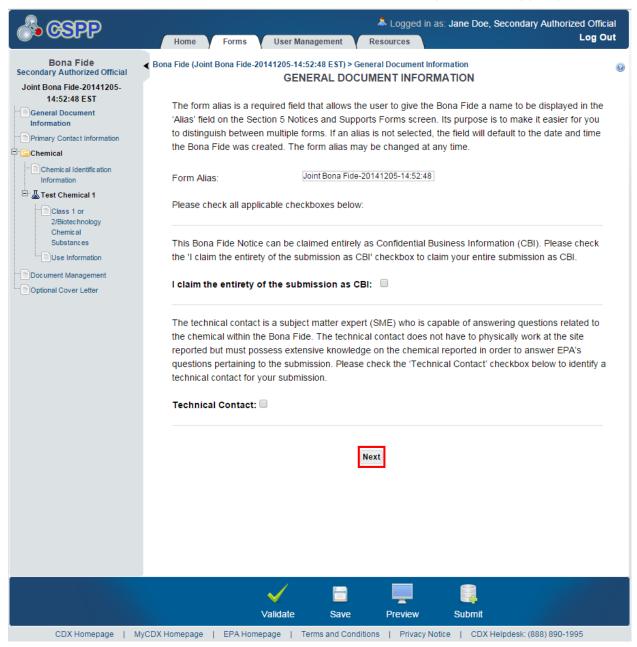
You can indicate that a technical contact will be identified by checking the 'Technical Contact' checkbox. The technical contact must possess sufficient knowledge to answer any questions EPA may have about the chemical reported within the form. The application will generate a 'Technical Contact Information' screen when you check the 'Technical Contact' checkbox.

- **Form Alias:** Enter the form alias. Upon navigating to the screen, the screen auto-generates an editable form alias comprised of <Form Type-YYYYMMDD-HH:MM:SS Time Zone>. This is a required field.
- I claim the entirety of the submission as CBI: Check the 'I claim the entirety of the submission as CBI' checkbox to flag all data contained within the form as confidential business information.
- **Technical Contact:** Check the 'Technical Contact' checkbox to generate a 'Technical Contact Information' screen for you to enter contact information about the technical contact associated with the reported chemical.

6.1.2 Primary Contact Information

You can access the 'Primary Contact Information' screen by clicking the 'Next' button from the 'General Document Information' screen. You can also access this screen by clicking the 'Primary Contact Information' link within the navigation tree.



The data fields on the 'Primary Contact Information' screen are pre-populated based on information entered during CDX registration. All fields are editable allowing for necessary updates. The 'Job Title' field on this screen is not pre-populated from CDX registration and is a required field.

If you checked the 'I claim the entirety of the submission as CBI' checkbox on the 'General Document Information' screen, all entered primary contact information is flagged as CBI.

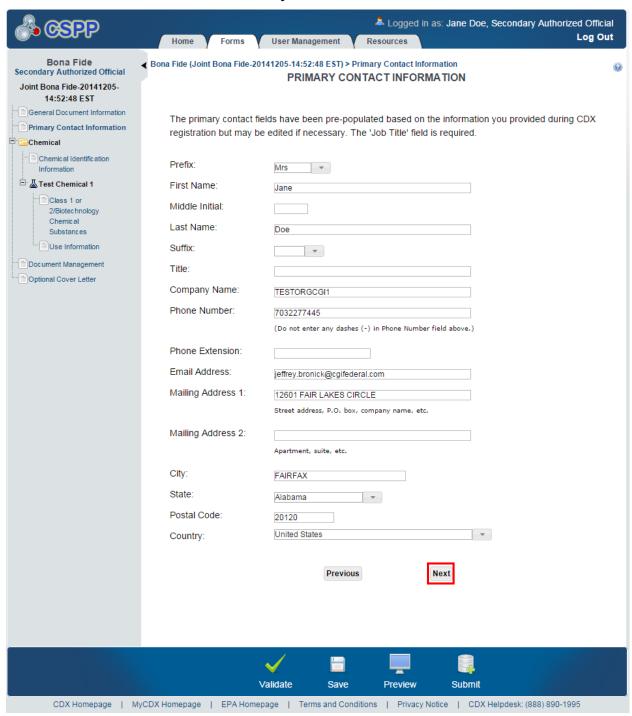
The following fields are captured and displayed from the logged in user's CDX registration information:

- **Prefix:** Select the primary contact's prefix from the drop-down menu.
- **First Name:** Enter the primary contact's first name. This is a required field.
- **Middle Initial:** Enter the primary contact's middle initial.
- Last Name: Enter the primary contact's last name. This is a required field.
- **Suffix:** Select the primary contact's suffix from the drop-down menu.
- **Title:** Enter the primary contact's job title. This is a required field.
- Company Name: Enter the primary contact's company name. This is a required field.
- **Phone Number:** Enter the primary contact's daytime phone number; dashes are not allowed. This is a required field.
- **Phone Extension:** Enter the extension to the primary contact's daytime phone number.
- **Email Address:** Enter the primary contact's email address. The email address must follow the standard email address format: John.Doe@ABC.com. This is a required field.
- **Mailing Address 1:** Enter the first line of the primary contact's mailing address. This is a required field.
- Mailing Address 2: Enter the second line of the primary contact's mailing address.
- **City:** Enter the city of the primary contact's mailing address. This is a required field.
- **State:** Select the state of the primary contact's mailing address from the drop-down menu. The state field is required if the user selects 'United States' from the 'Country' drop-down menu.
- **Postal Code:** Enter the postal code of the primary contact's mailing address. This is a required field.
- **Country:** Select the country of the primary contact's mailing address. This is a required field.

6.1.3 Technical Contact Information

If you indicated on the 'General Document Information' screen that technical contact information will be provided, then you can navigate to the 'Technical Contact Information' screen by clicking the 'Next' button from the 'Primary Contact Information' screen. You can also access this screen by clicking the 'Technical Contact Information' link within the navigation tree.

The technical contact is a subject matter expert (SME) who is capable of answering questions related to the chemical submitted to EPA within the Bona Fide form. The technical contact does not have to work at the port or site reported on the form but must possess sufficient knowledge to answer EPA's questions pertaining to the chemical reported in the form.

The text fields on the 'Technical Contact Information' screen will be blank upon accessing the screen. To add information, you will enter data into the blank text boxes for the listed text fields. If you checked the 'I claim the entirety of the submission as CBI' checkbox on the 'General Document Information' screen, all entered technical contact information will be flagged as CBI.

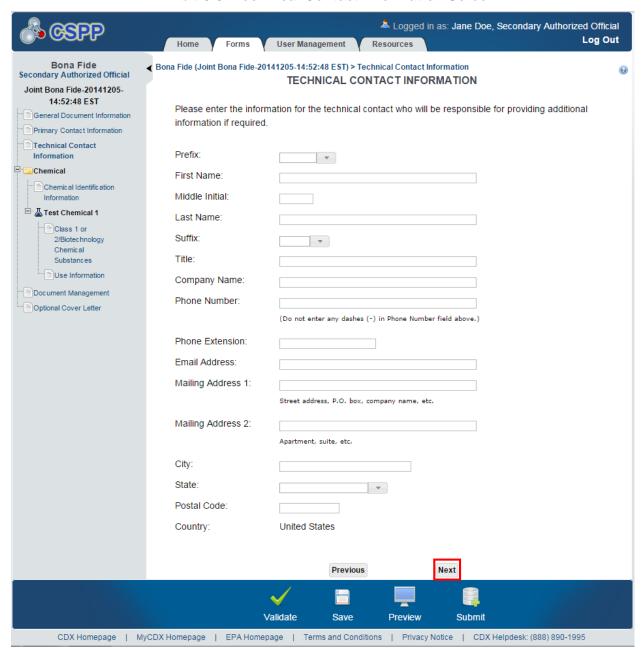
Please note that if you are using IE 7, there will be a spacing issue between the 'Suffix' drop-down menu and the 'Title' text field.

You can navigate to the 'Chemical Identification Information' screen by clicking the 'Next' button from the 'Chemical Identification Information' screen. You can also access this screen by clicking the 'Chemical Identification Information' link within the navigation tree.



The 'Chemical Identification Information' screen identifies the type of chemical the submitter will enter into the application. You will be able to file a Bona Fide form for a class 1 or 2/Biotechnology chemical substance or a polymer. Based on your selection, the appropriate screens for the respective chemical will appear.

This screen also provides a text field for you to identify an alias for the chemical substance.

- Class 1 or 2/Biotechnology Chemical Substance: Select the 'Class 1 or 2/Biotechnology Chemical Substance' radio button to indicate that the chemical is a class 1 or 2/biotechnology substance. If you select the 'Polymer' radio button after initially selecting the 'Class 1 or 2/Biotechnology Chemical Substance' radio button, the application generates an error message warning you that you will lose all data for this chemical if the chemical type changes. The user is required to select one of the two radio button options displayed in the 'Chemical Type' section.
- **Polymer:** Select the 'Polymer' radio button to indicate that the chemical is a polymer. If you select the 'Class 1 or 2/Biotechnology Chemical Substance' radio button after initially selecting the 'Polymer' radio button, the application generates an error message warning you that you will lose all data for this chemical if the chemical type changes. The user is required to select one of the two radio button options displayed in the 'Chemical Type' section.
- Chemical Alias: Enter the chemical alias to associate with a chemical.

Navigation: If you selected the 'Class 1 or 2 Chemical Substance' radio button, click the 'Next' button to navigate to the 'Class 1 or 2 Chemical Substances' screen. If you selected the 'Polymer' radio button, click the 'Next' button to navigate to the 'Polymer Identification Information' screen.

6.1.5 Class 1 or 2/Biotechnology Chemical Substance

If you selected the 'Class 1 or 2/Biotechnology Chemical Substance' radio button, click the 'Next' button to navigate to the 'Class 1 or 2/Biotechnology Chemical Substances' screen.

The 'Class 1 or 2/Biotechnology Chemical Substances' screen provides fields for you to enter information describing the chemical for the Bona Fide which is to be filed, including its name, composition, and structure.

You can add a chemical component by clicking the 'Add New Chemical' button. Upon clicking the 'Add New Chemical' button, an expandable/collapsible field set generates that contains numerous fields to identify the chemical in question. You will be able to enter multiple chemical substances, each with unique information, by clicking the 'Add New Chemical' button for each chemical substance you wish to identify.

After the document(s) is/are attached and you have clicked the 'OK' button, the 'Attach Chemical Structure' pop-up window closes and the document information will be displayed in a table format on the 'Class 1 or 2/Biotechnology Chemical Substances' screen. The attachment table displays the file name of the document and user-provided description of the document.



Click the 'Delete' icon (×) located under the 'Actions' column to delete unwanted documents. Click the appropriate file name of the document within the 'File Name' column of the attachment table to access or edit previously attached documents.

Please note that if you are using IE 7, part of the content on this screen displays behind the Bona Fide navigation tree and certain fields on this screen may display twice.

- Add New Chemical: Click the button to generate the class 1 or 2/Biotechnology chemical substances field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.
- **Expand All:** Click the 'Expand All' link located at the upper-right of the expandable/collapsible field sets to expand a series of field sets.
- **Collapse All:** Click the 'Collapse All' link located at the upper-right of the expandable/collapsible field sets to collapse a series of field sets.
- Class of Substance: In the section, 'Class of Substance,' you identify whether a 'Class 1' or 'Class 2/Biotechnology' chemical substance is being reported. When you select the 'Class 2/Biotechnology' chemical substance radio button, you are indicating that some portions of the structure may not be known and an additional screen will appear within the navigation tree that provides fields for you to enter information concerning how the chemical was created. If multiple class 2 chemical substances are added, one 'Class 2/Biotechnology Substances' screen will apply to all chemical substances.
- Add Chemical ID: You can access the 'Add Chemical ID' pop-up window by clicking the 'Add Chemical ID' button within the 'Chemical Identification Information' field set. You can search for the reported chemical(s) either by the 'CASRN' or 'CA Index Name or Other Synonym.' If you retrieve zero results, the system provides fields for you to enter the chemical information by filling in the 'Chemical Name' and the 'Chemical Abstract Services Registry Number' under the manual entry field set. The system provides functionality to enter the selected chemical by clicking the 'OK' button located at the bottom of the 'Add Chemical ID' window. Refer to Section Error! - Chemical Name: The system provides fields for you to identify the 'Chemical Name' and the 'CASRN' (if available). 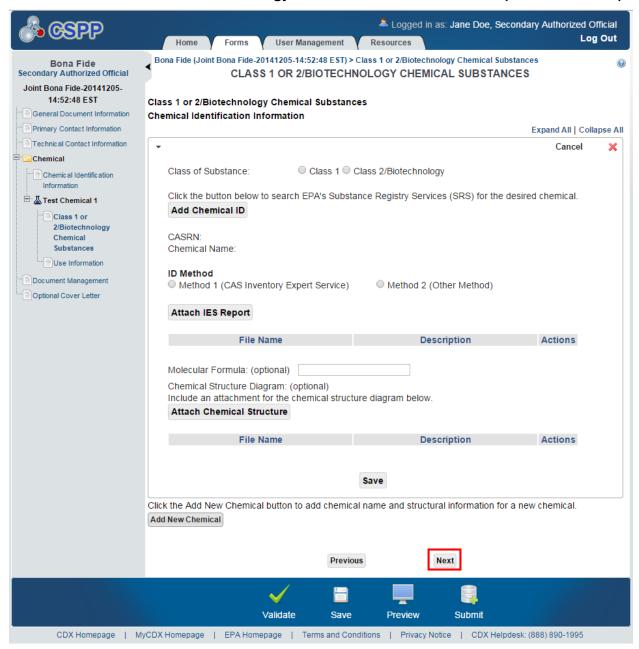


- **ID Method:** The system shall require that you identify which ID method was used to determine the chemical identity. If you select 'Method 1,' you are required to attach an IES report. You can also select 'Method 2 (Other Method).'
- Attach IES Report: To access the 'Attach IES Report' pop-up window, click the 'Attach IES Report' button that displays within the 'Chemical Identification Information' field set. - **File Name:** Displays the file name and file extension of the file that is uploaded on the 'Attach Chemical Structure' window.
- **Description:** Displays the description of the chemical structure.
- Actions: Click the 'Delete' icon (×) to delete the entire attached chemical structure row permanently from the system. A warning message displays to confirm the deletion of the document.
- Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able to navigate away from the screen using the 'Previous' and 'Next' buttons. 6.1.6 Class 2/Biotechnology Substances

You can navigate to the 'Class 2/Biotechnology Substances' screen by clicking the 'Next' button from the 'Class 1 or 2/Biotechnology Chemical Substances' screen when you select the 'Class 2/Biotechnology' radio button. You can also access this screen by clicking the 'Save' icon () within the action bar and clicking the 'Class 2/Biotechnology Substances' link within the navigation tree.

The 'Class 2/Biotechnology Substances' screen provides fields for you to enter information regarding a class 2/biotechnology chemical substance. A class 2/biotechnology chemical substance is a substance that may not have a defined chemical structure that has been identified. This screen provides fields for you to identify specific elements in the creation of the chemical using the following fields: 'Precursor Substances,' 'Nature of Reaction,' and 'Range of Composition (Optional).'

You will be able to enter precursor substances by searching SRS or by the manual entry fields when the substance is not in SRS. The substances will display in a table listing the 'Chemical Name' and CASRN.

The system provides fields for you to capture 'Nature of Reaction' and 'Range of Composition' in text boxes.

- **Precursor Substances:** This table captures the chemicals identified as immediate precursor substances, along with the respective CASRNs.
- **Search SRS:** Click the 'Search SRS' button to display the 'Search Substance Registry Services' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the search SRS functionality.
- Chemical Name: Displays the chemical name associated with a precursor substance. Click the 'Chemical Name' link to navigate to the 'Search SRS' pop-up window for edits.
- CASRN: Displays the CASRN associated with a precursor substance.
- Action: Click the 'Delete' icon (×) to delete the entire chemical row permanently from the system. A warning message will display to confirm the deletion of the chemical.
- Nature of Reaction: Enter the 'Nature of Reaction' description. This is a required field.
- Range of Composition: Enter the 'Range of Composition' description.

Exhibit 6-6: Class 2 Substances Screen

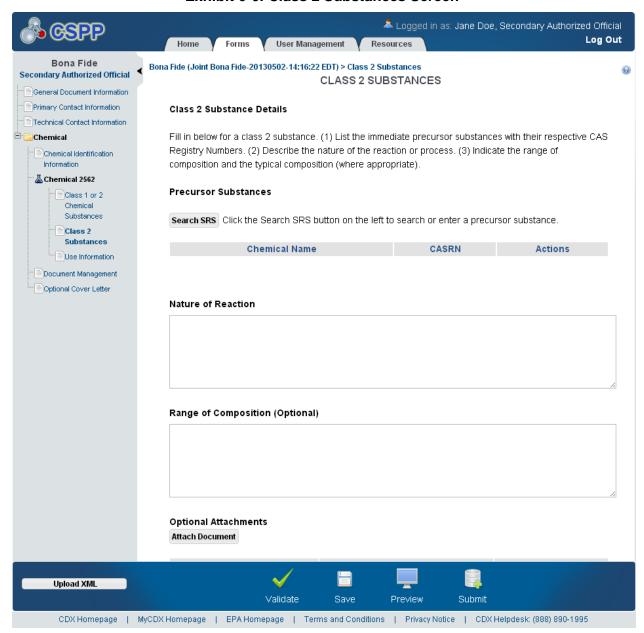

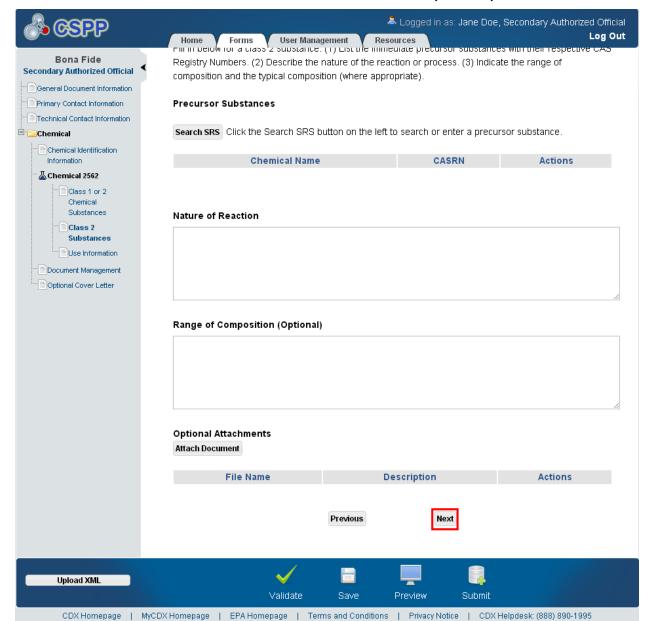


Exhibit 6-7: Class 2 Substances Screen (Scroll 2)

6.1.7 Polymer Identification Information

You can navigate to the 'Polymer Identification Information' screen by clicking the 'Next' button from the 'Chemical Identification Information' screen when you select the 'Polymer' radio button. You can also access this screen by clicking the 'Polymer Identification Information' link within the navigation tree after clicking the 'Save' icon within the bottom action bar.



Click the 'Add New Chemical' button to create a chemical substance. Upon clicking the 'Add New Chemical' button, an expandable/collapsible field set generates that contains numerous fields that pertain to the particular polymer. The system provides numerous fields for you to enter multiple chemical substances, each with unique information, by clicking the 'Add New Chemical' button for each chemical you wish to identify.

For a single component submission, create the field set by clicking the 'Add New Chemical' button. Upon clicking the 'Add New Chemical' button, the application generates a field set containing numerous fields for you to enter information pertaining to that particular chemical.

For a multi-component submission, create individual field sets by clicking the 'Add New Chemical' button. Multi-component chemical submissions occur when two or more chemicals always generate together in a single pot and are never isolated. Upon clicking the 'Add New Chemical' button, the application generates a field set containing numerous fields for you to enter information pertaining to that particular chemical. Enter additional chemical components, each with unique identifying information, by clicking the 'Add New Chemical' button for each additional chemical that is part of the multi-component mixture. All multi-component chemicals will reside in one chemical folder in the navigation tree.

- Add New Chemical: Click the button to generate the 'Polymer Identification Information' field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.
- **Expand All:** Click the 'Expand All' link located at the upper-right of the expandable/collapsible field sets to expand a series of field sets.
- Collapse All: Click the Collapse All' link located at the upper-right of the expandable/collapsible field sets to collapse a series of field sets.
- Add Chemical ID: Click the 'Add Chemical ID' button within the 'Polymer Identification Information' field set to generate the 'Add Chemical ID' pop-up window. You can search for the reported chemical(s) either by the 'CASRN' or 'CA Index Name or Other Synonym.' If you retrieve zero results, the system provides fields for you to enter the chemical information by filling in the 'Chemical Name' and the 'Chemical Abstract Services Registry Number' (CASRN) under the manual entry field set. The system provides functionality for you to enter the selected chemical by clicking the 'OK' button located at the bottom of the 'Add Chemical ID' window. Refer to **Section 3.10** for further details regarding the search SRS functionality.
- **Chemical Name:** The system provides fields for you to identify the 'Chemical Name' and the CASRN (if available). The system provides functionality for you to search for the



chemical substance using the 'Add Chemical ID' search or manually enter the chemical information in the 'Add Chemical ID' pop up.

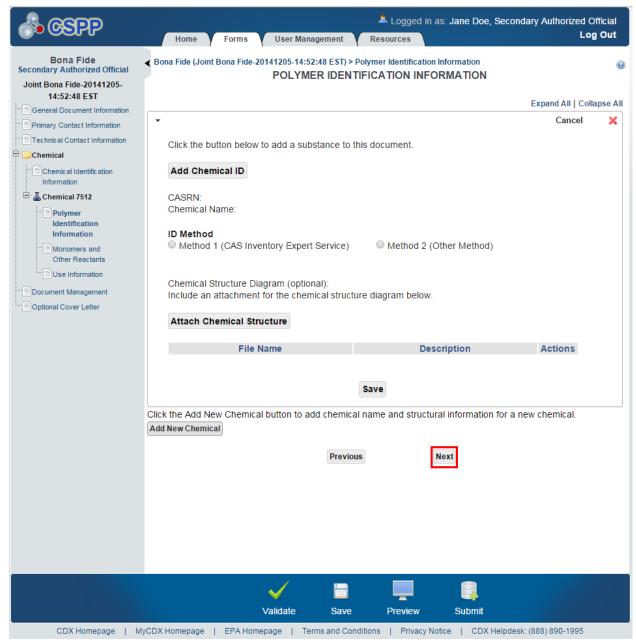
- **ID Method:** The system shall require that you identify which ID method was used to determine the chemical identity. When you select 'Method 1 (CAS Inventory Expert Service),' the system generates an 'Attach IES Report' button for you to attach an IES report. If you select 'Method 1,' you are required to attach an IES report. You can also select 'Method 2 (Other Method).'
- Attach IES Report: Click the 'Attach IES Report' button within the 'Polymer Identification Information' field set after selecting the 'Method 1 (CAS Inventory Expert Service)' radio button to access the 'Attach IES Report' pop-up window. After you attach the document(s), and click the 'OK' button, the 'Attach IES Report' pop-up window closes and the document information displays in a table format on the 'Polymer Identification Information' screen. The attachment table displays the file name of the document and the user-provided description of the document. Click the 'Delete' icon (X) located under the 'Actions' column to delete unwanted documents. Click the file name link under the 'File Name' column to access or edit previously attached documents.
- Chemical Structure Diagram: The system allows you to attach a chemical structure diagram.
- Attach Chemical Structure: Click the 'Attach Chemical Structure' button within the 'Polymer Identification Information' field set to access the 'Attach Chemical Structure' popup window. You can attach the file(s) and enter a description of the document.
- **File Name:** Displays the file name and file extension of the document that is uploaded on the 'Attach Chemical Structure' window.
- **Description:** Displays the description of the chemical structure.
- Actions: Click the 'Delete' icon (×) to delete the entire attached chemical structure row permanently from the system. A warning message displays to confirm the deletion.
- Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able to navigate away from the screen using the 'Previous' and 'Next' buttons. Refer to Section Error! Reference source not found. for more information regarding the save functionality in an expandable/collapsible field set.

After the document is attached and you click the 'OK' button, the 'Attach Chemical Structure' pop-up window closes and the document information will be displayed in a table format on the 'Polymer Identification Information' screen. The attachment table displays the file name of the document and provided description of the document. The system provides functionality for you to delete unwanted documents by clicking the 'Delete' icon (×) located under the 'Actions' column. Click the appropriate file name of the document within the 'File Name' column of the attachment table to access or edit previously attached documents.

6.1.8 Monomers and Other Reactants

The 'Monomers and Other Reactants' screen is used to identify the chemical measurements and monomers that make up a polymer. The 'Monomers and Other Reactants' screen has an 'Add Monomer' button that allows you to identify the monomer(s) that make up the polymer composition.

- Add Monomer: Click the 'Add Monomer' button to generate an expandable/collapsible field set.
- Cancel: Click the 'Cancel' link located in the upper right-hand corner of the expandable/collapsible field set to prevent edits from saving and to remove a field set. The 'Cancel' link displays when the expandable/collapsible field set is open for editing. A confirmation message displays to confirm the action.
- Edit: Click the 'Edit' link located in the upper right-hand corner of the expandable/collapsible field set to modify the information entered in the fields. The 'Edit' link displays when the expandable/collapsible field set has been saved and the data is not currently editable.
- **Delete:** Click the 'Delete' icon (\times) located in the upper right-hand corner of the expandable/collapsible field set to delete the field set. A confirmation message displays to confirm the deletion.

- Monomer or Other Reactant: Displays the monomer or other reactant name; this field populates based on information entered on the 'Search Substance Registry Services' pop-up window. This is a required field.
- **Include in Identity:** Check the 'Include in Identity' checkbox to claim the value for 'Monomer or Other Reactant' as part of the monomer identification.
- **Typical Composition:** Enter the 'Typical Composition' value that a monomer contributes to a polymer; the value entered must be a positive numerical value greater than zero (0) and less than or equal to 100 with up to three decimal points. If the value entered is less than or equal to '2' a warning will be displayed in the global 'Validate' function or during the submission process indicating that the 'Typical Composition' is a value that is less than or equal to 2% and asking the user whether it should be included in the 'Chemical Identity.' This is a required field.
- Save: Click the button to save the information entered within the expandable/collapsible field set. You must click this button instead of the 'Save' icon () located within the bottom action bar to successfully save the entered information within the field set before being able



to navigate away from the screen using the 'Previous' and 'Next' buttons. Refer to **Section Error! Reference source not found.** for more information regarding the save functionality in an expandable/collapsible field set.

- Attach Document: Click the 'Attach Document' button to generate the 'Attach Documents' pop-up window. Refer to **Section Error! Reference source not found.** for additional details regarding the attach document functionality.

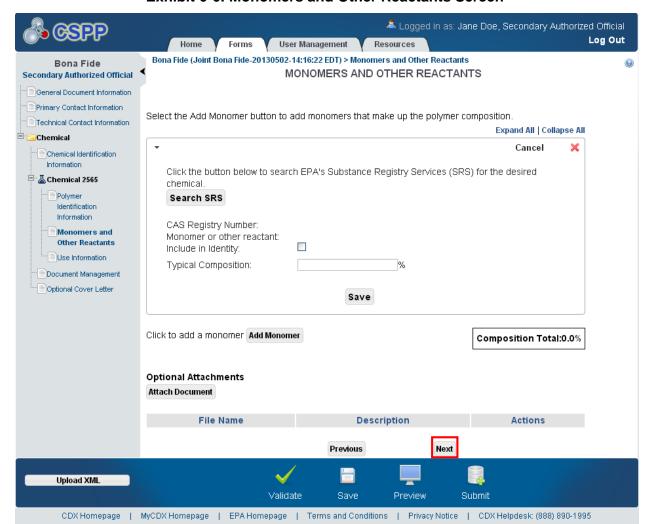


Exhibit 6-6: Monomers and Other Reactants Screen

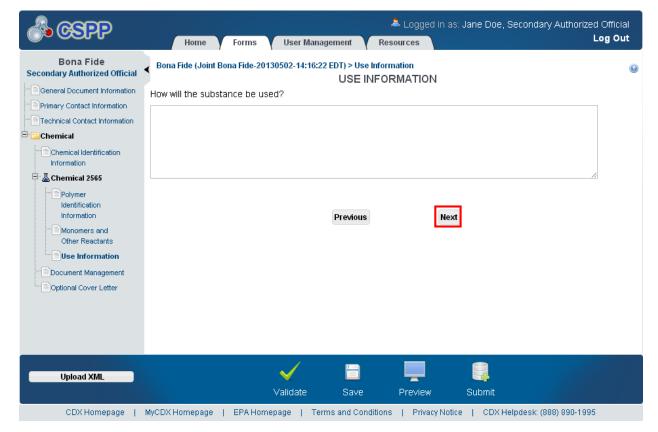


Exhibit 6-7: Use Information Screen

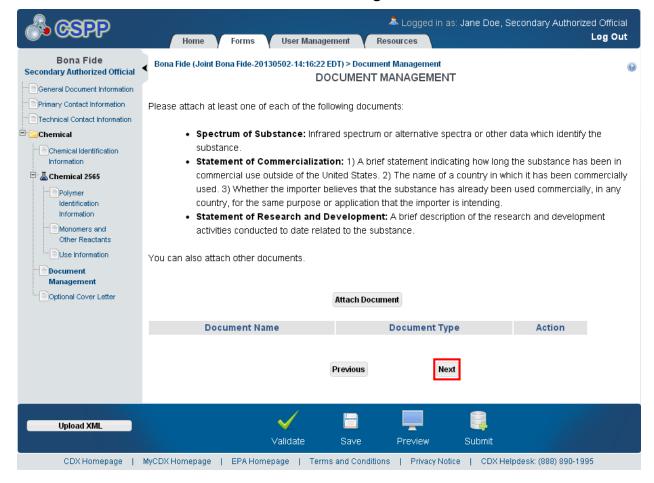

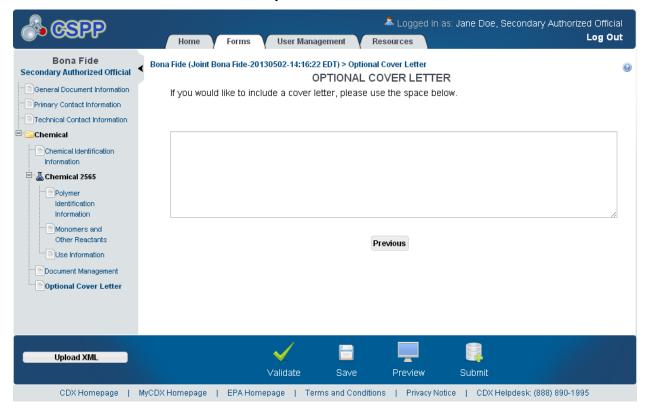

Exhibit 7-1: Preview Biotechnology Form Screen

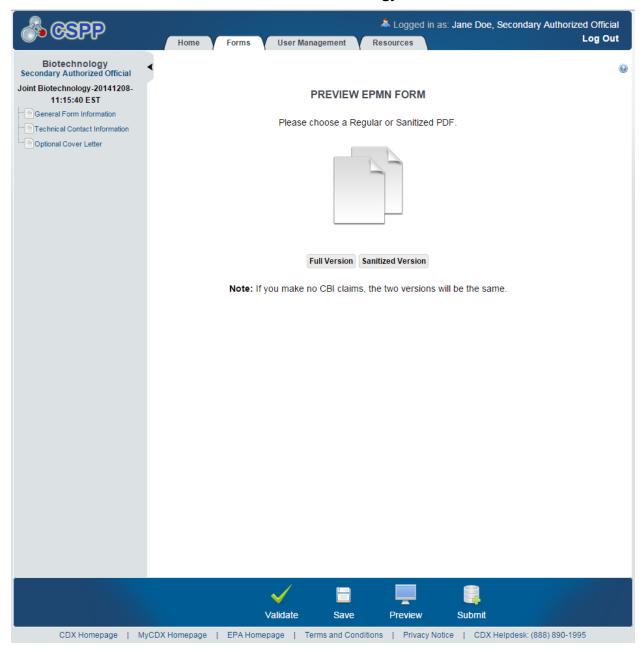

8 Validate

You can click the 'Validate' icon () at any stage of completing a Section 5 Notices and Supports form. The 'Section 5 Notices and Supports Validation' pop-up window displays when you click the 'Validate' icon (). Disable the pop-up blocker within your internet browser so that the 'Section 5 Notices and Supports Validation' pop-up window displays correctly. The 'Section 5 Notices and Supports Validation' pop-up window displays a report of all validation errors and warning messages. During the validation process, the application validates each screen of the Section 5 Notices and Supports form to find missing and invalid data.

Please note in IE 7, the 'Help' button aligns to the right side of the 'Section 5 Notices and Supports Validation' pop-up window.

Validation Errors: Errors are denoted by an 'Error' icon (①) and can be fixed by clicking the error link. The links will display the *Screen Title Name* (e.g., Chemical Identification) and the associated error. After you click a link, the main application screen will display the section where the error occurred so you can easily fix the error. Once you have fixed the error(s), click the 'Validate' icon (\checkmark) again to refresh the 'Section 5 Notices and Supports Validation' pop-up window. If the information you fixed passes validation, the error will be removed from the 'Section 5 Notices and Supports Validation' pop-up window. You must fix all validation errors to submit the form to CDX successfully.

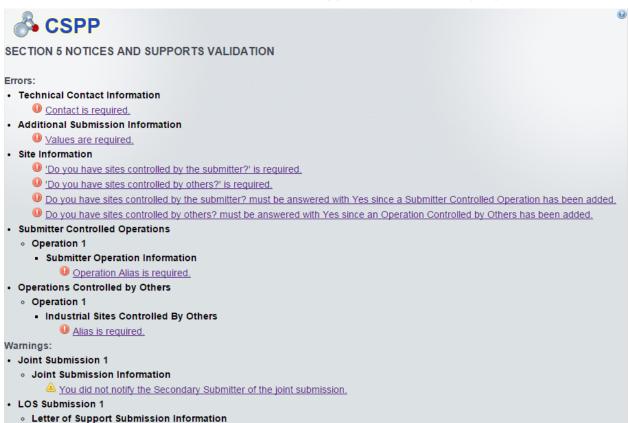

9 Submit to EPA via CDX

As the Secondary AO, you have the ability to sign and submit a Joint or Letter of Support form for a Section 5 Notices and Supports form to EPA. You may also submit amendments for Joint forms. You can save your form at any point during the data entry process. Any assigned Supports for your form cannot submit the Section 5 Notices and Supports form. The save functionality allows you to return to a form at any point in the future.

Once you complete all required information and pass validation, the system will allow a Section 5 Notices and Supports form to be successfully submitted.

9.1 Submitting Official Information

Click the 'Submit' icon () located in the bottom action bar of the Section 5 Notices and Supports application to access the 'Submitting Official Information' screen. This screen displays to a Secondary AO upon submission.

After clicking the 'Submit' icon (), the system requires you to review your contact information provided during CDX registration. The system also requires you to identify your job title. Click the 'Home' button to navigate to the Section 5 Notices and Supports 'Home' screen.

The following statement, which displays to the Primary AO and Secondary AO, must be confirmed before the system will allow you to move forward: "Please confirm that you are the legally responsible party from the submitting company." If you check the checkbox associated with this statement, the application navigates to either the appropriate certification screen or the 'Cross-Media Electronic Reporting Regulation (CROMERR)' screen. The checkbox must be checked in order to continue with the submission.

A 'Submitting On Behalf Of' checkbox will be displayed on the screen if you are submitting an amendment. After you check the checkbox, click the 'Next' button to navigate to the 'Submitting On Behalf Of' screen. The 'Submitting On Behalf Of' checkbox is only displayed for amendments/revisions/updates to the original submission.

Please note in IE 7, the 'Cancel' and 'Next' buttons will be misaligned in the center of the 'Submitting Official Information' screen.

- **Submitting On Behalf Of:** This checkbox only displays for amendments/revisions/updates to an original submission.
- **CBI:** Check the 'CBI' checkbox to claim the submitting official's information as confidential.
- Please confirm that you are the legally responsible party from the submitting company: Check the checkbox to confirm that the individual submitting the form has permission to do so.
- **First Name:** Displays the first name of the submitting official, which has been pre-populated from CDX registration information.
- **Middle Initial:** Displays the middle initial of the submitting official, which has been prepulated from CDX registration information.
- Last Name: Displays the last name of the submitting official, which has been pre-populated from CDX registration information.

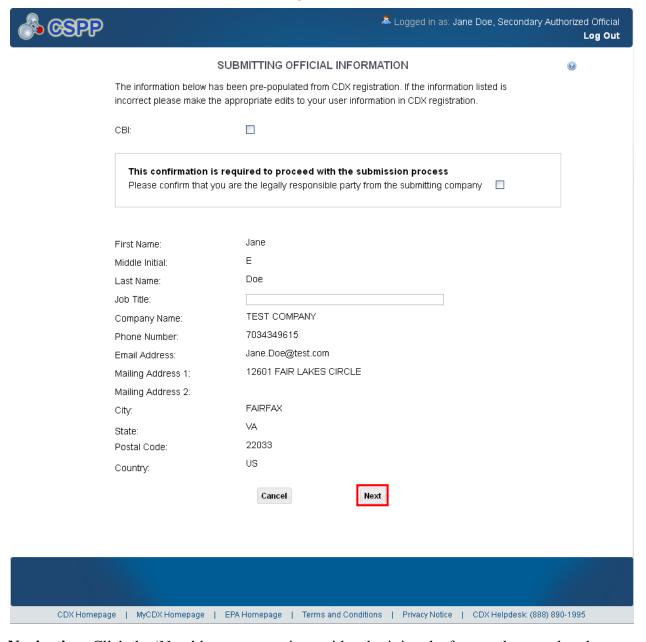

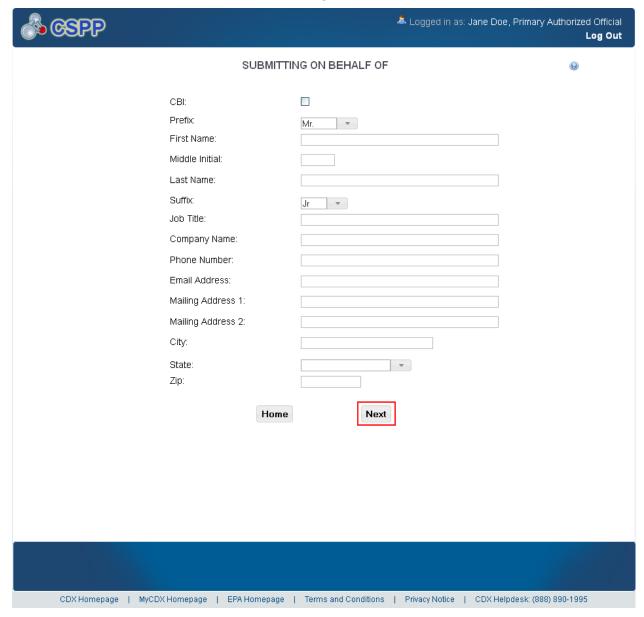

Exhibit 9-3: Submission Process: Validation Screen

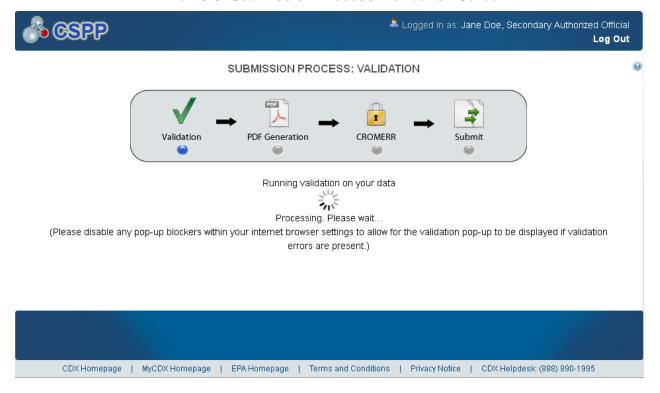
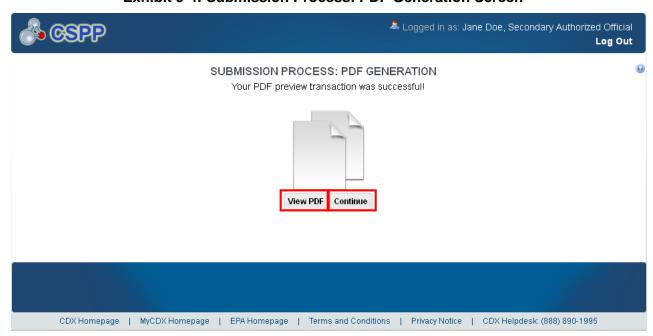

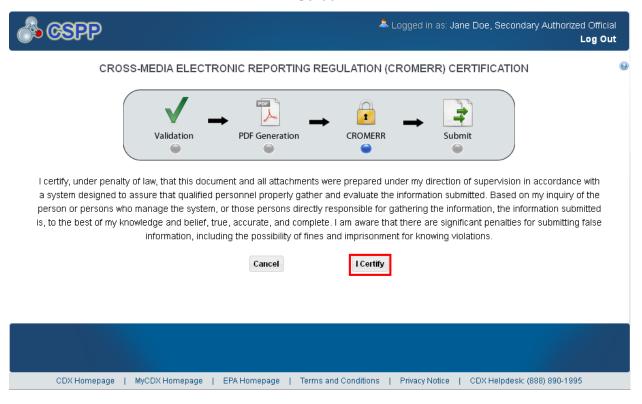

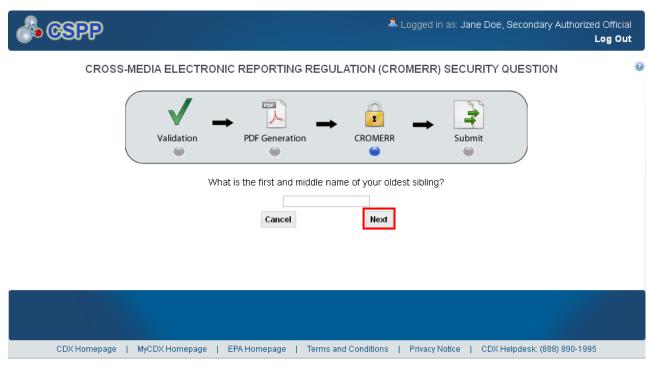

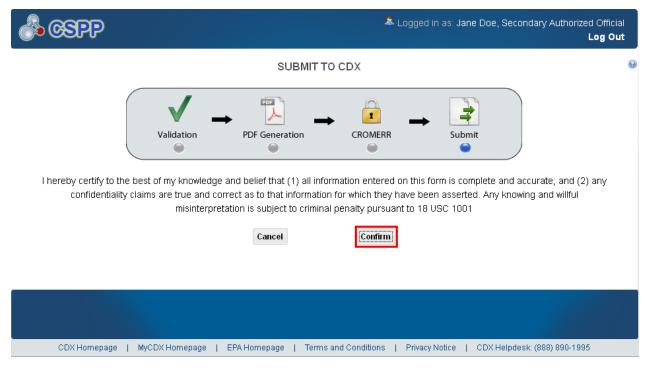

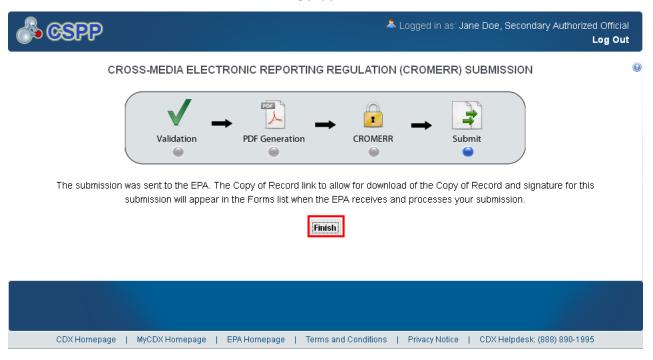

To download a Copy of Record, navigate to the 'Section 5 Notices and Supports Forms' screen and locate a form alias for which you have successfully completed a submission and which has a status of 'Submitted.'

Click the 'Copy of Record' icon () from the 'Section 5 Notices and Supports Forms' screen to navigate to the 'Enter Passphrase' screen to login into CDX. The 'Enter Passphrase' screen requires you to enter the passphrase originally associated with the form. If your passphrase is entered correctly, you will access the 'Cross-Media Electronic Reporting Regulation (CROMERR) Login' screen where you are required to enter your credentials you provided during CDX registration. Once you have provided the correct CDX password, click the 'Next' button to navigate to the 'Cross-Media Electronic Reporting Regulation (CROMERR) Security Question' screen. The 'Cross-Media Electronic Reporting Regulation (CROMERR) Security Question' screen randomly selects and displays one of the five CROMERR eSIG-PIN questions that you answered on the 20-5-1 Question screen during CDX registration. 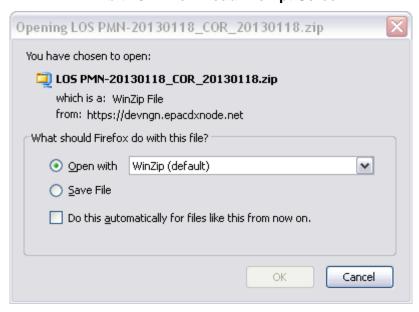


Exhibit 10-2: Download Prompt Screen

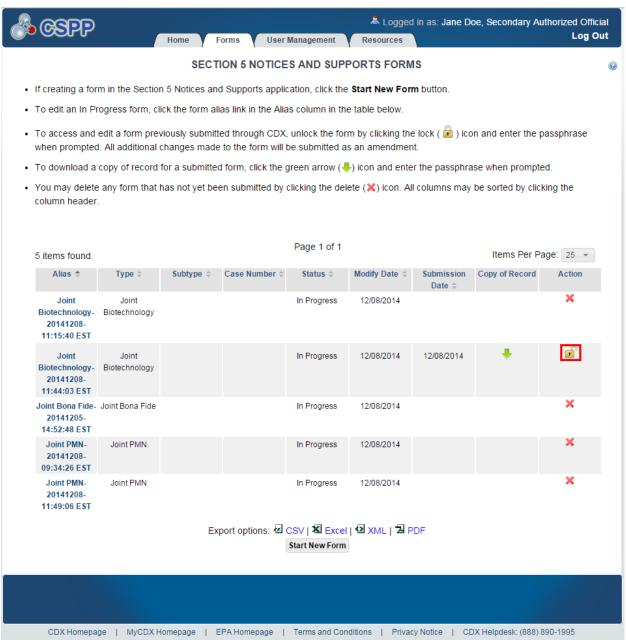


11 Create an Amendment

To amend a submitted Joint PMN, Joint Biotechnology, or Bona Fide Letter of Support submission, navigate to the 'Section 5 Notices and Supports Forms' screen and locate a previously submitted form with a status of 'Submitted.' In addition to displaying a status of 'Submitted' under the 'Status' column, the 'Lock' icon () will be displayed under the 'Action' column. Click the 'Lock' icon () under the 'Action' column to start an amendment.

After a submission has been unlocked, the 'Section 5 Notices and Supports Forms' screen will display a status of 'In Progress' under the 'Status' column, and an 'Unlocked' icon () will display under the 'Action' column; however, you will not see these changes until you navigate back to the 'Section 5 Notices and Supports Forms' screen. Refer to Section 1 through Section 4.1.26 for instructions on editing a revised PMN form. Refer to Section 5.1.1 through Section 5.1.3 for instructions on editing a revised Biotechnology form.

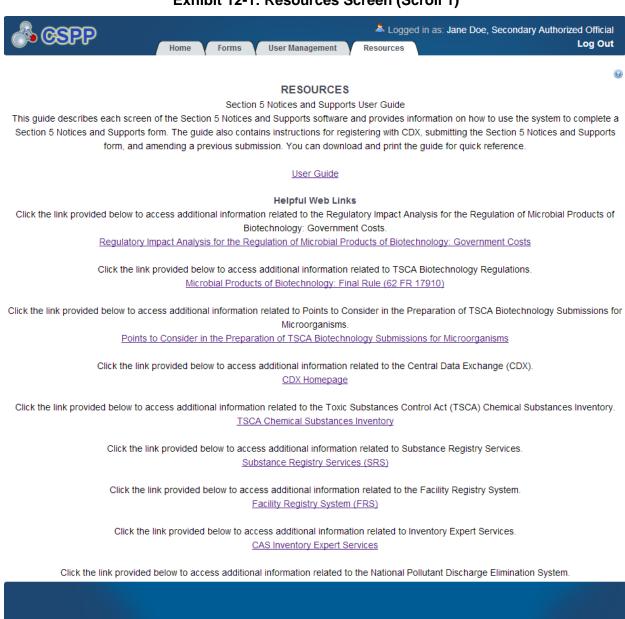
