**HPOG Impact Study** - The HPOG Impact Study is being designed to assess the effectiveness of the HPOG grant program. Additionally, it will demonstrate how variations in program services affect program impacts. The literature on promising and innovative Career Pathway programs, especially in health care, is quite limited. As such, the HPOG Impact Study will fill a void in the sectoral training and career pathways literature both about program effectiveness and about which types of programs or program components are most effective. this study will not examine site-specific impact, but rather will examine the effectiveness of program components across studies.
