

,1 Grain Stocks Report Version 1

- If your firm operates storage facilities in more than one state, separate reports should be prepared for each state.
- Report total capacity and stocks of whole grains and oilseeds in storage facilities operated by your firm.
- If your firm operates more than one Mill, Elevator, or Warehouse in :
 - report **total data for all storage facilities** if individual storage facilities do not report.
 - report **only your plant's storage facilities** if individual storage facilities do report.
- **INCLUDE** both bulk and sacked capacity in the rated storage capacity.
- **INCLUDE** all whole grains and oilseeds stored in your facilities and/or piles (temporarily stored) regardless of ownership for farmers, elevators, millers, processors, farmer owned reserve, under loan, and the Government Commodity Credit Corporation. **Include** grain to be used for seed. **Include** both domestic and imported stocks.
- **Exclude** grain owned and/or stored at another licensed grain elevator.
