Gerald S. Adler, "Medicare Beneficiaries Rate Their Medical Care: New Data From the MCBS," Health Care Financing Review, Vol. 16, No. 4 (Summer 1995): 175-187.  
Examines beneficiary satisfaction with technical and interactive aspects of their medical care. Explores the relationships between these attitudes with the characteristics of subgroups. Satisfaction is generally high, but it is lower for disabled enrollees, HMO members, those with poorer health status, dual enrollees, and those without supplementary insurance.

Richard Apodaca, David Judkins, Annie Lo, and Kimberly Skellan, "[Sampling from CMS Lists](#)," Proceedings of the Section on Survey Research Methods, American Statistical Association, (1992): 250-255.  
Presents the sample design of the MCBS, advantages of clustering, and some of the difficulties encountered in sampling. The paper also examines coverage issues, address quality, and response rates for the initial round.

Jan Blustein, "Medicare Coverage, Supplemental Insurance, and the Use of Mammography by Older Women," The New England Journal of Medicine, Vol. 332, No. 17 (April 27, 1995): 1138-1143.  
Mammography rates from Medicare bills were linked to MCBS data on person characteristics to examine the rates of testing for elderly women with varying supplementary coverage. Out-of-pocket costs are found to be barriers to preventive screening.

George Chulis, Franklin Eppig, Mary Hogan, Daniel Waldo, and Ross Arnett, "Health Insurance and the Elderly," Health Affairs, (Spring 1993): 111-118.  
Describes the distribution of Medicare supplementary insurance among the elderly Medicare population.

George Chulis, Franklin Eppig, Mary Hogan, Daniel Waldo, and Ross Arnett, "Health Insurance and the Elderly: Data from MCBS (Medicare Current Beneficiary Survey)," Health Care Financing Review, Vol. 14, No. 3 (Spring 1993): 163-81.  
Persons with Medicare only are a fairly small share of the elderly (11.4 percent). About three-fourths of the Medicare elderly have some form of private insurance. The share with Medicaid is 11.9 percent. In general, Medicare per capita spending levels increase as supplemental insurance comes closer to first dollar coverage.

George Chulis, Franklin Eppig, Mary Hogan, Daniel Waldo, and Ross Arnett,

"Why More Cost-Sharing Won't Slow Medicare Spending," [Journal of American Health Care Policy](#), Vol. 3, No. 4 (July/August 1993): 15-20.

Challenges the assumption that additional cost-sharing necessarily reduces the demand for medical care. MCBS data show that not only high-income people but also the bulk of the Medicare population purchase supplemental insurance to protect themselves from out-of-pocket costs.

George S. Chulis, Franklin J. Eppig, and John A. Poisal, "Ownership and Average Premiums for Medicare Supplementary Insurance Policies," [Health Care Financing Review](#), Vol. 17, No. 1 (Fall 1995): 255-275.

Details the distribution of supplementary health insurance among the Medicare population by demographic, socioeconomic, and health status characteristics. Also addressed are type of insurance, average premiums, and multiple policy coverage.

M. H. Davis and S. T. Burner, "Three Decades of Medicare: What the Numbers Tell us," [Health Affairs](#), Vol. 14, No. 4 (Winter 1995): 231-243.

A Data Watch article reviews a thirty-year history to provide a broad overview of the Medicare program, outlining both historical and current trends in coverage, financing, payment mechanisms, beneficiary status, and spending.

Data from the MCBS and the Medicare Buy-In file were used to estimate how many eligible elderly Medicare beneficiaries were participating in the Qualified Medicare Beneficiary program, to determine the characteristics of participants and non-participants, and to identify the most significant barriers to program participation.

Margo L. Rosenbach, "Access and Satisfaction Within the Disabled Medicare Population,"  
Health Care Financing Review, Vol. 17, No. 2 (Winter, 1995): 147-167.  
Focuses on under-65 Medicare population with mental and physical disabilities.

Margo L. Rosenbach, Killard W. Admache, and Rezaul K. Khandker,  
"Variations in Medicare Access and Satisfaction by Health Status: 1991-93,"  
Health Care Financing Review, Vol. 17, No. 2 (Winter 1995): 29-49.  
Examines Medicare access, use, and satisfaction before and after the implementation of the physician fee schedule. The study found increases in access and satisfaction over time, particularly among those in ill health.
