NFPA 10 Certification and recordkeeping.

These provisions of the proposed rule would require that individuals performing the annual inspection, maintenance, and necessary recharging of fire extinguishers be certified in accordance with the standards of NFPA 10.

**This is a RECORDKEEPING requirement -- A Vessel Master is expected to File and Produce the document once a year.**

Affected Population:

Vessels with Portable fire extinguishers choosing to maintain these themselves. This is based on the assumption that 90% of all these vessels hire a 3rd party to perform extinguisher maintenance. **SQL Query in Folder.**

**EXCLUSIONS:** Do not include Subchapter C vessels as the extinguishers on these vessels are on-time use and therefore not serviceable. Also Subchapter's O, OD, & OI are currently not directed to use NFPA 10 and so are excluded.
