Introductions

Introduction Option #1 - If they HAVE written on placemat.

C. Experience (if they've filled it out. If they haven't, skip to D)

 - a. How easy or hard was it?
 - b. How boring or fun was it?
 - c. How helpful were the instructions?
- 7. Where did you get that pen / pencil?
- 8. What types of puzzles have you done before?
- 9. What did you do when you finished writing here?
- 10. Did you realize there was something on the back?
 - a. How did you know that?
- 11. What did you think of what's on the back?

D. If they haven't filled it out

E. Comprehension

 - b. Were there any words or symbols you didn't understand?

- 16. What do you think this was trying to do or say?
- 17. How useful or important is this information to you?
- 18. Was there anything new you learned from this?
- 19. Are you familiar with the idea of financial scams?

F. Content and Design

 - a. What type of group do you think they are?
 - b. How much would you trust a group like this?
 - c. (If they say Consumer Financial Protection Bureau, or CFPB) Have you heard of them before?
- 21. Why do you think they created it?
- 22. Is the text large enough for you to read clearly?
- 23. Is there anything missing? If so, what?
- 24. For Scramble:
 - a. What do you think Eldercare.gov is?
 - b. Have you been there before?

G. Actions

- 25. What would you do with this now?
- 26. If you had a question about your finances, who would you reach out to?
- 27. If you or someone you knew were a victim of a financial scam, what would you do?
- 28. If it asked you to dial a phone number to report a financial scam, is this something you would do?
- 29. If it asked you to go online for more information, is this something you would do?
- 30. If it asked you to tear off a section, fill in information and mail it in to receive something, would you do that?
- 31. If you got this information and wanted to learn more, what would you do?

H. Format

- 32. Can you think of any way to improve this idea?
- 33. Is this enough information, too much or not enough?
- 34. Is there any type of information you'd like to see here?

I. Wrapping up

- 35. (Show other two designs) Here are two other items we created. Which do you like best, and why?
 - a. Which activity?
 - b. Which graphic?

- 36. Have you heard of the Consumer Financial Protection Bureau before?
- 37. What type of organization do you think the Consumer Financial Protection Bureau might be?
- 38. Last question do you have any other suggestions or ideas for us on how to improve this idea?
