## FROM THE DIRECTOR U.S. CENSUS BUREAU

The U.S. Census Bureau is conducting the Manufacturers' Unfilled Orders Survey. This survey collects data on sales and unfilled orders for 2015 and 2014 from domestic manufacturing companies; the data collected will be used in the development of estimates of monthly unfilled orders in the Manufacturers' Shipments, Inventories, and Orders (M3) survey.

The M3 survey measures monthly current industrial activity and provides an indication of future production; it is a principal economic indicator and is critical to assessing current economic activity. The data are used by the Bureau of Economic Analysis, the Counsel of Economic Advisors, the Federal Reserve Board, the Conference Board and members of the business community such as the National Association of Manufacturers, Wall Street Journal, Market Watch and Bloomberg business analysts. The Manufacturers' Unfilled Orders survey will provide benchmark totals for the monthly series and improve the quality of the current estimates.
