Approval of transfer of ownership and/or registry of the Vessel will be subject to the same terms and conditions governing transfer of a U.S. Flag vessel to foreign registry or ownership or both, as set forth in 46 CFR Part 221. Any foreign transferee will be required to execute an agreement similar to the contract under which this application is filed. A U.S. surety company bond or other surety satisfactory to the Maritime Administration will be required to guarantee performance of the conditions of said agreement.</p>
