The best way to determine which, if any, EDN funding sources are appropriate for your developing country project or business is to spend 5-10 minutes to submit a brief online screening document so that an EDN Originator can determine the best approach for your project.

Please note that this questionnaire does not constitute an application for funding, but serves as a tool to begin a conversation with an EDN Originator.

The services of an EDN Originator are not free of charge and pricing may vary by Originator and the extent of the services required to submit your application. We recommend that you discuss the potential cost of services with your Originator.

You may not have all the answers to the screening questions – just provide the information you have available and proceed to the next question. You can change your answers at any time prior to hitting the Submit button.

After completing the questions, you will be provided with a listing of all the EDN Originators from which to make a selection. Initially, the listing will display the Originators that work in your project location and sector. However, you can filter the listing further, and you are free to select up to 4 EDN Originators that you believe best fit your needs. The EDN Originator(s) you select will follow up with you within 5 business days to offer assistance. Even if you find your request falls outside of OPIC's funding guidelines, you may be well served reviewing your needs with an EDN Originator.
