- Report total price paid to growers at first point of sale as dry rough rice before deducting drying and storage charges, or transportation costs to the first point of sale. Exclude and LDP or MLG benefit and any payment of storage or transportation earned after point of sale.
- Report data for all settlements by STATE where grown.
- Rice purchased through redemption of CCC loans should be valued at the loan redemption rate (World Market Price [WMP] or loan plus interest whichever is lower) plus any additional payment (premium) to growers.
