- Payment Address (OGPA) screen

This screen is used to establish or change the address where the payment is sent. It also collects direct deposit information. The screen allows for input of direct deposit routing and transit numbers (RTN), direct deposit code (DDC), check digit code (CDC), direct deposit account number (DAN), and the Federal Information Processing Standard (FIPS) code.
