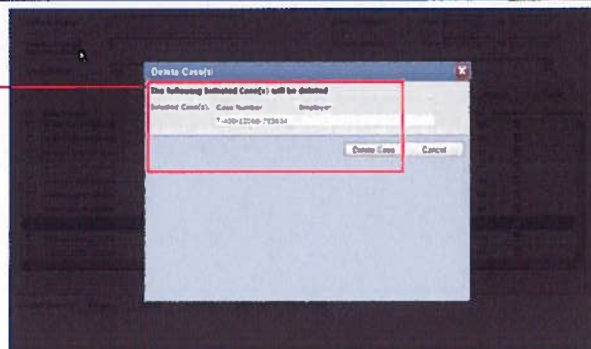
After selecting a case to reuse, select the sections to add to the new case, then click the Add to Form button
