SUPPORTING STATEMENT

A. Justification

The Department of Education is requesting a revision of the previously approved Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR UP) annual performance report that expires on April 30, 2016. The information is collected under the authority of Title VII, Part A, Subpart 2, Section 711 of the Higher Education Act of 1965, as amended; the program regulations in 34 CFR 648; and the Education Department General Administrative Regulations (EDGAR) in 34 CFR 74.51. The overall goal of the program is to increase the number of low-income students who are prepared to enter and succeed in a post-secondary education.

There is one version of the performance report that is part of this package: the annual performance report. GEAR UP grants are awarded for a period of six or seven years. Grantees are required to submit an annual performance report on April 15 for each budget period of the grant. The annual performance report asks for information specific to the budget year for which the report is being submitted as well as the prior year for which student outcome data are collected. This information allows the Department to track the number of GEAR UP students who graduated and enrolled in postsecondary education during the grant period. The Department uses the data collected from the performance reports to: (a) monitor grantee compliance with program regulations (34 CFR 648) in administering grant funds; (b) collect

the quantifiable data needed to evaluate project outcomes; and (c) assist in providing technical assistance to strengthen individual projects.

The performance report is used to collect programmatic data for purposes of annual reporting, budget submissions to OMB, Congressional hearings, Congressional inquiries, and to respond to inquiries from higher education interest groups and the general public.

3. Grantees use a web-based system to electronically retrieve and submit the requested information in the performance report. The electronic version of the performance report automatically saves grantee information and student level data entered in one year for use in the following year. Therefore, the data does not need to be re-entered, only updated when changes occur. This assists in reducing the burden to grantees.

Since the information submitted in the performance reports is specific to the GEAR UP grant project, there is no duplication. There is no other collection instrument available to collect the information necessary to meet the purposes described in item 2 above.

Local Educational Agencies (LEA), Institutions of Higher Education (IHE), and State Education Agencies (SEAs) are the sole recipients of GEAR UP grants. There is no impact on small businesses or small entities.

Collection of information is annual. Collection of information on a less frequent basis would impede the Department's ability to determine if the grantee is making satisfactory progress in meeting the goals and objectives proposed in its initial application for funds.

Further, failure to collect this information would hinder the Department's ability to carry out its required responsibility to perform an overall assessment of the GEAR UP Program and its impact.

There are no special circumstances that would cause this information collection to be conducted in such a manner, except for the three-year record-keeping retention period in EDGAR 74.53.

Comments and feedback regarding the frequency, clarity of instructions, reporting format, and data elements included in the performance report have been received from grantee institutions in prior years. The feedback received was the impetus for the changes that have been incorporated into the performance report. The changes made in the form since the last OMB submissions are primarily for the purpose of streamlining and clarifying the intent of the questions. The 60 days was published on 12/24/15 in the Federal Register Notices for public comment, and the 30 days will be published as well.

For this submission, clarifying language and new fields were added to questions in the performance report to address previous input and comments received from grantees since the previous OMB submission. The survey data section has been omitted, which will significantly reduce burden on grantees. No questions were added to the report, only clarifying language in the instructions. These changes will result in better data collection for the GEAR UP program. During the 60 day public comment period, the Department received 5 sets of comments. Three of the five sets of comments were positive feedback applauding the Department on the changes made to the APR. Those comments did not require a response from the Department. We received two sets of comments which required a response. The Department made some recommended changes as suggested by the commenters and also provided feedback to the commenters concerning why their suggested changes were not accepted. Copies of the comments and responses are in a separate attachment.

The Department will not provide any payments or gifts to respondents.

There is no program regulatory requirement for assuring confidentiality, except as provided by EDGAR (34 CFR 75.740 – Privacy), and the Family Educational Rights and Privacy Act of 1974.

Prior to accessing the web based reporting software there is a Privacy Act Notice that grantees must read. It states that the system contains personal information protected under the provisions of the Privacy Act of 1974, 5 U.S.C. § 552a -- as amended. Violations of the provisions of the Act may subject the offender to criminal penalties. A Privacy Impact Assessment was completed in 2013 with the previous submission and has been updated for the 2016 submission. We do not intend to do a system of records. A system of records is not needed as we do not collect SSN information, and data is aggregated to evaluate the accomplishments and impact of the GEAR UP program as a whole. Records are destroyed within ten years of being received at the federal records center.

The estimated total reporting burden for this data collection is 1,270 hours. This includes a total of 127 respondents (91 public institutions and 36 private institutions), each with an estimated response time of 10 hours. The burden hours have been reduced since the previous collection package was submitted for clearance due to the elimination of the survey data section of the report and a decrease in the expected number of respondents. Comments and feedback regarding the clarity of instructions in the performance report have been received from grantee institutions. As noted under item 8, clarifying language was added to questions based on feedback received from grantees. The changes did not affect the burden hours.
