SUPPORTING STATEMENT FOR REQUEST OF OMB APPROVAL UNDER THE PAPERWORK REDUCTION ACT AND 5 C.F.R. 1320

The Surface Transportation Board (STB or Board) requests a three-year extension of approval of the regulations governing the filing of tariffs by regulated water carriers.

A. Justification:

- 1. Need for Information in Collection. Congress provided that the Board actively regulate water carriers engaged in transportation of freight in the noncontiguous domestic trade—i.e., domestic (as opposed to international) shipments moving to or from Alaska, Hawaii, or U.S. territories or possessions (Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Northern Mariana Islands). 49 U.S.C. § 13102(17). For common carriage service by water in noncontiguous domestic trade, water carriers are required to publish their rates in tariffs and file them at the STB. 49 U.S.C. § 13702(b); 49 C.F.R. § 1312. (A tariff provides a list of prices and fees that the carrier charges to the shipping public.)
- 2. <u>Use of Data Collected</u>. Information in this collection is used by the public to learn about prices and fees charged by water carriers that provide freight transportation in noncontiguous domestic trade. Historically, the agency has maintained tariffs in a Tariff Library at the STB headquarters. Recently, the Board began posting them on its website, located at https://www.stb.dot.gov/recordations.nsf.
- 3. <u>Reduction through Improved Technology</u>. This collection may be submitted electronically. The water carrier tariffs are posted on the Board's website (as linked above).
- 4. <u>Identification of Duplication</u>. The Board is required by statute to administer this collection. No other Federal agency collects the information reported in water carrier tariffs.
- 5. <u>Minimizing Burden for Small Businesses</u>. The Board concludes that this collection does not have a significant economic effect on a substantial number of small entities. It takes no more than 45 minutes to file the required copy of the tariff with the Board.
- 6. <u>Consequences if Collection not Conducted or Less Frequent</u>. Failure of non-contiguous domestic water carriers to file these tariffs as required would negatively impact (1) public access to information about water carrier tariffs and (2) the ability of the Board to fulfill its statutory mandate.
 - 7. <u>Special Circumstances</u>. No special circumstances apply to this collection.
 - 8. Consultation with Outside Agency. As required, the Board published a notice

providing a 60-day comment period regarding this collection. <u>See</u> 81 Fed. Reg. 26,302 (May 2, 2016). No comments were received. A 30-day notice was published concurrently with this submission to Office of Management and Budget (OMB). <u>See</u> 81 Fed. Reg. 51,959 (Aug. 5, 2016).

- 9. Payments or Gifts. The Board does not provide any payment or gift for this collection.
- 10. <u>Assurance of Confidentiality</u>. All information collected through this report is available to the public.
 - 11. Sensitive information. This collection contains no information of a sensitive nature.
- 12. <u>Estimated Burden Hours</u>. The following information pertains to the estimate of burden hours associated with this collection:
 - (1) Number of respondents: Approximately 29.
 - (2) <u>Frequency of response</u>: On occasion. Over the last three years, respondents have filed an average of 885 responses per year. The same number of filings is expected during each of the next 3 years.
 - (3) <u>Annual hour burden per respondent</u>: 663.75 hours (885 filings X .75 hour estimated time per filing).
- 13. <u>Estimated Total Annual Cost to Respondents</u>: No non-hour costs have been identified for this collection. This form may be filed electronically.
- 14. <u>Annualized Cost to the Federal Government</u>: The Board performs periodic cost studies to determine the cost to the Board of various Board functions. These costs determine the various fees set by the Board, including the fees for filing of water carrier tariffs. The fee study shows the total annual cost to the Board for this collection is \$23,399.40.
- 15. Explanation of Program Changes or Adjustments. This is an existing collection, which is being adjusted to update the burdens and costs based on the quantities experienced by the Board for the collection of water carrier tariffs since the last approval of this collection by OMB in 2013. Since then, the number of tariffs submitted to the Board decreased, and the cost to the federal government decreased due to technology improvements.
- 16. <u>Publication of Data and/or Results</u>: There are no plans to tabulate or publish this collection. The Board posts the tariffs on its website, located at https://www.stb.dot.gov/recordations.nsf.
- 17. <u>Display of expiration date for OMB approval</u>. No exception is sought. The required content for a water carrier tariff is specified in the relevant statutory and regulatory provisions. <u>See</u> 49 U.S.C. § 13702(b); 49 C.F.R. § 1312. There is no form or other applicable instructions.

The control number and expiration date for this collection will be published in the Federal Register as provided in 5 C.F.R. § 1320.3(f)(3).
