Department of Veterans Affairs Sample Data Sheet

- Number 1: Provide the full name of the Cemetery
- Number 2: Provide the complete mailing address for the cemetery.
- Number 3: Provide open or closed status of the cemetery.
- Number 4: Provide the current full name of the director of the cemetery.
- Number 5: Provide a current and up to date phone number including area code.
- Number 6: Provide a current fax number to the administrator/ cemetery.
- Number 7: Provide current up to date e-mailing address for the Director of the cemetery.
- Number 8: Provide the current Web site address of the cemetery.
- Number 9: Provide date cemetery opened.
- Number 10: Provide the dedication date that the cemetery opened.
- Number 11: Provide the date of the first burial either by full casket or cremation.
- Number 12: Provide the estimated closure date (*Month and Year*), based on burial rate (see example: [How to Estimate Date of Closure](#)).
- Number 13: Provide the name of State Agency responsible for the cemetery.

Acreage

- Number 14: Provide the total number of acres for the cemetery (included both developed and undeveloped.)
- Number 15: Provide the current number of acres that is developed.
- Number 16: Provide the total number of undeveloped Acres.

Casketed Gravesites

- Number 17: Provide the current number of developed casketed gravesites available.
- Number 18: Provide the estimated number (phased) gravesites in undeveloped acreage.
- Number 19: Provide the total number of casketed gravesites maintained to date.

Cremation Gravesites

- Number 20: Provide the current number of in-ground cremation gravesites available.
- Number 21: Provide the estimated number (phased) cremation gravesites in undeveloped acreage.
- Number 22: Provide the total number of in-ground cremation burials maintained to date.

Columbarium Niches

- Number 23: Provide the current number of columbarium niches available.
- Number 24: Provide the estimated number (phased) undeveloped columbarium niches.
- Number 25: Provide the total number of columbarium niches maintained to date.

Total Gravesite Usage

- Number 26: Provide the current number of casketed, cremation and columbarium (adding blocks # 17, # 20 and # 23).
- Number 27: Provide estimated number for gravesites in undeveloped acreage (adding blocks # 18, # 21 and # 24).
- Number 28: Provide total number of casketed, in-ground and columbarium maintained to date (adding blocks # 19, # 22 and # 25).

Burials

- Number 29: Provide the number of first casketed burials for the fiscal year - both Veterans and Dependents.
- Number 30: Provide the number of first in-ground cremated burials for the fiscal year - both Veterans and Dependents.
- Number 31: Provide the numbers of first columbarium burials for the fiscal year - both Veterans and Dependents.
- Number 32: Provide the number of second casketed, burials for the fiscal year - both Veterans and Dependents.
- Number 33: Provide the number of second in-ground cremated burials for the fiscal year - both Veterans and Dependents.
- Number 34: Provide the number of second columbarium burials for the fiscal year - both Veterans and Dependents
- Number 35: Provide sub total (adding blocks # 29 through # 34) - both Veterans and Dependents.
- Number 35A: Provide sub total (All previously reported burials).
- Number 36: Provide the total number of burials from date of opening the cemetery to the current date) - both Veterans and Dependents (adding blocks # 35 and # 36).

- Number 37: Provide the number of plot allowance payments received for Veteran burials from the Federal government.
- Number 38: Provide the total amount that the State charges Veterans and Dependents for burials (Do not include plot allowance).
- Number 39: Provide total number of State employees in the cemetery office.
- Number 40: Provide total numbers of State personnel in the field other than the cemetery office.
- Number 41: Provide the overall number of State personnel (adding blocks # 39 and # 40).
- Number 42: Provide the amount of State funds obligated for Human Resources (Do not include plot allowance).
- Number 43: Provide the amount of State funds obligated for other operating costs (Do not include plot allowance).
- Number 44: Provide the total operating expenses (include burial plot allowances if applicable) (adding blocks # 37, # 42 and # 43).

- Number 46: What are your eligibility requirements, including residency requirements.
- Number 47: Briefly describe any facts of special interest or historical significance relating to the cemetery grounds. - Number 49: List memorials located at the cemetery. Examples: Memorials to veterans of specific wars or campaigns and monuments placed by Veterans Service Organizations.
- Number 50: Location of cemetery. Please include precise direction from the nearest large airport to cemetery.
- Number 51: List the names of all Medal of Honor recipients and other notable Veterans buried in your cemetery.
- Number 52: Describe use of compensated work therapy program (CWT), volunteer, convict or other supplemental labor. Describe use of contractors to accomplish cemetery tasks.

How to Estimate Date of Closure For Casketed Burial Area

Add block # 29 for both Veterans and Dependents and use that total to divide into block #17. That total should be added to the current reporting year to obtain the estimated closure date.

Example: Block # 29 - (Veterans) 4 and (Dependents) 18 = 22
 Block # 17 is 400
 Divide 22 into 400 = 18 years
 Add 18 years to the reporting month and year (April 2008) = April 2026

How to Estimate Date of In-Ground Burial Area

Example: Block # 30 - (Veterans) 12 and (Dependents) 6 = 18
 Block # 20 is 276
 Divide 18 into 276 = 15 years
 Add the 15 years to the reporting month and year (April 2008) = April 2023

How to Estimate Date of Closure for Columbarium Area

Example: Block #31 - (Veterans) 22 and (Dependents) 7 = 29
 Block #23 is 640
 Divide 29 into 640 = 22 years
 Add the 22 years to the reporting month and year (April 2008) = April 2030
