What is the Jobs Plus Evaluation Study?

If you decide to participate, you may stop participating at any time without penalty or loss of benefits to which you are otherwise entitled.

Confidentiality

We will record your comments during the focus group, for later review by the research team. However, given that this is not a private interview, we cannot guarantee the confidentiality of this discussion.
