Raws li Txoj Cai Txoj Ntaub Ntawv Xyoo 1995 (Paperwork Reduction Act of 1995), ib lub koomhaum yuav tsis pub tsim los yog pab txhawb, thiab ib tug neeg yuav tsis tas teb lus rau, ib txoj kev sib sau ntaub ntawv yog tias lawv tsis tso tus lej muaj tseeb tswj OMB kom yus pom. Tus lej muaj tseeb tswj OMB rau txoj kev sib sau cov ntaub ntawv no yog 0578-0013. Lub sijhawm uas yuav tsum muab cov txoj kev sib sau cov ntaub no ua kom tiav yog kws yeas txog li ntawm 150 feeb tauj ib qho kev teb lus, xam tas nrho lub sijhawm los mus saib xyuas dua cov kev taw qhia, nrhiav cov hauv paus ntsiab lus tshawb tawm uas qub, mus sau thiab tuav tswj cov ntsiab lus tshawb tawm uas xav tau, thiab muab cov kev saib xyuas dua txoj kev sib sau cov ntsiab lus ua kom tiav.

TSAB CAI TXWV TSIS PUB LWM TUS PAUB

Cov sob lus saum toj yog ua raws seem li Tsab Cai Txwv Tsis Pub Lwm Tus Paub Xyoo 1974 (Privacy Act of 1974 (5 USC 522a)). Txoj kev muab cov ntaub ntawv no yog ib yam nyob ntawm yus yeem; tiamsis, yog tias muab tsis tau kom yog, kom tiav yuav ua rau lawv tuav tseg or yog rho tawm tej yam kev pab koj khiav ntaub ntawv los yog kev pab nyiaj. Cov ntaub ntawv yuav muab tau tuaj rau lwm lub koomhaum USDA los tau, lub hauv paus tswj se Internal Revenue Service, lub hauv paus tswj kev ruaj ntseg Department of Justice, los yog lwm lub koomhaum tswj taug kev cai lij choj hauv Lub Xeev los yog Nom Tswv Loj, los yog thaum uas teb ntawv tuaj tom xam tuaj, tus thawj xam tuaj, los yog ib lub chaw tswj saib kev cai tuaj.

SOB LUS HAIS TXOG KEV TXWV TSIS PUB CAIS NEEG

"Lub Hauv Paus Tswj Kev Ua Teb Noj (U.S. Department of Agriculture (USDA) txwv tsis pub muaj kev cais neeg rau tas nrho lawv cov kev pab cuam thiab cov kev ua ub no raws li ntawm tib neeg tus haiv, xim nqaj tawv, xeeb tebchaws twg tuaj, pojniam los yog txiv neej, kev ntseeg, hnub nyoog, kev mob lub cev tsis taus, los yog vim li cas tas nrho los yog ib feem ntawm ib tug neeg twg cov nyiaj khwv tau los ntawm tej kev pab nyiaj pej xeeb los. (Tsis yog tas nrho cov kev txwv yuav siv tau rau tas nrho cov kev pab cuam.) Cov tib neeg uas muaj mob lub cev tsis taus uas yuav tsum tau lwm yam kev los sib txuas lus txog cov ntaub ntawv ntawm cov kev pab cuam (Braille, sau niam ntawv kom loj, thev hais lus, thiab lwm yam ntxiv) yuav tsum tiv tauj USDA'S TARGET Lub Chaw ntawm (202) 720-2600 (siv suab thiab siv TDD).
