INSTRUCTIONS FOR COMPLETING FORM RAC-21

- 1. The RAC-21 is a companion report to the RAC-20. Exports reported on the RAC-20, are further broken down by country of destination.
- 2. The carton and bag total for a varietal type reported on the RAC-20 should equal the "pack" total for that varietal type on the RAC-21. The bulk total for a varietal type reported on the RAC-20 should equal the bulk total reported on the RAC-21.
- 3. Documentation may be requested to verify shipments.
- 4. Reports shall be submitted to the Raisin Administrative Committee (RAC) on or before the **seventh** day of each month by 10:00 a.m., covering the shipments for the preceding month.
- 5. Consult RAC Field Representatives on any points not clear to you.

This report is required by law (7 U.S.C. 608d, 7 CFR 989.173, CFR 989.173(c)(1)(iv)). Failure to report can result in a fine of \$1,100 for each such violation, and each day during which such violation continues shall be deemed a separate violation.
