A. Justification

CBP Form 6043, *Delivery Ticket*, is used to document transfers of imported merchandise between parties. This form collects information such as the name and address of the consignee; the name of the importing carrier; lien information; the location of where the goods originated and where they were delivered; and information about the imported merchandise. CBP Form 6043 is filled out by warehouse proprietors, carriers, Foreign Trade Zone operators and others involved in transfers of imported merchandise. This form is authorized by 19 U.S.C. 1551a and 1565, and provided for by 19 CFR 4.34, 4.37 and 19.9. It is accessible at: <http://www.cbp.gov/sites/default/files/documents/CBP%20Form%206043.pdf>

The information is to be used by CBP officers to document transfers of imported merchandise between parties.

The information on the Delivery Ticket, Form 6043 can be submitted electronically via the Automated Commercial Environment (ACE).

This information is not duplicated in any other place or any other form.

Without this information, CBP would not be able to document transfers of imported merchandise between parties.

Public comments were solicited through two Federal Register notices published on February 16, 2016 (Volume 81, Page 7823) on which no comments were received, and on May 12, 2016 (Volume 81, Page 29572) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

All data submitted and entered into ACE is subject to and protected by the Trade Secrets Act (18 U.S.C. 1905) and is considered confidential, except to the extent as otherwise provided by law. A PIA for the Automated Commercial Environment (ACE) dated July 31, 2015, and a SORN for the Import Information System,

dated August 17, 2015 (Volume 80, Page 49256) will be included in this ICR.

Public Cost

The estimated cost to the respondents is \$3,990,360. This is based on the estimated burden hours (66,000) multiplied by (x) the average loaded hourly wage rate for warehouse operators (\$60.46). CBP calculated this loaded wage rate by multiplying the Bureau of Labor Statistics' (BLS) 2014 median hourly wage rate for Transportation, Storage, and Distribution Managers (\$41.06), which CBP assumes best represents the wage for warehouse operators, by the ratio of BLS' average 2014 total compensation to wages and salaries for Management, Business, and Financial occupations (1.4725), the assumed occupational group for warehouse operators, to account for non-salary employee benefits.^{1,2}

13. **Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.**

There are no record keeping, capital, start-up or maintenance costs associated with this information collection.

14. **Provide estimates of annualized cost to the Federal Government. Also provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment**

overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information.

The estimated annual cost to the Federal Government associated with the review of these records is \$1,830,648. This is based on the number of responses that must be reviewed (200,000) multiplied by (x) the time burden to review and process each response (.166 hours) = 33,200 hours multiplied by (x) the average hourly loaded rate for a CBP Officer (\$55.14)³ = \$1,830,648.

15. Explain the reasons for any program changes or adjustments reported in Items 12 or 13.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There is no change to the information collected or to CBP Form 6043.

16. For collection of information whose results will be published, outline plans for tabulation, and publication.

This information collection will not be published for statistical purposes.

17. If seeking approval to not display the expiration date, explain the reasons that displaying the expiration date would be inappropriate.

CBP will display the expiration date for OMB approval of this information collection.
