Westat and SRI International are conducting the study for the U.S. Department of Education's Policy and Program Studies Service, on behalf of the Office of English Language Acquisition and the Office of Educational Technology. The goals of the study are to identify the types of DLRs used in instructing English learner (EL) students, how these are used, and in what ways these support EL student's second language learning of academic English and learning of core academic content.
