2. Excel Number Format for the SFA ID field must be set to 'Text' if preceding zeros in a number are required.
3. Data must be submitted in a Microsoft Excel 97-2003 spreadsheet (.xls).
4. Each row will contain one record with all form data elements.
5. The system will only read the first (leftmost tab) worksheet in a submitted workbook, regardless of the order of tabs.
6. The system will begin reading from the topmost leftmost cell, displayed as "A1". This means that the first cell in the first row (which describes the contents of the columns) **MUST be removed prior to submission.**
7. FPRS interprets an empty row as the end of the data file so that no additional data will be accepted. Empty rows in the data file.
8. There is an upper limit of 1500 rows per submission.
