Example:

If this location reported **253 shipments in Item D1**, it would correspond to the range of **241-280** and every **7th** outbound shipment record would be selected.

This means:

1. The location would count **7 records**, starting with the first shipment record of the week that was identified in Item D1, select that record and report it in Item F.
2. The location would then count **another 7 records** again from the shipment selected in step 1 and record that shipment in Item F.
3. The location would repeat this process until it had gone through the full set of shipment records for the week identified in Item D1.
4. The location would report 36 shipments in Item F. Item F contains 80 lines, so the location would leave lines 37-80 blank.
