**PRIVACY ACT STATEMENT**

**AUTHORITY:** 10 U.S.C. 2192a, Science, Mathematics, and Research for Transformation (SMART) Defense Education Program; 5 U.S.C. 3304, Competitive service examinations; 20 U.S.C. 17, National Defense Education Program; and E.O. 9397 (SSN), as amended.

**PRINCIPLE PURPOSE(S):** To record a SMART Participant's agreement to permit the use of their image, name and voice publications and/or other productions related to the SMART Program.

**ROUTINE USES:** Disclosure of records are generally permitted under 5 U.S.C. 552a(b) of the Privacy Act of 1974, as amended.
