**TITLE OF INFORMATION COLLECTION:** 2019 Science Ambassador Fellowship Summer Course Satisfaction Survey

#### **PURPOSE:**

The Centers for Disease Control and Prevention (CDC) seeks to obtain Office of Management and Budget (OMB) approval to collect feedback for the 2019 CDC Science Ambassador Fellowship summer course held July 15-19, 2019 in Atlanta, GA. The Science Ambassador Fellowship summer course is held annually for the purpose of (1) providing a training experience for middle school and high school teachers to link teachers with CDC subject matter experts to develop effective public health-related lesson plans that meet National science education standards, and (2) increasing the number of teachers who integrate public health and epidemiology concepts into their science education curricula and, additionally, share these resources with their communities. The goals of this survey are to improve summer course participant experiences and ensure the summer course is meeting its goals and participant needs. This information collection will be used by Science Ambassador Fellowship planners to refine the summer course and to improve logistics, communication, and quality of future sessions.

#### **BURDEN HOURS**

The feedback survey will be web-based and include (at most) 16 questions. Respondents will take approximately 10 minutes to complete the survey through Survey Monkey. This estimate is based on piloting the survey with five CDC staff. For the 2019 Science Ambassador Fellowship summer course, we are seeking approval to collect feedback from 30 non-federal individuals (i.e., middle school, high school, community college professors, and other educators). Given 30 respondents with a response time of 10 minutes each, the total response burden will be 5 hours. There will be no direct costs to the respondents other than their time to respond to the survey.
