1. **Create Account** – Go to the **myCensus** webpage: <https://mycensus.census.gov> and click "Create Account". You will need to enter a valid email address. As part of the registration process you will create your own password and security questions. You must confirm your email address to finish setting up your account. You will use this account every time you access the survey.
2. **Add Survey** – Once you have created an account, you will be taken to the **myCensus** webpage. Click on the "**Add a Survey**" button and enter your Authentication Code (below). Please note that this is a one-time-use secure code that will expire once it is used.

3. **Start Survey** – Next you will be taken to your "Survey Dashboard." Click "Start " on the **2016 Report of Organization** card to access the reporting system. You can return to the survey anytime, by accessing the **myCensus** webpage using the website indicated in Step 1 and using the account credentials you created. You will not need to re-enter the Authentication Code after its first use.

**Your response is required by law.** Title 13 United States Code, Sections 131 and 182 authorizes this collection. Title 13 U.S.C., Sections 224 and 225 require businesses and other organizations that receive this questionnaire to answer the questions and return the report to the U.S. Census Bureau. Title 13 U.S.C., Section 9 also requires that we keep your answers strictly confidential. The information you provide may be seen only by persons sworn to uphold the confidentiality of Census Bureau information and may be used only for statistical purposes. Further, copies retained in your files are immune from legal process.
