

**SUPPORTING STATEMENT FOR  
Application for Certificate of Citizenship

COLLECTION INSTRUMENT(S): N-600**

**A. Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

U.S. Citizenship and Immigration Services (USCIS) uses the information collected on the Form N-600 to determine whether the applicant meets citizenship eligibility requirements and conditions. Upon approval of the application the applicant is declared to be a citizen of the United States and USCIS issues a certificate of citizenship, pursuant to section 320 of the Immigration and Nationality Act (INA).

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

USCIS uses the data collected on this form to determine eligibility for the requested immigration benefit. The form standardizes requests for the benefit, and ensures that basic information required to assess eligibility is provided by applicants.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

The use of this form provides the most efficient means for collecting and processing the required data. In this case, USCIS does not employ the use of information technology in collecting and processing information. USCIS, however, has designated the Form N-600 for e-filing under the Business Transformation Project.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

A review of the Forms Inventory Report revealed no duplication of effort, and there is no other similar information currently available which can be used for this purpose.

**5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.**

This collection of information does not have an impact on small businesses or other small entities.

**6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.**

Sections 320 and 341 of the INA provide for the issuance of a certificate of citizenship to individuals who claim to have derived U.S. citizenship through the naturalization of a parent, the naturalization or citizenship of a spouse, or under certain provisions of the law. Form N-600 provides a crucial means of establishing the authenticity of such claims and the absence of this form would impede the processing of such claims for U.S. citizenship. The information collected through this form is essential to documenting whether the applicant has met all of the eligibility requirements to receive a certificate of citizenship recognizing his or her U.S. citizenship status. The information is also collected to ensure a complete and accurate adjudication.

**7. Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- **Requiring respondents to report information to the agency more often than quarterly;**
- **Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **Requiring respondents to submit more than an original and two copies of any document;**
- **Requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
- **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
- **Requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**
- **That includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data**

**security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**

- **Requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

This information collection is conducted in a manner consistent with the guidelines in 5 CFR 1320.5(d)(2).

- 8. If applicable, provide a copy and identify the data and page number of publication in the Federal Register of the agency's notice, required by 5 CFR 1320.8(d), soliciting comments on the information collection prior to submission to OMB. Summarize public comments received in response to that notice and describe actions taken by the agency in response to these comments. **Consultation with representatives of those from whom information is to be obtained or those who must compile records should occur at least once every 3 years - even if the collection of information activity is the same as in prior periods. There may be circumstances that may preclude consultation in a specific situation. These circumstances should be explained.**

On February 2, 2016 USCIS published a 60-day notice in the Federal Register at 81 FR 5476. USCIS received 1 comment after publishing that notice regarding the information necessary to adjudicate the form. USCIS thanks the commenter for responding, and there is no need for the additional information that the commenter felt was necessary to collect. On May 16, 2016, USCIS published a 30-day notice in the Federal Register at 81 FR 30331. USCIS did not receive comments.

The Final Fee Rule was published on October 24, 2016 at 81 FR 73292.

- 9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.**

USCIS does not provide any payment for benefit sought.

- 10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation or agency policy.**

There is no assurance of confidentiality. *The system of record notice associated with this information collection is the United States Citizenship and Immigration Services Alien File, Index, and National File Tracking System of records, which was published in the Federal Register on November 21, 2013 at 78 FR 69864 and the United States Citizenship and Immigration Services Benefits Information System, which was published in the Federal Register on September 29, 2008 at 73 FR 56596. The privacy impact assessment associated with this information collection is the Computer Linked Application Information Management System 4 (CLAIMS 4) (Dated November 5, 2013).*

- 11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private. There are some questions regarding marital history of parents that are considered sensitive in nature. However, this information is necessary to make a determination on the applicant's eligibility for citizenship and there is no assurance of confidentiality.

- 12. Provide estimates of the hour burden of the collection of information. The statement should:**
- Indicate the number of respondents, frequency of response, annual hour burden, and an explanation of how the burden was estimated. \* The above Average Hourly Wage Rate is derived from the *May 2013 Bureau of Labor Statistics Mean Hourly Wage* for "All Occupations". The wage rate of \$32.52 is calculated from the base average wage rate of \$23.23 times the wage rate benefit multiplier of 1.4. The selection of "All Occupations" represents the possibility that respondents can be employed in any type of work; the collection is not targeting any specific category of employment.

**13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 and 14).**

- **The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. The estimates should take into account costs associated with generating, maintaining, and disclosing or providing the information. Include descriptions of methods used to estimate major cost factors including system and technology acquisition, expected useful life of capital equipment, the discount rate(s), and the time period over which costs will be incurred. The estimated cost to the respondent for obtaining any necessary documents, postage, attorney fees, photographs, and other incurred expenses is \$122.50 per respondent for a total of \$7,506,678.

*There is a fee of \$1,170 for the filing of the form.*

**Government Cost**

The cost to the Federal Government is estimated by the fee cost times the number of respondents. The \$1,170 fee times the number of respondents 61,279 equals \$71,696,430.

The increase in the total annual hour burden is due to the increase in the estimated hour burden per response due to the addition of additional signature and attestation language in the form and instruction.
