#### 1. What is this study about?

The sessions will be audio and/or video recorded, as long as you agree, and will also only be used for research purposes.

#### 7. Will the results go to the participant's school?

The participant's answers will not be disclosed to his or her school and will not be linked to any personally identifiable information such as the school's name.
